

Evidence ready against twelve

Says war crimes prosecutors after district visits

War crimes investigators and prosecutors have collected evidence against 12 people including former Jamaat-e-Islami Ameer Ghulam Azam and BNP leader Salauddin Quader Chowdhury for committing crimes against humanity during the LiberationWar.

Five of them are now in prison in two cases filed on charges of crimes against humanity.

Moves would be made to arrest the rest, Zead Al Malum, member of the prosecution team, told journalists at his office at the Old High Court Building yesterday. He however did not elaborate.

Their involvement in crimes against humanity became evident in primary investigation, he said.

Crimes against humanity fall under article 3(2) of International Crimes Tribunal Act, 1973, which also covers offences like war crimes, genocide, murder, abduction, confinement, torture and rape.

If found guilty, they might face up to death sentence.

One employee was killed and five others injured in an explosion at a ceramic factory in Gazipur yesterday morning.

Blast in factory

The dead is Rafiqul Islam, 28, while the injured are Mohammad Ali, 35, supervisor of the finishing unit; Mossaraf Hossain, 25, floor in-charge; team leader Selim Miah, 30; workers Abdul Haque, 34, and Akkas Ali, 24.

A nitrogen gas cylinder and an oil tanker of the printing section of Sun Power Ceramics went off with a bang at about 11:00am, injuring six staffs, said Afzal monir, executive director of the factory at Hotapara.

Strong laws for safe climate

Environment bills seek more clout, courts to tackle polluters

Two bills were placed in parliament yesterday seeking to increase power and number of environment courts to take stern actions against polluters and also to establish a trust to tackle adverse impacts of climate change.

State Minister for Environment and Forest Hasan Mahmud placed the bills, which were sent to the parliamentary standing committees on environment and forest ministry for scrutiny.

The bill to enact new law aims to expedite trial of environment related offences

and offers setting up environment court at every district headquarters with expanded jurisdiction to take stern actions against all sorts of polluters. A judicial officer of the rank of a joint

district judge will be appointed as the judge of the environment court to conduct trial of environment related offences alongside his general jurisdiction.

The bill also proposed for setting up one or more special magistrate's courts at district level with the authority to hold trial of environment offences and issue order to confiscate goods and other materials as punishment.

It proposed repealing the existing Environment Court Act, 2000 which allows the government to form court only at divisional headquarters. According to the existing law, a person might be jailed for maximum three years or fined Tk 3 lakh for polluting environment.

But the proposed legislation increased the jail term up to five years and the fine up to Tk 5 lakh.

Both the special magistrate's court and the environment court will enjoy authority to realise fines from the offenders. Besides, the courts may order to meet **SEE PAGE 15 COL 7**

UN award for Bangladesh

Bangladesh received an UN award for its remarkable achievements in attaining the Millennium Development Goals (MDGs) particularly in reducing child mortality rate.

Prime Minister Sheikh Hasina accepted the award at a colourful function at Astoria Hotel in New York yesterday. The award was conferred upon Bangladesh and five other countries a day ahead of the MDG conference on the sidelines of

Experts say maternal mortality, child malnutrition still remain high

Although Bangladesh receives a UN award for reducing child mortality, malnutrition of children and maternal mortality rate still remain high and a major concern, said Prof Quazi Kholiquzzaman Ahmad.

Besides, though poverty rate has come down from 60 percent : in 1990-91 to 37 percent, rising inequality between the rich and the poor is a major concern, he observed.
