# 4 boys face abduction charge, one arrested

Four 10 to 12 year-old boys of Dinajpur Sadar upazila were made accused in the case for abducting a seven-year-old boy, while police arrested one of the accused after the abducted boy's father handed him over to police yesterday.

Dilip Chandra Roy, 11, son of Rohindra Roy of Kaogaon village under Dinajpur Sadar upazila, and his 'three aides' Sajib, 11, Manik, 12, and Biplop, 10, are accused in the abduction case filed with Dinajpur Police Station yesterday morning.

Father of seven-year-old Md Mehdi Hasan Raihan, Md Minu Mia of Munshipara village under Dinajpur Sadar upazila, and his relatives went to the police station along with Dilip Chandra Roy, 11, the alleged mastermind of kidnapping Mehdi, and filed the

According to the case statement, Minu Mia and his relatives on Monday afternoon caught Dilip from Munshipara of Dinajpur town and after interrogation by the locals the boy admitted that he abducted Raihan on Saturday morning and took him to Md Abdul Kasem of Phulbari upazila in Dinajpur.

Raihan went missing on September 25 morning from Zabed Traders at Munshipara of Dinajpur town and his father Minu Mia filed a general diary with Dinajpur Police Station the same day, it said.

Three adult people were also involved in the abduction, the complainant said.

Raihan's family members said that Dilip used to play with the seven-yearold boy and occasionally snatched away money from him.

"It seems odd that a seven-year-old son is innocent.

boy should have money," said a police official pleading anonymity.

Sub Inspector of Dinajpur Police Station Md Mamun, also investigation officer of the case, said during interrogation Dilip told the police that he abducted Raihan from Munshipara on Saturday morning.

Police said they conducted raid at different places following statements of the arrested boy but the missing boy could not be rescued as of filing this

Police quoted Raihan's family members as saying that no one has yet claimed any ransom for the boy.

Police produced Dilip before a court that sent him to jail, police said.

STABBING JCD ACTIVIST ON CAMPUS

### SUST expels 5 BCL men temporarily, orders probe

The authorities of Shahjalal University of Science and Technology yesterday expelled five activists of Bangladesh Chhatra League (BCL) temporarily on charge of their involvement in Monday's incident that left a JCD activist critically injured.

The authorities took the decision at a meeting and also formed a three-member probe committee headed by Prof Ilyas Uddin Biswas, treasurer of the university.

The expelled BCL men are Shahidullah Maruf and Belayet Hossain of computer science and engineering department, Imran Ahmed of statistics department, and Sayed and Tuhin of political studies department.

On Monday, Ashiqur Rahman Ayon, an activist of JCD and also a fourth year student of petroleum and geo resources department, was stabbed allegedly by a group of BCL men on the campus.

Critically injured Ashiqur is now undergoing treatment at Sylhet MAG

Osmani Medical College and Hospital.

Witnesses said, Ashigur came under attack by the BCL men numbering about 7 to 8 at around 11:45am as he came out of the class at the E building on the campus.

They stabbed Ashique with sharp weapons causing serious injuries to his shoulder and head. He was immediately rushed to the hospital. According to sources, the incident was a sequel to a previous enmity.

Members of the Rapid Action Battalion arrested a robber who was injured by bullet in an encounter with them in Habiganj Sadar upazila early yesterday


Arrestee Mukhles Miah of Habiganj Sadar upazila is an accused in at least 19 cases, Rab said.

Police sub-inspector (SI) Hafiz Khan and Havilder Akhtar of Rab also sustained injuries in the encounter. A revolver, two ammunition and two billhooks were also recovered from the spot.

The injured robber was admitted into Habiganj Sadar Hospital while Rab men were released after giving first

ASP Zakir Hossain, Assistant Director of Rab at Srimongal, said a contingent of Rab reached Lashkarpur on the Dhaka-Sylhet highway at about 3:30 am yesterday as a gang of 10 robbers were taking preparation for committing robbery.

Sensing the presence of Rab men, the robbers opened fire at them while the elite force retaliated. After exchange of about 17 gunshots, Rab men caught bullet hit Mukhles.
