Health professionals tell conference

Public health professionals from different countries assembled in the city to discuss the magnitude of health problems due to climate

More than 200 professionals from France, India, Indonesia, Germany, Japan, Malaysia, Switzerland and host Bangladesh started dialogue yesterday at the two-day confer-

Prof Dr Moazzem Hossain, director of the communicable disease control of Directorate General of Health Services (DGHS), said neglected tropical diseases (NTDs) such as filariasis, snake bite, kala'azar, and rabies were discussed on the first day of the conference.

Prime Minister's Adviser on Establishment HT Imam spoke as the chief guest while Prime Minister's Adviser on Health Prof Dr Syed

Modasser Ali inaugurated the event, organised by DGHS Communicable Disease Control Department.

Dr Moazzem said impacts of the climate change on health is evident in sub-tropical extreme weather events and sea level rise have already battered people's lives in the country.

He said Prime Minister Sheikh Hasina has raised her voice in the last conference of parties (COP-15) in Denmark and has again raised Bangladesh's concern over global warming in the just-concluded UN General Assembly (UNGA).

Syed Modasser Ali said the potential impact of global warming on the transmission of NTDs did not get due attention from researchers over decades, although the evidence shows that epidemic potential for such diseases might increase by 12-27 percent as a direct consequence of higher temperature.

DGHA Director General Prof Dr Shah Munin Hossain chaired the inaugural session, where Prof Kazuhiko Moji presented the keynote paper and chairman of Bangladesh Medical Research Council Prof Mahmud Hasan spoke as the special guest.

Martyrs' families crave quick war crimes trial

The families of martyred intellectuals and freedom fighters want quick trial of war criminals for which they have been waiting for the last 39 years in agony seeing the criminals left unpunished and enjoying state support to

"As the investigation team of International Crimes Tribunal is working, we feel that the nation remembers the atrocities and brutalities perpetrated on martyred intellectuals and freedom fighters," said Shaheen Reza Noor, second son of martyred intellectual journalist Serajuddin Hossain.

He said, "I remember a group of masked Al Badar men who had taken away my father on the night of December 10, 1971. Eight to ten masked men arrived at our rented Shantinagar residence at 3:00am knocked the door harshly. I heard a known voice as saying, 'Shaheen, open the door.' And I opened it," Shaheen told the agency yesterday at his Mohammadpur resi-

'The masked men stormed into the house along with our landlord Shamsul Huda and his brother-in-law journalist Syed Mahmud.... they went into my father's room and took away him and then boarded a jeep within a minute. My father was wearing a blue colored lungi and a white T-shirt,' recalled Shaheen.

"We have talked about it much but now we want quick trial of the criminals," he said quoting his mother.

Shaheen was confirmed that the masked men were Al Badars. "I identified one of them as his mask was worn out. He was Khalil. He was jailed for life during the trial under the collaborator act. But I don't know what happened to him when the act was annulled by Ziaur Rahman."

Huq, a former attorney general, and a close friend of my father, came to our residence with tearful eyes and told us to go to Rayer Bazar. I along with my relatives rushed there and was horrified to see the bodies of intellectuals, mostly partially decomposed, in a ditch."

"We didn't take any body from there as we could not trace out my father. The colors of clothes with the body were not same as my father was wearing while taken away." A feeling of relief was also visible among the

family members of martyred freedom fighter Muhammad Salimullah as the war crimes trial has started. "Now the trial has started ... every member

of our family is eagerly waiting to see the collaborators are punished. You know, now my mother never misses any TV bulletin to know about war tribunal news," said Sadi Mohammad, famous singer of Rabindra sangeet. Sadi's father Mohammad Salimullah who

was an Awami League leader was hacked to death on March 26, 1971 by collaborators. "The incident is still a nightmare to me.... It is still vivid in my mind that a Pakistani soldier was stabbing on my father's back with a dagger before my eyes."

"He stabbed so violently that it took some time to take the dagger out. I tried hard to stop the bleeding with my hand on the wounds, but it did not stop because it (stabbing) was so

"I dragged my father into the street, but a mob surrounded us. Seeing the mob, which had already killed 25 Bangalees in the areas, my father said, 'My son, runsave your life.' Those were the last words from my father. I started running for life, but looked back and saw the mob falling on him. My father's body was left on the street for a long time until the local Shaheen said, "We waited till December 16 for mosque's Imam, risking his life buried him at Mohammadpur Graveyard."

WAR CRIMES TRIAL

Jamaat leaders file petitions with HC

Five detained leaders of Bangladesh Jamaat-e-Islami yesterday filed five separate petitions with the High Court (HC) for quashing the proceedings of International Crimes Tribunal against them in connection with crimes against humanity in 1971.

Secretary General Ali Ahsan Mohammad Mojahid, Nayeb-e-Amir Delwar Hossain Sayedee, Assistant Secretary General Muhammad Kamaruzzaman and leader Abdul Kader Mollah filed the petitions through their lawyers. The counsel for the petitioners said his clients have challenged

the proceedings of International Crimes Tribunal against them. He said the tribunal has issued arrest warrants against them without framing formal charges, adding that the tribunal cannot issue arrest warrant at this stage.

The HC is likely to hear the petitions today.

The International Crimes Tribunal on September 21 rejected six petitions filed by four detained Jamaat leaders, except Sayedee, for their release, withdrawal of arrest warrants against them and staying trial proceeding for war crimes.

Nasaka abducts four Bangladeshi fishermen

Myanmar border security force Nasaka abducted four Bangladeshi fishermen and their fishing boat from the Naf River at Teknaf of Cox's Bazar yesterday.

The fishermen are Noor Hossain, 26, of Boroitoli, and Anwar Hossain, 25, Ali Johor, 35, and Nur Mia, 24, of Naitangpara. BDR sources said the four fishermen went fishing on a boat in

the Naf River around 6:00am. At around 7:00am, Nasaka captured the four fishermen at gunpoint and took them to nearby Maungdaw of Myanmar, they

Lieutenant Colonel Muzammel Hossain, commander of Teknaf 42 Rifles Battalion, said a written complaint was received from kidnapped Noor Hossain's family at sadar BDR camp in this connection.

Earlier, on September 27, Nasaka took away two fishing boats near from Saint Martin coast throwing 15 fishermen in the NafRiver.

BDR sent a letter to Nasaka protesting the incident and demanded immediate handover of the fishermen and the boat.
