IMF targets abuse of debt ratings

The International Monetary Fund criticised Wednesday the abuse of sovereign debt ratings, warning that credit rating agencies may wield undue influence with investors.

"Sovereigns should do more to provide relevant and timely information to CRAs (credit rating agencies) and other market participants to enable them to conduct their own independent credit analysis," the IMF said in a synopsis of a report entitled "The Uses and Abuses of Sovereign Credit Ratings."

Two more tax zones by Oct: NBR chief

Two more tax zones will be created in the Chittagong region by October to take the tally to five and accelerate tax collection, the National Board of Revenue chairman said yesterday.

One zone will be in Chittagong and the other in Comilla, Nasiruddin Ahmed told reporters, after making rounds at a five-day Income Tax Fair in the port city.

The income tax department of Chittagong is organising the fair at Chittagong MA Aziz Stadium.

Reiterating that the September 30 deadline for filing income tax returns would not be extended, the NBR chief said: "We want to help develop a culture of filing income tax

returns in time."

Ahmed, however, said people could apply for an extension of the deadline for up to three months, as per rules, if anyone fails the deadline for personal reasons.

Ahmed said NBR would arrange an income tax fair annually in seven divisional towns from next year.

The process of setting up a full-fledged Bond Commissionerate and unification of the two existing customs houses in the port city, for imports and exports, will be completed by next month, he said.

Tax Commissioner Ramendra Chandra Basak said more than Tk 25 % crore in taxes has been collected in the first three days of the fair.

The fair ends today.

Indian Mahindra Satyam posts back-to-back losses

Mahindra Satyam on Wednesday reported net losses for its 2009 and 2010 financial years, giving the first view of its financial state almost two years after it was hit by India's biggest corporate fraud. For the year ended March 2010, Satyam

posted a net loss of 1.25 billion rupees (\$27.8 million) on revenue of 54.8 billion rupees (\$1.22 billion). For fiscal 2009, it had a loss of 81.77 billion, wiping out most of the revenue of 88.13 billion rupees. "There was a profit expectation on the

street. They have made a profit, if you take out exceptional items. But it is lower-thanexpected," said Subhashini Gurumurthy, sector analyst at Ambit Capital in Mumbai.

"I expect the stock to react negatively."

Satyam stunned investors in January 2009 when its former chairman and founder

Ramalinga Raju said profits had been overstated and assets falsified in a fraud allegedly worth over \$1.5 billion.

Tech Mahindra, which acquired Satyam in April 2009 and is operating it as an independent company, has said it can only merge the firm into the parent after restated results for fiscal years 2009 and 2010 are announced.

Last week, Mahindra Satyam said it would delist from the New York Stock Exchange in mid-October as it was likely to miss the deadline to file restated financial results for fiscal 2009 under U.S. accounting standards.

Shares in Mahindra Satyam, previously called Satyam Computer Services, have surged 24 percent in September in anticipa tion of the results. They had peaked up 42 percent this month before news of the planned delisting dragged down the shares.

Peugeot, Mitsubishi team up

French automaker PSA Peugeot Citroen and Japan's Mitsubishi Motors said Wednesday they had signed an agreement to develop light commercial electric vehicles.

The carmakers said they will begin technical development of electric versions of the Peugeot Partner combi-van and the Citroen Berlingo, with the aim of beginning production by the end of 2012.

Earlier this year the companies scrapped an ambitious capital tie-up that would have created the world's sixthlargest auto alliance, amid reports of financial discord.

But they agreed to cooperate to share resources and cut costs in a bid to close down on rivals.

Mitsubishi announced a partnership with PSA Peugeot Citroen in April that will see the launch of a compact SUV in Europe in early 2012, based on the existing Mitsubishi RVR in Japan and its European counterpart, the ASX.

The global auto industry is increasingly joining forces to save billions of dollars through technology sharing and accelerate production of low-pollution electric cars.
