### ALLOWING IMPORT OF SCRAP SHIPS Six govt officials face

# contempt rule

The High Court yesterday issued a contempt of court rule against six government high officials for issuing no objection certificates (NOCs) to import scrap vessels violating its orders.

The Department of Environment recently issued NOCs to importer of MV Badri and MT BO though the HC earlier directed the government several times not to issue such NOC to vessels that do not have proper decontamination certificate obeying the Basel Convention.

An HC bench of Justice Md Imman Ali and Justice Obaidul Hasan yesterday also directed the contemnor officials to appear before it on October 13 in connection with the contempt of court petition filed by Bangladesh Environmental Lawyers Association (Bela).

The officials include the director general and director

(Chittagong division) of Department of Environment, director general and chief chemist of Department of Shipping, chairman of Chittagong Port Authority and collector of Customs (Import).

The court issued the rule asking them to explain within 10 days why contempt of court proceedings shall not be drawn against them for issuing NOCs to import scrap vessels violating court orders.

The court stayed the operation of the NOCs for one month and directed importers of scrap vessels to maintain status quo on dismantling of the ships.

Bela stated in the petition that the contemnor officials issued NOCs in connivance with the ship breakers that is a violation of the HC orders.

FROM PAGE 1 Hindus claim the site of the Babri Masjid is the birthplace of their deity, Ram, and want to build a temple there.

Prime Minister Manmohan Singh has appealed for calm. In a statement, he said: "My appeal to all sections of the people is to maintain peace and tranquility and to show respect for all religions and religious beliefs in the highest traditions of Indian culture."

The court ruled that the site should be split, with the Muslim community getting control of a third, Hindus another third and the remainder going to a minority Hindu sect, Nirmohi Akhara, which was one of the early litigants in the case.

It said that the current status of the site should continue for the next three months to allow the land to be peacefully measured and divided.

The Hindus will keep the area where a small tentshrine to Ram has been erected, lawyers said.

"The majority ruled that the location of the makeshift temple is the birthplace of Ram, and this spot cannot be shifted," said Ravi Shankar Prasad, a lawyer for one of the parties to the suit.

Both Hindu and Muslim lawyers say they will appeal against the ruling in the 60year-old case to the Supreme Court, which is likely to delay a final decision still further.

"We have to study the judgement in details," said Zafaryab Jilani, lawyer for the All India Muslim Personal Law Board.



Nothing was looted from the house, he added.

The four-storey house was equally shared by Mizanur and Linkon while the adjacent five-storey building was equally shared by Mizanur's two other brothers -- Lipton and Khokon, who died earlier.

Sadek said Mizanur and his mother Sufia had a feud with Linkon and Lipton over the possession of six shops at the front of the two buildings on Shahid Faruque Road in North Jatrabari.

#### **Bus drivers** sued over Sayedabad accident

The gateman of Sayedabad Railway crossing, the site of Wednesday's train-bus collision, was among the six killed and a case was filed yesterday with Government Railway Police (GRP) station at Kamalapur accusing the two bus drivers.

The body of the gateman Aminul Islam Jewel, 32, a resident of nearby Karatitola area, was identified by his younger sister Shilpi at Dhaka Medical College (DMC) morgue yesterday.

Abdul Matin Mondal sub-assistant engineer of Bangladesh Railway, filed the case.

Sources said the dead bodies were taken to their homes by their relatives.

GRP, Kamalapur has started investigation into the incident. Its Subinspector Wahidul Haque, also the investigating officer (IO) of the case, said none was arrested but the two buses were seized.

Though the level crossing had an auto type bar, he said it is still unclear whether the bar was brought down or

The IO said, quoting some witnesses, the two buses crossed the gate before the bar came down. Later, the buses could neither proceed as there was an iron bar nor could they backtrack due to severe traffic jam, he added.

Wahidul Haque said pedestrians were killed in the incident as most of the passengers got down from the bus seeing the train approaching.

He also said a fourmember investigation committee was formed by Bangladesh Railway to probe the accident.

The then Awami League government in 1997 signed the accord with the Parbatya Chattagram Jana Sanghati Samity (PCJSS) ending a twodecade-long bush war.

PCJSS Organising Secretary Shaktipada Tripura ment got three and a half years after signing the accord but did not take any effective measures to implement it.

"Before the ninth general elections Awami League pledged to implement the peace agreement but they have only reformed the Land Commission and removed some temporary army

The extension came on the last day of the five-day long income tax fairs in Dhaka and Chittagong, organised to boost tax collection and bring more people under the tax

Earlier, Ahmed, at a press conference at the Diploma Engineers Institute in Dhaka, said 55,707 taxpayer identification number (TIN) holders submitted their income tax returns worth Tk 117.19 crore.

Such fairs would be organised at divisional cities from next year, he added.

It was the first fair of its kind in the country and a total of 17,560 new TINs were registered.

The fairs opened simultaneously at the auditorium of Diploma Engineers Institute in Dhaka and the MA Aziz Stadium in Chittagong on September 26.

Thousands of businessmen, professionals and share traders thronged the fairs. Many queued for hours to submit their returns. The events offered TINs to

new taxpayers and helped them fill income-tax forms from 10:00am to 6:00pm each day. The authorities, however accepted statements till 8:00pm yesterday. As of September 29, about

3.26 lakh TIN-holders submitted tax returns, which is less than half of the last year's submission by 7.57 lakh people, according to NBR officials. A meagre 7.57 lakh people

paid income taxes in a country of 160 million people, although there are about 27 At 8.5 percent Bangladesh's tax-gross

domestic product ratio is one of the lowest in South Asia.

came out with more blunt intention, openly directing the health administration of the district to fill all the 13,500 posts with AL men. Much to the public disappointment, more such incidents or ruling party influences across the country were reported in the media. What a suicidal exposure it is for a party that came to power with a thumping majority and pledges for a change. For days the tension

brewed in Pabna before going from bad to worse. Examination centres for recruitment came under attack and government officials were assaulted. The administration got united and countered with an unprecedented public demonstration of its frustration over political influence, putting AL-loyalty before eligibility in recruitment. League men rallied and brought out processions to oust him from Pabna while the DC along with his colleagues stuck to his guns.

"The DC is not a good person, and he doesn't work for me or for the party [AL]. He is trying to tarnish my image by spreading propaganda against me," the lawmaker said. The DC, on the other hand, fired back: "I can't entertain any unlawful demand of the lawmaker. I'll discharge my duty as per the

Both the strong men boasted of support from Prime Minister Sheikh Hasina, who was then attending United Nations General Assembly in New York. There came a compromise formula, with the event getting more and more media focus and piling up embarrassment for the government. Twenty-one AL men landed in jail upon surrender, the DC along with the superintendent of police were withdrawn from Pabna and media was castigated for exaggeration.

Suppose, lawmaker Prince did not press for anything unusual that BNP leaders did not gun for while in power, the DC refused to budge for some reasons other than ethics or rules of service and a section of media went on to exaggerate. Still, the whole issue from which the unfortunate incident stemmed remains as ominous as ever, as bad as it could be for

the people and country.

The lawmaker was so hel bent on getting his men on government service that he dared to push his party on a collision course with the administration, support and sincerity of which are essential to fulfil election pledges and implement the development projects. And did he ever care to think what the people of Pabna would make of his aggressive actions? The MP is for the partymen, not for the people, and that the government would continue to deprive them of jobs for not

being AL activists. Now the question is whether there will be any soulsearching in the policymaking circle of the party, whose charter for change inspired millions of voters to be hopeful about a fresh start

towards a better Bangladesh. Would the AL bigwigs care to know what the ruling party has really gained out of the event--- 'yes' from some myopic partymen and huge

'no' from the people? Soon after the Pabna pub-

licity, some AL big names tried to smart from the crisis, telling that it is only natural that people's representatives will have some recruitment obligation to fulfil and that BNP leaders had done that too. As being the people's representative, lawmakers are pledgebound to uphold people's interest, not party's. They are expected to ensure only efficient and eligible candidates get recruited. And, under the charter for change, is not the AL supposed to break away from the culture of we-aredoing-as-they-did? All appointments must

have to be made on the

strength of eligibility. None but qualification should come into consideration for recruitment and promotion. The target should be, as desired by the people and as outlined by all who wish Bangladesh well, to have a small but efficient government workforce. We can no way achieve it if the government gives in to the demand for partisan appointment. And if this culture of recruitment continues, the only signal the people would get is that none but political activists would be employed. And the taxpayers, not politicians, will have to bear the burden.

The administration along with many, meanwhile, has been waiting for the premier to return home with an expectation that head of the government would act judiciously and impartially to tackle the situation, action of which can have a decisive impact on its prospect in the general elections due in little over three years. DC Manzur has certainly

scored some points in his favour despite his loyalty to the AL being questioned. He might have violated a rule of service by going public with his frustration, but he indeed was bold enough to stand against unethical interferences, for the people in other words. The DC was hastily withdrawn from Pabna, and a group of AL leaders was planning to teach him a good lesson for the 'disobedience' on arrival of the prime minister on Wednesday night. The bureaucrats are also waiting to see how prudently the prime

minister settles the matter. What the DC did should be subject of a fair departmental inquiry and suitable actions. But any action beyond rules can make the administration nervy and erode its confidence in the government. And no party knows more than the AL how dangerous it can be when the administration

becomes uncomfortable. Problems are not in short supply in people's life-- the crises of electricity, gas, drinking water, traffic, housing, spiralling prices of essentials and climate. The government is about to enter the third of its five-year term, and the country still waits to see how it delivers on those crucial

important fronts. The people have witnessed enough of excesses by leaders of its student and youth fronts over tenders in development work and even admission in schools and colleges. They have seen how terribly the government failed to contain

those bad boys. The government must wake up now to the reality and get its priorities fixed before people's vote of confidence in
