Suu Kyi sues junta to keep her party intact

Detained opposition leader Aung San Suu Kyi filed a lawsuit against Myanmar's junta at the Supreme Court yesterday for dissolving her party ahead of widely criticised elections, her lawyer said.

Suu Kyi's National League for Democracy (NLD) has been forcibly abolished for boycotting the November 7 vote, which activists and the West have condemned as a charade aimed at putting a civilian face on militaryrule.

The lawsuit aims to reverse the dissolution.

The NLD won a landslide election victory in 1990 but was never allowed to take office. Suu Kyi has spent most of the past 20 years in detention and is currently under house arrest.

In May, the Supreme Court threw out a suit filed by Suu Kyi aimed at preventing her party's dissolution.

Asked why the NLD is submitting yet another case with the court,

end on November 13, just days after the election.

Suu Kyi's lawyer told reporters: "We are continuing because we have not given up. If we give up we have nothing left to do." The New Light of Myanmar newspaper, a junta mouthpiece,

recently warned an unnamed party -- thought to be the NLD -- to drop protests against its abolition, and threatened jail for anyone impeding the upcoming vote.

The party decided to boycott the election in response to rules barringserving prisoners -- such as Suu Kyi -- from participating. The Nobel Peace laureate's current term of house arrest is due to

Myanmar has been ruled by the military since 1962 and critics say the generals are taking no chances for the upcoming poll.

One quarter of the seats in parliament are reserved for the military,

while the junta's proxy parties are seen as having a major advantage in



party created by former NLD members, is among those planning to contest the vote, a decision that put it at odds with Suu Kyi, who favoured a boycott.

Opposition parties have faced formidable hurdles, including a fee of 500 dollars per candidate -- the equivalent of several months' wages for most people -- and a tight time table to register to stand.

"The defeat of the US is imminent and will happen in the near future," Faisal Shahzad told the court shortly before his sentence was announced.

"Brace yourselves because the war with the Muslims has just begun," he said.

Authorities in Srinagar began removing some security bunkers yesterday as part of New Delhi's efforts to defuse tensions in the troubled region.

Kashmir has been in a siegelike state of strikes, protests and curfew for months, threatening to undermine rule from New Delhi, which has been fighting an armed separatist rebellion in the region since 1989.

More than 100 people have been killed and scores arrested in protests since June -- among the biggest since an armed separatist rebellion broke out in Kashmir in 1989.

"We have started removing (security) bunkers in Srinagar, the complete process will take couple of days," said Prabhakar Tripathy, a senior police official.

He said 16 bunkers will be removed in Srinagar, summer capital of Kashmir, one of the world's most militarised regions.

But the step may not be enough for Kashmiris who want the revocation of a widely-hated security law that gives the military sweeping powers to search, arrest or shoot protesters.

More than half a million security personnel are deployed in Kashmir, most of which, for years, has been declared "disturbed", a precondition for the application of the Armed Forces Special Powers Act.

Nepal police block vote by Tibetan exiles

Armed police have blocked thousands of Tibetan exiles in Nepal from voting for a new government-in-exile by forcibly seizing ballot boxes, police and activists said.

Witnesses said police stormed three separate voting centres in the Nepalese capital Kathmandu, home to almost 9,000 Tibetan exiles, as the election was being held on Sunday. "This was in total violation of

our human rights," said one exile, speaking on condition of anonymity. "We believe everybody should be allowed to vote."

Thousands of Tibetans living in India, Bhutan, Nepal, Europe and the United States took part in Sunday's vote, a preliminary election for a new prime minister and parliament in exile.

house owner Jahirul Islam, he did not let the tenants vacate the house. Jahirul used to earn Tk four lakh per month from house rent, Rokon-Ud-Dawla said.

The house is situated in a densely populated locality, and each of its floors had 49 rooms.

Shukkur Kazi, security guard of the house, said the house owner recently expanded the structure to six storeys, which was earlier twostorey.

Neither Jahirul Islam nor the factory owner Kamal Patwary lives in the house. There are at least 40 more

vulnerable multi-storied structures in the area and Rajuk would pull them down in phases, said Shafiqul Islam of Rajuk.

WASA CONTINUES CANAL RECOVERY DRIVE

On the second day of the canal recovery drive led by Wasa magistrate Kazi Wasi Uddin, the authority demolished two two-storey buildings and a one-storey building.

"We have demolished two two-storey buildings and a one-storey building on the second day of the drive," said a Wasa official.

He said Wasa started the drive on Katashur canal on October 4 to remove the illegal structures from the 1.8 km canal. "We will continue our work

for the next seven days to dig up the occupied portion of the canal to set up pillars for demarcation," said the official. Wasa will conduct more

drives on three more canals--Ramchandpur, Rayerbazar and Kalayanpur Ka canal-this month.

It will gradually recover lands from land grabbers of 13 canals of the city following the Cadestral Survey Map (CS map) and will set up concrete structure along the bank of the canal to stop further encroachment, he added.



Nasa launches Himalayas monitoring system in Nepal

A new system that will allow scientists to monitor the impact of climate change in the Himalayas using images from Nasa satellites was launched in the Nepalese capital Kathmandu on Tuesday.

Around 1.3 billion people depend on the water that flows down from the Himalayan glaciers, which experts say are melting at an alarming rate, threatening to bring floods and later drought to the region.

But relatively little is known about the impact of climate change on the vast region, which environmental campaigners describe as a "third pole" because of its huge water reserves in the form of ice and snow.

The web-based system, called SERVIR, will allow scientists, governments and aid agencies to access satellite images of the

Himalayas, giving them early warning of floods and other disasters and aiding research on climate change.

A Nasa statement said SERVIR, launched in partnership with the International Centre for Integrated Mountain Development (ICIMOD) in Kathmandu, could be used to address threats to biodiversity as well as risks from flooding, forest fires and storms.

"The whole of the Himalayan region is something of a black hole for scientists and we hope to use this system to bridge the data gap," said Basanta Shrestha, a senior ICIMOD executive.

"We can use this to monitor the dynamics of the cryosphere (ice systems) in the light of climate change, which is very important in terms of both disaster management and future water availability."

Indonesia president cancels Netherlands visit over arrest threat

Indonesia's President, Susilo Bambang Yudhovono, has called off a state visit to the Netherlands because of a threat that he could be arrested.

A separatist group, the Republic of South Moluccas (RMS), has asked a court to order his detention in connection with alleged human rights violations.

Mr Yudhoyono said that if he had gone ahead with the three-day visit, it might have led to a "misunderstanding".

Indonesian authorities crushed the RMS after it declared independence in 1950.

It was revived following the fall of President Suharto in 1998, and is currently based in the Netherlands, Indonesia's former colonial power. From 1999 until 2002, ethnic violence in the Moluccas islands left an estimated 5,000 people

dead and displaced 500,000 others. A spokeswoman for a court in The Hague confirmed that the RMS had asked for an

injunction to have Mr Yudhoyono arrested on arrival.

The group wanted him to face prosecution for the alleged human rights violations and the physical abuse of political prisoners, she added.

Mr Yudhoyono was reportedly already onboard his plane at Jakarta's airport yesterday when he decided to cancel the state visit.
