A case was filed with Manikganj Sadar Police Station. No one was arrested in connection with the robbery as of filing of this report at 6:00pm yesterday.

One held with bombs

He was arrested along with bomb-making materials in September this year and released on bail a few days ago, said Officer-In-Charge Motiar Rahman of Gangni Police Station.

Dubai expat strangled

A Dubai expatriate was strangled at village Loraighata in Moheshpur upazila on Tuesday night. The dead was identified as Hasanur Rahman, 32, son of Jalu Uddin of Kadamtali village in the same upazila. Locals and police said Hasanur went missing on Monday. Locals found his body in a ditch yesterday morning. Being informed, police rushed to the spot, recovered the body and sent to Sadar Hospital for autopsy. Enmity over land dispute might be the cause of the incident, police said.

BDR mutineers' trial

The Special Court-14 took into its cognizance the charges against 29 BDR mutineers of 1 Rifles Battalion at Kalikatcha in Sarail upazila of Brahmanbaria district yesterday. Witness Subedar Major Md.Nurul Karim brought the charges against the accused during the trial that began at around 11:00 am and continued until 12:25 pm. The Special Court adjourned the trial proceedings of the mutineers until 9:00 am today. Col SM Farhad of Comilla sector commander, chaired the fourmember special court at the battalion headquarters of 1 Rifles Battalion. The other members are Deputy Attorney General Farhad Ahmed, BDR officials Lieutenant Colonel Akhteruzzaman and Major Md Maksudul Alam. Lieutenant Col Abu Saleh Md.Gulam Ambia, the commanding officer of 1 Rifles battalion, is the procecutor while Gazi Zillur Rahman and Dewan Mohiuddin are the special procecutos. The special court asked the authorities concerned to arrest 12 fugitive accused in the case and produce them before the court. The rest 17 accused are now in Brahmanbaria jail. In a press breifing yesterday, Lieutenant Col Abu Saleh Md.Gulam Ambia said 29 members of the battalion revolted against their officer on February 26 in 2009, expressing their solidarity with the mutineers of BDR headquarter in Pilkahna, Dhaka.

10-yr-old girl saved from early marriage

An attempt of early marriage of a ten-year-old girl was foiled in Dumuria upazila on Monday evening due to timely intervention of upazila chairman Gazi Abdul Hadi and upazila women affairs officer Nazmun Nahar.

The girl was identified as Jony Akhter, daughter of Mahatab Sheikh, a butcher by profession at Katakhali village under the upazila. She is also a class five student of Dumuria Non-government Primary School.

Parents arranged the early marriage of the girl with a 22year-old man of Jamira village under Phultala upazila whose identity could not be known.

On a secret information, Dumuria Upazila Chairman Gazi Abdul Hadi, also joint

Awami League, and women affairs officer Nazmun Nahar rushed to Katakhali village and foiled the early marriage of the girl.

Nazmun Nahar said we including police could not know the name of the man with whom marriage of the girl was supposed to take place.

As all guests invited to the marriage ceremony, including the marriage registrar and the matchmaker, left the place before we reached there, none at the village could tell the name of the groom, upazila chairman Gazi Abdul Hadi said.

According to the women affairs officer, the girl was shifted elsewhere from her parents' house early yesterday. 'We are closely watching movement of her parents to locate the girl's wheresecretary of Khulna district abouts', Nazmun Nahar said.

Drug peddler gets life, 3 others held

A Chapainawabganj court yesterday sentenced a drug peddler to life imprisonment in a case filed under Narcotics Control Act while law enforcers arrested three others with illegal drugs in Mymensingh the same day.

In Chapainawabganj, District and Sessions Judge's Court awarded life imprisonment to Osman Gani, 27, son of Abdul Mannan of Raninagar village under Alatuli union of Chapainawabganj Sadar upazila, reports our correspondent.

Judge Anwar Hossain pronounced the verdict in presence of the accused. The judge acquitted another accused Alam Ali, 38, of the same village as charges brought against him could not be proved.

According to the prosecution, BDR team of Hakimpur border outpost arrested Osman in front of a house at Harishpur village in the upazila at around 7:10pm on December,26, 2007 and recovered 80 grams heroin from his possession

The BDR men handed him over to Sadar Police Station the following day and filed a case against Osman and his accomplice Alam under Narcotics Control Act.
