A puja festival with a difference

Devotees make 151 images on religious themes in Faridpur village

Durga Puja, the biggest festival of the Bangali Hindu community, this time sees an exceptional arrangement at Baikunthapur village in Madhukhali upazila of Faridpur district as 151 pratimas (image), exhibiting 22 different themes on the legends of the goddess have been erected there.

The themes include Sristi Rahosya (mystery of creation), Brindaboney Radha Krishna (Radha and Krishna in Brindaban), Satya Baner Jibon Tyag (Satya Ban's sacrifice of life), Hanumaner Ayoddhya Gomon (Hanuman goes to

Ayoddhya), Ram Sitar Bonobash Jatra (Exile of Ram and Sita) and Sitar Ogni Parikkha (Sita's test by fire).

Sculptor Basudev Goswami of Sonapur village of Rajbari with the help of his wife Dipali Goswami and sons Krishna Goswami and Boloram Goswami made the 151 images over the last four months. Mahanondo Paul and Shidun Halder also helped Basudev.

Baikunthapur Saha Jubo Sangho (BSJS) has arranged the festival in the yard of

Boidyanath Saha. "This is the first time Durga Puja is being celebrated with 151 depictions anywhere in

the country. I presented different themes with the help of my co-artists. The themes will help the visitors and the Hindu devotees to understand the inner significance of religion," Basudev Goswami said.

The main entrepreneur of the festival, Biplob Saha, son of Boidyanath Saha of Baikunthapur village, said, "Around Tk 12 lakh has been spent for making the beautiful depictions during last four months. The young men of Baikunthapur Saha Jubo Sangha are working selflessly to organise the celebration."

Nishisth Saha, one of the organisers of the festival, said forty famous people including

poets and writers form across the country will join the celebrations.

Madhukhali upazila Chairman Mafizur Rahman Manju said, "The celebration of Durga Puja with 151 depictions is really extraordinary. It has never happened before. A large number of enthusiasts from across the country are expected to visit Baikunthapur Mandap."

"The unique celebration of Durga festival in Baikunthapur village has created a lot of enthusiasm among the people in the district," Faridpur Deputy Commissioner Helaluddin Ahmed said.

BORDER COORDINATION MEET AT TENTULIA

BDR, BSF exchange lists of criminals

Bangladesh Rifles (BDR) and Indian Border Security Force (BSF) yesterday exchanged the lists of criminals of the bordering areas of the two countries at a sector commander level border coordination meeting at Tentulia in Panchagarh district.

Dinajpur Sector Commander Col Saleh Ahmed and Rangpur Sector Commander Col Mohammad Khairuzzaman led the eight-member BDR delegation while a ninemember BSF team was led by Kishanganj DIG Mohammad Farid Khan at the meeting at Tentulia Gano Sahajya Sangstha Bhaban in Tentulia upazila.

The meeting began at 11:00am and continued till 5:00pm.

Col Saleh Ahmed and Col Khairuzzaman received the BSF officials when they entered Bangladesh through Kazipara border in Tentulia upazila at 10:30am.

After the meeting, Col Saleh and Col Khairuzzaman told a press briefing that the lists of they said. criminals of the bordering

Four get life for four murders in Kishoreganj

Acid thrower jailed for 10 years in Bagerhat

A Kishoreganj court yesterday sentenced four people to life imprisonment for killing four people in 2000 while a Bagerhat court awarded 10 years jail to an acid thrower the day before.

The lifers are Gias Uddin alias Geshu, Jashim alias Murshid, Sabuj miah and Kalam alias Kanai of Katiadi upazila of Kishreganj district. Of them, Gias and Jashim are in jail while Sabuj and Kalam still at large, according to a correspondent.

Additional District and Sessions Judge SM Abdus Salam pronounced the verdict, acquitting ten others as charges brought against them could not be proved. He fined the convicts Tk 10,000 each, in default they are to suffer six months more

According to prosecution, the four entered an oil and fertiliser shop Paschim Bazar in Katiadi upazila on the night of February 24, 2000 and killed shop employees Dhirendranath Saha, 60, Shankar Chandra Saha, 35, and Shuklal Saha,60, and

truck helper Bijoy Chakraborty as they were asleep. They also took away Tk 75,000 from the shop.

Shop owner Priya Lal Roy filed a murder and looting case with Katiadi Police Station the following day, accusing 14 people.

In Bagerhat, Additionala District and Sessions Judge's Court on Wednesday

sentenced an acid thrower to 10 years rigorous imprisonment, reports UNB.

The court also fined the convict, Masud Sheikh, of village Chapatola in Sadar upazila Tk 20,000, in default he is to suffer two years more in jail.

According to prosecution, Masud threw acid on Minara Begum, wife Ismail Sheikh, of the same village, on the night of January 22 this year when she came out of their house to respond to the call of nature, leaving her critically injured.

A case was filed against Masud with Sadar Police Station the following day. After investigation, police submitted charge sheet against him on April 6.

Youth commits suicide

A youth committed suicide at Molankhori village under Sadar upazila of Thakurgaon district on Tuesday night. He was identified as Manik, 26, son of Saikat Ali of the village. Police quoted locals as saying that Manik took poison in his room after an altercation with family members in the evening. He was rushed to Thakurgaon Sadar Hospital where the doctors declared him dead. An unnatural death case was filed with Thakurgaon Police Station.

Robbers loot house

Armed robbers looted cash and other valuables from the house of District Primary Education Officer Abdul Kader in the city's Seroil Mothpukur areas early yesterday. A gang of 10 robbers entered the house through window of the kitchen and tied up Kader and his family members at gun point. Police said the gang took away Tk 2.70 lakh, 12 tolas of gold ornaments, mobile sets and other valuables.

7 hurt as AL rivals clash

At least seven people were injured in a clash between two factions of Awami League at Chardumuria in Sadar upazila on Wednesday night. Of the injured, three were admitted to Munshiganj General Hospital and private clinics in the town while the rest given first aid. Two factions--one led by district Awami League vice president Shah Alam Mallik and the other by sadar upazila Awami League vice president Mustafa Molla--clashed over selection of candidates for the next union parishad elections in the upazila. The feuding groups also traded gunshots during the clash that continued for two hours from 9:30pm. Police and Rab personnel dispersed the clashing groups and brought the situation under control.

One stabbed to death

A man was stabbed to death at Natunbandar village under Sadar upazila in Panchagarh on Wednesday night. The dead was identified as Abdul Matin,40, son of late Mohir Uddin. Officer-in-Charge of Panchagarh Police Station Jamiruddin told this correspondent over cellphone that Matin came under attack while he was returning home from a tea stall at the village at around 8:00pm. A gang of criminals stabbed in his head and neck and left the scene, leaving him critically injured. Locals took Matin to Panchagarh Sadar Hospital where the doctors declared him dead. Victim's wife Feroza Begum filed a murder case with Panchagarh Police Station yesterday. Police arrested Abdul Kader, 45, son of late Nasiruddin of the same village in connection with the murder.
