BNP central Joint Secretary General Mizanur Rahman Minu, also former mayor of Rajshahi City Corporation, was scheduled to attend the programme as

chief guest.

Another group, known as 'rebel group', with Hamidur Rahman as convenor and Amzad Hossen as joint convenor of upazila unit of BNP, also called a meeting at the same place and time. Both the groups made massive announcement throughout the upazila for last couple of

Upazila BNP sources said that the first group is supported by the party's Rangpur divisional Joint Secretary Shamsuzzaman Samu and the other group is backed by former party lawmaker of the upazila and incumbent mayor of Jaldhaka municipality Kabir Chowdhury.

On Friday night, both the groups brought out separate processions in the town in support of yesterday's meeting. At one stage, the rival groups chased and threw stones at each other.

To avert deterioration of the situation, district administration imposed Section 144 in Jaldhaka municipality area at about 10:30pm on Friday.

At about 10:00am yesterday, both the groups again called separate meetings outside the municipality area -- one group at Bara Ghat Haat and the other group at Tengon Mari Haat.

But police intervened at both the places and made the activists leave the places.

Later the upazila administration imposed Section 144 also at the two places that are well-known business centres of the upazila.

At a press conference held at a local hotel at 3:15pm yesterday, BNP Joint Secretary General Mizanur Rahman Minu said agents of ruling Awami League in the name of BNP workers tried to create chaos at Jaldhaka to foil yesterday's agitation programme.

He termed imposing Section 144 in Jaldhaka as an anti-democratic act.

7 hurt as BCL, Shibir clash in Cox's Bazar

At least seven people were injured as Islami Chhatra Shibir and Bangladesh Chhatra League (BCL) activists clashed at Cox's Bazar Polytechnic Institute at Muhuripara under Sadar upazila yesterday.

Locals said the activists of the student bodies were locked in an altercation while welcoming freshers near the main gate of the institute in the morning.

Later, they attacked each other, leaving seven people from both sides injured.

On information, police rushed to the spot, dispersed the clashing groups and brought the situation under control.

The BCL activists later Police arrested four students from the spot.

Locals gouge out eyes of 2 'robbers' in Bagerhat

Two drug peddlers held in Benapole

Local people caught three alleged robbers and gouged out eyes of two of them near Jielmari Bridge in Rampal upazila of Bagerhat district on Friday night while law enforcers arrested two drug peddlers in Benapole the same night.

In Rampal upazila of Bagerhat, locals said they challenged three robbers while they were going to Mongla riding a motorbike at around 9:00pm. "As they tried to flee, we chased the three and caught them, they said.

They are Binoy Mandol, 26, son of Krishnapada Mandol, Saheb Ali Sheikh, 27, son of Jalil Sheikh, and Alamin sheikh, 28, son of Abdul Hye Sheikh of the upazila.

Locals beat up the three and gouged out eyes of Binoy and Saheb Ali, They also torched the motorbike, according to UNB. On information, police

rushed to the spot and arrested the three along with a foreign made gun. The three were later admitted to Khulna Medical College Hospital.

Our correspondent from Benapole reported that two

drug peddlers were arrested with 202 bottles of phensidyl at Doulatpur village under Benapole Police Station at

midnight on Friday. The arrestees are Nazrul islam, 30, and Asaduzaman Ripon, 39. Acting on a tip-off, a team of Rab-6 raided the house of Nazrul at the village and arrested Nazrul and Asad along with the drugs.

The arrestees confessed to their involvement in drug peddling in the area. A case was filed against the two under Narcotics Control Act with Benapole Police Station.
