## NBR moves on spot assessment

The National Board of Revenue (NBR) will soon introduce a countrywide spot assessment for new taxpayers.

..........

NBR intends to meet taxpayers from next month to increase the number of payers and reduce the hassles they face.

"People's income has increased but the number of taxpayers has not. To find new taxpayers, we will continue the drive in rural areas through June next year," NBR Chairman Nasiruddin Ahmed told The Daily Star.

The NBR chairman said some payers allege that they face harassment while paying taxes. An event styled not mention any specific timeframe, 'Meet the Taxpayers' will be held at every tax zone on the second week of every month, to listen to their grievances.

NBR officials will be present at the programmes, where both income tax and value-added tax (VAT) payers would be able to lodge their complaints.

NBR has 18 tax zones across Bangladesh, and will make spot assessments in 10 growth centres in each. The NBR chairman and members from Dhaka will also participate in spot assessment in phases.

The NBR sent directives to the zones that will make a list of the prospective taxpayers. During spot assessment, they will be brought under the tax net.

### Farm loan distribution rises 32pc

Agriculture loan disbursement increased by 32 percent in the first quarter of the current fiscal year due to the central bank's move to speed up credit to rural areas.

In the July-September period of the current fiscal year, Tk 2,533 crore loans were disbursed, up from Tk 1,912 crore in the same period of the last fiscal year.

In the current fiscal year, the target for distribution of total farm loans was set at Tk 12,617 crore, which is the record highest. In the last fiscal year, a big amount of Tk 11,117 crore was disbursed as farm loans.

Officials of commercial banks said Bangladesh Bank took steps to increase distribution of agricultural loans, including a roadshow from Teknaf to Tentulia, where agricultural loan was one of the four themes.

The central bank held meetings with the chief executive officers and branch managers of banks at field level to ensure distribution of hassle-free loans to the farmers.

In the meetings, BB said one of the criteria for performance evaluation of the commercial banks would be the amount of agricultural loans distributed by them.

### Dhaka eyes deeper ties with Tokyo

#### Hasina visits Japan next month

Bangladesh's economic ties with Japan are set to deepen, as the two sides are in talks on a comprehensive economic partnership agreement (CEPA), which is likely to be signed during Prime Minister Sheikh Hasina's visit to Tokyo next month.

Officials of the two countries are working to finalise the itinerary for Hasina's visit that comes after the Indian primer's five-day Japan tour, starting today.

The Japanese government is expected to set November 28 as the date for the visit of head of Bangladesh govern-

Observers see the visit as crucial, as Japanese funding for the proposed Padma bridge will surface in Hasina's talks with her counterpart Naoto Kan.

Around half a dozen deals, including CEPA, and protocols among others on coordinated consular access and establishment of Japan Foundation in Dhaka to enhance people-to-people contact are likely to be inked during the

Attaching high importance to Hasina's tour of Bangladesh's largest development partner country, officials also point to the interests in exporting more, especially apparels, to Japan.

They note that exports to Japan last year were worth \$300 million.
