Stalkers injure 7 including two teachers in Madaripur

2 sued for assaulting madrasa girls in Satkhira

Stalkers and their accomplices injured two teachers and five students of Nurul Amin University College in Shibchar upazila of Madaripur district yesterday following protest against teasing a girl stu-

In Satkhira, father of two female students of a madrasa filed a case against two stalkers for assaulting his daughter.

A Correspondent reports from Madaripur: Kamal Hossain, a teacher of Nurul Amin University College, was conducting a class of HSC first year when Rokon Mia, a student of the class, uttered slang language directing at a female classmate, said teachers, students and police.

of the class, protested the act.

Centring the issue, a gang of 20 to 22 students led by Rokon surrounded Shafiqul, Yousuf and Rakib, all from Sheikhpara area, at around 9:00am yesterday.

As Shafiqul ran towards the students' hostel the gang chased him and beat him up mercilessly.

Being informed, Assistant Professor Jahir Raihan went to the spot, rescued Shafiqul and took him to the principal's room and gave him first aid.

Following assurance from the principal, Shafiqul, Yousuf, Rakib and several other students of Sheikhpura area went to the second floor of the college to attend a

gang led by Rokon again swooped on the students from Sheikhpura area and Shafiqul Islam, a student beat them up, injuring three people.

The criminals also injured teachers Jahir Raihan and Kamal Hossain as they tried to prevent the attackers.

On information, two teams led by Sub-Inspector Oliduzzaman and Sub-Inspector from Shibchar police station and Bhadrasan police camp rushed to the spot and brought the situation under control, college Principal Lutfor Rahman

Our Satkhira Correspondent adds: Father of two female students of a madrasa filed a case with Shyamnagar police station against two stalkers on Saturday night.

The accused are Ismail Hossain, 24, and Ibrahim A few minutes later, a Hossain, 21, of village Mahmudpur in Shyamnagar upazila.

Shahidullah Gazi of village Mahmudpur in Shyamnagar filed the case.

The complainant said Ismail and Ibrahim used to tease his two daughters, who are class nine students of Shyamnagar Kendriya Alim Madrasa, on the way to their institution.

The two men assaulted the girls when they were returning home from the madrasa on Thursday, he alleged.

As the news of the incident spread among the students, they informed madrasa Principal Maulana Ismail Hossain and demanded arrest and punishment of the stalkers.

Informed by the principal, police rushed to the madrasa and assured the students that they would take stern action against the stalkers.

We are trying to arrest the stalkers," Shyamnagar police station Officer in Charge Abdus Samad said after filing of the case.

Trial of 49 mutineers starts in Khulna today

The special court, set up at 41 Rifles Battalion headquarters in Satkhira, yesterday fixed February 6, 2011 for hearing on charge framing against 105 mutineers of the battalion while trial of 49 mutineers of 23 Rifles Battalion under Khulna sector will begin at a special court at the sector headquarters

In Satkhira, All the 105 mutineers were yesterday produced in the special court headed by Rajshahi Sector Commander Lt Col Yahiya Azam Khan.

Two other members of the court are Lt Col Khalid Hossain and Major Touhidul Islam, reports our correspon-

The court yesterday took the allegations against the BDR jawans into its cognisance.

Lt Col Enayet Karim, commanding officer of 41 Rifles Battalion, appeared as the prosecutor. He read out the allegations against the mutineers.

The chief of the court ordered supply of copies of charges to the accused while granting them 27 days to get prepared for reply.

Our Staff Correspondent from Khulna reported that Trial of 49 mutineers of 23 Rifles Battalion at Goalkhali under Khalishpur Police Station in Khulna will begin at a special court at the sector headquarters at 9:00am today.

The BDR personnel were accused of participating in the rebellion on February 25 and 26 last year, expressing solidarity with the mutineers of BDR headquarters at Pilkhana in the capital.

A case against the 49 Jawans was filed with Khalishpur Police Station on April 29 last year accusing them of breach of discipline and vandalism under BDR Act. The then officer-in-charge (OC) of the police station Abu Mokaddem Ali lodged the case as complainant. He was also made investigation officer of this

In the case statement, the complainant stated that the accused mutineers of 23rd Rifles Battalion came out of their camp with arms on February 26, set fire to the official car of Major Azhar and damaged the car of Major Sarwari Alam of the battalion.

The stage is set to begin mutiny trial at the special court where security measures have been stepped up deploying 100 policemen, said OC Moksedul Momen of Khalishpur Police Station.

President Nizam Uddin and activists Mamun and Arafat beat up the two in room No 304 at the hall at around 12:30am for not complying with BCL men's instruction to join the

procession.

They also hit Mahmud and Sharif with sharp weapons and iron rods. Seriously injured JCD activists were rushed to the medical college hospital. police have been deployed on the campus following the incident.

Rokanuzzaman Bappi, convenor JCD university unit, has demanded punishment to the BCL men who attacked the JCD activists.

Contacted, Proctor Dr Anwar Hossain said a probe committee is being formed and actions will be taken against the persons responsible for the attack.

One beaten to death in Noakhali

One person was beaten to death and seven others injured by a gang of criminals at West Maijdee village under Sadar upazila of the district on Saturday night.

The deceased was identified as Mohammad Hossain, 60, of the village.

The injured are Shakil, 28, Monju, 20, Rubel, 18, Nazma, 25, Runa, 20, Tahera Begum, 50, and Sajib, 25.

Police and family sources said a mobile set was stolen at the village three days ago. Local criminals Kala Hazari, Badal and Rubel accused Shakil, son--in-law of Mohammad Hossain of stealing the mobile set and attacked the house of Mohammad Hossain at around 11:00pm.

They entered the house by breaking open the door and beat up Mohammad Hossain and other family members. Hossain died instantly. On information, Sudharam

police rushed to the spot, recovered the body and sent it to Noakhali hospitalmorgueforautopsy.

Tahera Begum, wife of the deceased lodged a case with Sudharam police station in this connection.

One gets life for abducting three schoolboys

A Chapainawabagnj court yesterday sentenced a man to life imprisonment for abducting three schoolboys in

Judge of the Women and

Children Repression Prevention Tribunal Arup Kumar Goswami pronounced the verdict. The convict is Tofazzal

Hossain, 28, son of Abdul of Satuwill village under Niamatpur upazila of Naogaon district. The court also fined him Tk 20,000, in default, he is suffer another year in jail.

The judge acquitted two other accused -- Mohammad Selim, 32, son of Abbas Ali,

and Mohammad Mahidur, 30, son of Faizuddin of Balutungi village under Shibganj upazila of Chapainawabganj district as charges brought against them could not be proved.

According to the prosecution, Tofazzal, Selim and Mahidur kidnapped Nadim Hossain, 15, son of Mozammel Haque, Sohel Rana, 14, son of Lal Mohammad, and Zamal, 15, son of Almas of Balutungi village, from Baroroshia village in Shibganj upazila when the three were going to a private tutor at around 3:30pm on June 5, 2005.

The kidnapper took the boys ton Dhaka and confined them to a room at Shyamoli. After a day, the boys managed to escape and informed their guardians. Being informed, their guardians went to Dhaka and rescued them from Shyamoli area on June 6, 2005.

On June 9, local people caught Tofazzal, one of the abductor, at Monakasha Bazar in Shibgonj upazila on June 9 and handed him over to Shibgonj police.

Nadim's father Mozamme Haque filed a case against Tofazzal, Selim, Mahidur with Shibganj Police Station under Women and Children Repression Prevention Act on June 9, 2005. Sub Inspector mahfujur
