SL's lone CWG gold medalist fails dope test

Sri Lanka's only gold medalist at this month's Commonwealth Games, boxer Manju Wanniarachchi, has tested positive for a banned steroid, a report said on Sunday. The privately run Lakbima News newspaper said Wanniarachchi, 30, who had brought home the island's first Commonwealth boxing gold in 72 years, had tested positive for the performance-enhancing steroid nandrolone.

The paper said the Commonwealth Games organisers had sent a report to Sri Lanka's National Olympic Committee and informed the boxer of the result with his urine "A" sample.

Title aspirants Abahani are looking forward to making it to the final of the season's curtainraising tournament for a record 15th time when they take on Brothers Union in the first semifinal of Grameenphone Federation Cup at the Birshreshtha Mostafa Kamal Stadium in Kamalapurtoday.

Despite possessing the record of playing the fed cup final a joint-highest 14 times in the 30-year history of the tournament, the title has eluded Abahani in the last decade. Their seventh and last-to-date triumph came in the 2000. They made it to the final in the last two editions, but each time were beaten by archrivals Mohammedan, a record 10-time title holders, who have already been eliminated this time from the group stage.

On paper, Abahani are definitely the superior side in today's game against Brothers but the Dhanmondi-based outfit have failed to do justice to their names in three matches they have played so far on way to confirming the semifinals. With every match, their performances went downhill and the ability to score was a cause for concern for the Sky Blues, managing only three goals in as many matches.

In fact, Abahani were lucky enough to reach the semifinals after Sheikh Russel captain Samir Omari wasted a penalty kick which would have otherwise eliminated the Sky Blues.

It is evident that whenever Abahani and Brothers square off, entertainment is on the menu. This time the clash is even more mouthwatering with the spice added by the recruitment of Brazilian playmaker Everton and Ghanaian striker Enock Bentilto to the three-time champions Brothers attack-line that makes them real a force to be reckoned with.

However, the Abahani officials said they are not fearing the Brothers attack and are hopeful of a good performance and looking to fire on all cylinders to reach the final for record 15th time.

"We played well in the first match, then missed some scoring chances in the second game and our backline looked feeble in the third match. But we are hoping that the boys will come up SEE PAGE 18 COL 1

Here is a brief comparative look at some of the salient clauses of the Bangladesh Cricket Board's constitution regarding the functionalities of a Chief Executive Officer (CEO) and the proposed amendments that will see a Chief Operating Officer (COO) replacing the CEO.

CEO

Sub clause 14.1 (BA):

Appointment of Chief Executive Office: Bangladesh Cricket Board will nominate, select and fix the salary and other facilities before appointing a chief executive officer. The CEO will carry out the following duties on the sidelines of duties entrusted by the executive committee from time to time.

Sub clause 14.1 (BA) 3:

He will always through the president remain under the guidance and supervision of the board of directors and will work on the suggestions of the board of directors.

Sub clause 14.1 (BA) 7: He will always thrive to expand and develop Bangladesh Cricket

Board's economic, corporate, administrative and sporting activities through his highest quality of administration and manage-

Sub clause 14.1 (BA) 9:

He will, if needed, prepare report, prepare proposal for the executive committee or for any standing committee and will submit those to the board of directors or to any related standing committee through the president.

Sub clause 14.1 (MA): Appointment of chief financial officer

(He) will nominate, select and fix the salary and other facilities before appointing a chief financial officer. The chief financial officer, under the supervision of the CEO, will carry out the duties entrusted by the board of directors.

The hosts clinched the series 1-0 by virtue of their five-wicket victory in the second match in Visakhapatnam on Wednesday. The opening onedayer in Kochi was also washed out by rain.

India completed a rare double against Australia at home, having earlier clinched the two-Test series 2-0.

There were many issues on the agenda during the press conference after yesterday's annual general meeting of the Bangladesh Cricket Board (BCB) but the subject that brought it to life was one word: Nimbus.

The groundbreaking six-year deal, penned in July 2008 (after the Head of Agreement of the contract was signed in November 2006), was worth 56.88 million dollars but has since become a constant thorn on the board's side.

Board president AHM Mustafa Kamal said Nimbus owes a lot of money to BCB, in excess of 22 million dollars, and they are trying to figure out a way to bring the money.

"We are supposed to get a lot of money from Nimbus, like 20 to 22 million dollars. The deal, signed during the caretaker government, was not done properly," said Kamal.

"We are trying to arrange two events with

India in near future but it has to be within the time frame of our contract with Nimbus. "I hope that we can make something out of it because it can offset some of the 14 to 17 million dollars they owe us and through the tours, we can also earn 4 million dollars," he said, adding that the tours could be confirmed

The board chief also said that Nimbus, due to several reasons, is unable to keep their end of the bargain. "According to them, there were material changes like matches being held in March instead of November, or from Sunday to Friday or day matches being played day-night. They faced obstacles due to these and some other issues," informed Kamal.

"It is surprising that such a deal was signed. They [Nimbus] did not implement the bank guarantee. It is almost like a blank paper that we have had to work on," he added.

A vital component of the big-money contract -- bank guarantee -- has never been implemented although it was incorporated in the Long Form Agreement (LFA) during Sina Ibn Jamali's reign as board chief, some 20 months after the Head of Agreement was signed without a clause for the guarantee.

"We couldn't go out of the Head of Agreement due to its limitations. For the board's interest, we had to make sure we get the best out of the deal and made sure we incorporated the bank guarantee in the LFA," said BCB vice-president Ahmed Sajjadul Alam, who was part of the board when the LFA was penned.

"One has to bear in mind that without the LFA, Nimbus was not paying us any money. I would stress that the LFA wasn't perfect simply because there were compulsions in the Head of Agreement," he added.
