Court extends bail to Paban

A Dhaka court on Sunday granted a seven-day extension of the bail order to Khandaker Akhter Hamid Paban, son of BNP Secretary General Khandaker Delwar Hossain, in a cracker blast case.

Judge Mohammad Zohurul Hoque of the Metropolitan Sessions Judge's Court passed the order after Paban's lawyer submitted a petition seeking extension of bail term on grounds of illness.

Earlier on October 10, the same court granted him a 15day bail that expired yesterday. Paban's lawyers submit-

ted a petition yesterday morning when the judge asked them to produce their client before the court for failing which the extension will not be granted unless they submit a medical certificate stating why Paban was unable to attend the court.

Formulate law to stop mineral resources export

Speakers urge govt

The government should pass specific law that will impose embargo on exporting mineral resources from the country, speakers of Dhaka-Fulbari long-march urged yesterday.

The country has not enough reserve of mineral resources including gas and coal for next 50 years. So there should be a law to ban exports of mineral resources, they said.

National Committee for Protection of Oil, Gas, Mineral Resources, Power and Port as part of its long-march organised a rally at Tangail Shaheed Minar, where speakers made the urge.

The long-march to press a 7-point demand to resolve energy crisis started on Sunday from Dhaka and will end at Fulbari on Saturday, said a press release.

They also reiterated their demands for implementation of Fulbari treaty immediately.

Committee Convener Engr Sheikh Mohammad Shahidullah, Member Secretary Anu Mohammad, Manjurul Ahsan Khan, Bimol Biswas, Khalekuzzaman, Ruhin Hossain Prince, among others, attended the rally.

Street rallies at different points including Konabari, Chandra, Alenga and Sirajganj were held during the long-march yesterday. Our Correspondent from Tangail adds: Leaders of the com-

MBBS Admission Test

Results of public medical colleges published

The results of MBBS admission test for 18 public medical colleges were published yesterday.

For the first time, a combined admission test for both public and private medical colleges was held on October 22. The results have been posted on website 'www.dghs.gov.bd'.

A total of 2,366 students were selected for the public medical colleges, 46 of them under freedom fighters' children quota, 20 under indigenous quota and the rest general students, said Prof Khondakar Md Shefayet Ullah, Director of Medical Education under Directorate General of Health Services.

He also said a total of 3,350 candidates were selected for the private medical colleges and their merit lists will be published within a week.

Four hundred candidates are also selected for waiting list in general seats for the public medical colleges, 10 under freedom fighter quota and eight under indigenous quota. They will get chance on the basis of vacant seats in

order of merit.

If any students want to challenge their results, they have to apply for result reexamination within 30 days of the result publication. The last date of the admission is November 15 and the classes will start from January 2011, said Dr Shefayet Ullah.

"After admission, if any students don't want to study, they can apply for cancellation of their admission within 30 days after starting the classes to get back their original marks sheets and certificates of SSC and HSC," he said.

The interested candidates having TeleTalk phone connections would also be able to find their results through sending short messages by typing 'MISdghs<space>college code<space>registration no to '9934'.

Candidates for the private medical colleges will also get their merit lists by sending same SMS within a week.

A total of 43,644 candidates competed for seats in 61 public and private medical colleges for the academic year of 2010-2011.

HC clears way for trial of Redowan

The High Court (HC) yesterday cleared the way for continuing a corruption case against former BNP state minister for liberation war affairs Redowan Ahmed at the trial court.

Earlier in 2008, the same court had stayed the proceedings of the case against Redowan, now a presidium member of National Democratic Party, following a writ petition filed by him challenging the legality of the proceedings of the case.

An HC bench of Justice Md Ashfaqul Islam and Justice SM Emdadul Hoque yesterday came up with the verdict by rejecting the same writ petition.

Freedom fighter Nurul Islam filed the case with Ramna Police Station on February 15, 2007, accusing Redowan of misappropriating Tk 50 lakh from the fund of Bangladesh Muktijoddha Sangsad during his tenure as state minister of the liberation war affairs.

police box around 11:15am as Nikhil made a comment on the role of traffic police deployed at the spot. The traffic police there allowed some traffics taking right turn near the police box while some are barred, said Amitosh who

Sangsad Bhaban area. Traffic sergeant Mahbub rushed in and seeing the word "Press" on the bike got furious and instructed constables Rashid and Raihan to beat them up, he said.

The two policemen then took the journalists to the police box and beat them up severely, Amitosh added.

At one stage, traffic inspector Rafiq reached the spot and stopped the constables from beating, he said. Following the incident, journalist leaders at an emergency meeting

SC vacates HC order: No bar to shift Babar from BSMMU

The Supreme Court (SC) yesterday vacated a High Court (HC) order that directed the government not to shift former BNP state minister for home affairs Lutfozzaman Babar from Bangabandhu Sheikh Mujib Medical University (BSMMU) hospital.

A three-member bench of the Appellate Division headed by Chief Justice ABM Khairul Haque passed the order following a government petition challenging the HC order.

Assistant Attorney General Ekramul Haque Tutul said there is no legal bar to shift Babar from BSMMU for producing him before a Chittagong court in connection with ten-truck arms haul case following the SC order.


In response to a petition filed by Babar, the HC on October 12 asked the government not to shift him from the hospital for two weeks. Earlier on October 3

Metropolitan Magistrate Court

in Chittagong permitted the police to show Babar arrested in the case linked to the country's largest ever arms haul in Chittagong on April 2, 2004, and ordered the jail authorities to produce him before the court on October 13. Babar was not produced

before the trial court on October 13 following the HC order. Attorney General Mahbubey

Alam and Additional Attorney General MK Rahman argued for the government, while barrister Rafique-ul Huq appeared for Babar.



CEO arrives today UNB, Dhaka
