20 acres of railway land grabbed in Lalmonirhat

About 20 acres of railway land in different areas of Lalmonirhat Sadar upazila have been illegally occupied during the last two months, allegedly by local influential people.

Ten structures have already been constructed on the grabbed lands around the now abandoned Lalmonirhat-Mogholhat tracks and at least 20 more are currently under construction at different points near Futani Market, Durarkuti, Fulgachh and Mogholhat.

Lalmonirhat Railway Divisional Estate Officer Abu Sayeed denied the allegations against railway officials and said his office did not issue any lease order for the land of abandoned Lalmonirhat-Mogholhat railway track.

However he said that he heard about the illegal structures being constructed.

"My office has been preparing a list of railway land grabbers. I will take legal action against them as soon as possible," Sayeed said.

Magura BNP feud spreads to local Jubo Dal unit

2 groups hold separate programmes on founding day

Internal conflict of Magura district unit BNP has now spread to front organisations as rival factions of Magura district unit Jubo Dal yesterday held processions and meetings separately to cele-brate its 32nd founding anniversary.

Since July last year, Magura district BNP has remained divided into two factions -one led by the unit's existing president Kabir Murad and general secretary Ali Ahmed Biswas and the other by president of the 'rebel group' advocate Mokaddes Hossain and general secretary Iqbal Akter Khan.

Backed by the first faction, Jubo Dal group led by the district unit Jubo Dal leaders Abu Sayeed-al-Mamun and Washikur Rahman Kallol brought out a procession from the BNP office on Shahid Mintu Road. Later, they held a discussion at its office premises where Washikur Rahman presided and Kabir Murad was the chief guest.

Ali Ahmed Biswas, Mihir Kanti Biswas, Ashraful Islam, Amirul Islam and Abu Sayeedal-Mamun addressed the discussion, among others.

The other faction held its discussion at Chourongi Square in the town where

Iqbal Akter Khan addressed as the chief guest. Faruk Ahmed Babul, Kutbuddin Ahmed, and Ashrafuzzaman Shamim addressed the meeting, among others. District Jubo Dal president Alamgir Hossain presided over the function.

Internal feud of Magura district unit of BNP that started in July last year over formation of committees at different levels has recently spread even to upazila and union levels, party insiders said.

Trial of seven JMB men begins

Sylhet Divisional Speedy Trial Tribunal yesterday started trial of seven accused in Habiganj serial blasts case.

The tribunal recorded statements of six witnesses to the serial blasts that took place in the district town on August 17, 2005. Judge Mahbub-Ul-Islam

fixed November 3 for recording statements of rest of the witnesses, Special Public Prosecutor Ashoke Kumar Kar told this correspondent.

Five of the accused, including outlawed JMB chief Maulana Saidur Rahman and his son Shamim, were produced in the court while Salah Uddin and Shafiqul Islam alias Nazim are still at large.

The tribunal on 14 October framed charges against the accused. According to the prosecution, the accused

exploded seven bombs in front of the deputy commissioner's office, pourasava market and and five other places of the district town. Police arrested Shamim at

IB computer centre at Tinkona pukur par in the district town on September 7, 2005. They also seized some books on jihad and CDs from the center.

The Criminal Investigation Department submitted the charge sheet against seven people, including Moulana Saidur Rahman and his son Shamim in December 2009.

Hearing on charge framing against 23 on December 20

Court chief Col Saleh Ahmad, Dinajpur sector commander, fixed the date and adjourned the trial proceedings until December 20. Other members of the court are Lt Col Mahaful Alam and Major Didar Al Latif. All the 23 accused were produced in the court.

On Tuesday, 10 BDR men of the battalion were arrested after the court issued an arrest warrant against them for their involvement in the mutiny. They were later handed over to the police who sent them to Dinajpur jail.

Assistant Nayek Subedar Md Asaduzzaman of the battalion read out allegations against the accused on Tuesday.

The complainant alleged that the BDR personnel looted arms from armoury and revolted against their officers on February 25 and 26 last year, expressing solidarity with the mutineers of

Bangladesh Rifles (BDR) personnel arrested two drug traffickers and seized heroin worth Tk 2.65 crore from them at Moharajpur in Chapainawabagnj Sadar upazila yesterday. The arrestee are Golam Mostofa, 30, son of Mohammad Jamal of Phatapara village, and Tajal, 24, son of Abdus Sattar of Goaldubi village under the upazila. Acting on a tip-off, a BDR team of Chapainawabagnj battalion headquarter went to Moharajpur village at around 11:00pm and arrested the two with a tool box. They opened the tool box and found 2.65kg heroin in it. Zayeed Hossain. Commanding officer of 39 Rifles Battalion, said they handed over the traffickers to Sadar Police Station and lodged a case against them under the Narcotics Control Act.

16 hurt in B'baria clash

At least 16 people were injured in a clash between two rival groups over control of Nidarabad tempo Stand under Bijoynagar upazial of the district yesterday. Police and witnesses said Nazrul and Jalil groups, equipped with lethal weapons, attacked each other in the afternoon, leaving at least 16 people from both sides injured. Ten shops near the tempo stand were also ransacked during the clash that continued for half an hour. On information, law enforcers from Bijoynagar Police Station rushed to the spot, dispersed the clashing groups by firing rubber bullets and brought the situation under control. Of the injured, Akkas Ali, 40, Janab Ali, 45, Mozzamel, 32, and Abdul Jalil, 35, were admitted to Brahmanbaria Sadar Hospital while the rest given first aid at the hospital. No case was filed in connection with the incident as of filing of this report at 6:00pm yesterday.
