Biman pilots call off strike

PM assures them of looking into their demands

In a late night development, pilots of Biman Bangladesh Airlines called off their strike following assurance of Prime Minister

Sheikh Hasina. "From now on all the pilots have joined our respective duties on assurance of the premier to look into our demands," Captain Shah Alam told The Daily Star coming out of Gono Bhaban. Captain MA Basit Mahtab, general secretary of Bangladesh

Airline Pilots' Association (BAPA), and Shah Alam went to the residence of the premier on her invitation to talk about the deadlock between the pilots of Biman and its management. "But the prime minister could not see us as she had family

engagement. She sent her Assistant Personal Secretary Saifuzzaman Shikhor with her message," Shah Alam added. "We placed our demands before him and he assured us that the prime minister would look into our demands seriously,"

added the senior pilot of Biman. The pilots and Saifuzzaman had talks for over two and a half

They, however, declined to give The Daily Star details of the discussion.

Following the pilot strike, Biman had cancelled all its flights scheduled for yesterday and today but three flights did take off yesterday under special arrangements with foreign crew flying the planes, sources at Biman's operation department said.

Flights for Sylhet, Kolkata and Jeddah took off yesterday.

Hi-tech fraud in admission test of DU

Rab yesterday arrested a gang of eight students who sent answers to multiple-choice questions via SMS to freshmen aspirants inside Dhaka University admission test

A team of Rab-3 and officials of DU administration tracked the gang for a week after an admission seeker, who was approached by the gang, gave them the lead.

Rab caught kingpin Aminul Islam inside a Kha unit admission test hall when he was sending out answers to admission seekers via text messages. THEFORGERY

Aminul prepared well for the exam and entered the hall with a fake identity and a hidden mobile phone. He got set number three of the question paper. He then texted "3" to five of his gang members, who forwarded the text to their client students. The client freshmen aspirants had also smuggled in mobile phones inside the test halls.

Bangladesh Army yesterday filed a case against 50 to 60 unidentified people in connection with the recent clashes between law-enforcers and villagers in Rupganj of Narayanganj. Aminur Rahman, a warrant officer of unit 34

of East Bengal Regiment in Dhaka Cantonment, filed the case with Rupganj Police Station around 12:30am. The case statement claims that the accused

inflicted a loss of Tk 45.2 lakh on the army by attacking its camps during the violence.

FLASH FLOOD-HIT HAOR AREAS

Tk 50cr rehabilitation scheme for farmers

The government is going to launch a Tk 50 crore agricultural rehabilitation programme for about 4 lakh farmers affected by flash floods in the last Boro season in the haor areas of northeast region of the country.

A total of 3,83,160 farmers in five districts -- Kishoreganj, Sunamganj, Netrakona, Moulvibazar and Sylhet -- will be given farm inputs worth Tk 1,077 each under the programme, Agriculture Minister Matia Chowdhury told The Daily Star.

Each farmer will get 10 kg of paddy seeds, 25 kg of urea, 12.5 kg of muriate of potash (MOP) and 12.5 kg triple super

phosphate (TSP) fertilisers.

Prime Minister Sheikh Hasina is scheduled to inaugurate the programme from Sunamganj in the first week of next month, officials said.

Of the farmers, who will get the farm inputs, 2.5 lakh are of Sunamganj, 70,000 of Sylhet, 40,000 each of Moulvibazar and Netrokona, and 30,000 of Kishoreganj. They were badly affected as flash floods destroyed their Boro crop in April this year.

"We have decided to rehabilitate these farmers so that they can overcome their loss of Boro crops," Matia Chowdhury said.

Two bags of urea and one bag each of TSP and MOP fertilisers will be given to four lakh farmers, she said, "We will not open the

bags so that no farmer can say he got less than the specified quantity, or no one can

misappropriate the agricultural inputs." Distribution will be completed within one week of inauguration of the programme so that the farmers can prepare Boro seedbeds for the next season. If seedbeds are made early, there will be less risk of damage of the crop in flash floods, the minister said.

The farm inputs will be given on the basis of farmers' cards, which the agriculture ministry already issued to the farmers in the country. If any farmer has not yet received this card, he can get it by following the procedure for this. And he **SEE PAGE 15 COL 6**

The government has decided to send female garment workers to Jordan only through state-owned recruiting agency BOESL fearing a rise in migration costs and malpractices by private agencies.

"We have asked the private recruiting agencies to reduce the migration charge but they have not done that as yet," Expatriates' Welfare and Overseas Employment Minister Khandaker Mosharraf Hossain told The Daily Star recently.

"Bangladesh Overseas Employment

Services Ltd will charge each female migrant worker a nominal fee of Tk 12,000. It will also keep a watch on their well-being during their stay in Jordan," he

A few Jordanian employers and Bangladeshi recruiting agencies, who have long been partners in recruitment,

are unhappy at the government decision. They said the BOESL is not efficient enough to send workers abroad quickly

Some Jordanian employers warned that they might look for an alternative

source of manpower if the Bangladesh

government does not allow the private agencies to send workers to Jordan. Quoting some Jordanian employers,

Bangladesh Embassy in Jordan informed the authority concerned in Dhaka of the matter.

In a letter to the expatriates' welfare ministry on October 6, Toufiq Islam Shatil, first secretary of Bangladesh Embassy in Amman, said Jordan lifted a ban on recruitment of Bangladeshi workers in July after nearly three years.
