Bombs recovered

UNB, Comilla

Crime Prevention Company-2 of Rab- 11 in a drive recovered 10 hand bombs and one pistol from Aronnyapur village in Sadar upazila on Friday night. Acting on a tip-off, a team led by company commander Major Abdur Rahman conducted the drive at the graveyard near Khanbari of the village at midnight and recovered the bombs and firearm in abandoned condition. In another drive the same team seized 50 kg of hemp packed in a sack from Miabari area of Shaldhor village in the same upazila at about 11:00 pm in abandoned condition.

Woman commits 'suicide'

UNB, Dinajpur

A housewife allegedly committed suicide by taking poison over family feud at Nababpur village in Kaharol upazila on Friday. The deceased was identified as Maria Begum, 26, wife of Mannan Ali of the village. Family sources said Maria took poison in the morning following a quarrel with her in-laws. Later, she was admitted to Dinajpur Medical College and Hospital where she died at about 11:00am.

Section 144 at Koira

UNB, Khulna

Section 144 was imposed in Koira upazila Sadar from 8:00am to 8:00pm yesterday as opposition BNP and ruling Awami League (AL) called separate meetings at the same time and same venue. Upazila unit BNP called a meeting at 3:00pm in front of Palli Unnayan Samity premises as part of its central programme. Meanwhile, upazila unit AL and Muktijoddha Sangsad jointly called a meeting at the same place and same time to press home their various demands. Apprehending possible clash between the two rival parties, local administration imposed Section 144 in the area.

Man stabbed to death

UNB, Habiganj

A man was stabbed to death by his rivals over land dispute at Burhanpur village in Nabiganj upazila on Friday. The deceased was identified as Mufti Miah, 45, of the same village. Suraha Begum, wife of Mufti Miah, was also seriously injured when she tried to save her husband. Police quoting locals said there was a long-standing dispute over the ownership of a plot of land between Mufti Mia and Saju Mia of the village. As a sequel to the dispute a quarrel ensued between them in the morning and at one stage Saju Miah and his men stabbed Mufti Mia indiscriminately leaving him dead on the spot. On information, police rushed to the spot and arrested one Tanvir, 25, of the village in connection with the murder. Injured Suraha Begum was rushed to Sylhet Medical College and Hospital where her condition was stated to be critical.

Women, child rescued

UNB, Satkhira

BDR members, in a drive, rescued two young women and a child from Laxmidari border in Sadar upazila on Friday evening while being trafficked to India. The rescued were identified as Sumi Begum, 25, and Ratna Begum, 23, daughters of Yusuf Ali of village Madanmia Chandpur in Faridpur district and Ratna's daughter Liza aged about 18 months. BDR 41 Rifle Battalion Bhomra camp sources said on secret information they launched a drive at the border and rescued the victims while they were being trafficked to India in the name of giving good jobs there. The border guards said sensing their presence the human traffickers managed to flee the scene. The rescued victims were handed over to Sadar police station.

Demand human chains in Pabna, Natore

Human chains were formed in Pabna town and Natore yesterday demanding punishment to the killers of college teacher Mizanur Rashid and Chanpa Rani Bhowmik.

Teachers, students, guardians and representatives from different professional bodies yesterday joined a human chain at Abdul Hamid Road in Pabna town demanding punishment to the killers of Mizanur Rashid and Chanpa Rani, reports our correspondent.

Nari Nirjatan Protirodh, Jote, an organisation against torture on women, organised the human chain programme for an hour from 10:30am.

Addressing a rally at the venue, the speakers urged the government to take immediate action against the killers of Mizan and Chanpa Rani. They also stressed the need for creating social awareness against the menace of stalking.

Stalkers killed Mizan by ramming him with a killers.

motorbike as he had protested stalking of his female students in Bagatipara upazila of Natore district while Chanpa Rani in Modhukhali upazila of Faridpur district met the same fate as she had complained to local authorities against a stalker of her daughters.

Our correspondent from Natore adds: Bhumihin Samity and Nijera Kori jointly formed a human chain at Malonchi Bazar under Bagatipara upazila in the district yesterday noon demanding immediate trial of the killers of college teacher Mizanur Rashid.

Fighting for life for 12 days, Mizan died at Bangabandhu Sheikh Mujib Medical University Hospital on October 24. After the human chain, Rajshahi divisional trainer of Nijera Kori Abdur Rashid, Bagatipara regional chairman of Nijera Kori Tapon Kumar Sarkar and Bhumihin leader Arshed spoke at the rally and demanded exemplary punishment to the

50 hurt as AL, BNP clash

At least 50 people, including 5 journalists, were injured in a clash between ruling Awami League and opposition BNP in front of fire service office at Borhanuddin upazila yesterday morning.

Sources said the clash ensued at about 11am when the two rival groups failed to hold their scheduled meetings at Borhanuddin Bazaar as the upazila administration imposed Section 144 from 6am to 6pm yesterday.

Of the injured, 18 were admitted to different hospitals and clinics of the upazila.

In Laxmipur, at least 15 people were injured in a clash between two factions of BCL over a cricket bat at a local bazaar in Sadar upazila yesterday.

Witnesses said an altercation ensued between Jabed and Delwar groups over missing of a cricket bat at noon.

Later, both groups equipped with lethal weapons attacked each other at local Maju Chowdhury's market that left 15 people injured from both sides.

A motorbike was torched during the clash.

In Munshiganj, at least six people, including women, were injured in a clash between two rival groups over land dispute at Gopal Nagar village in Sadar upazila on Friday.

Police said there was a long standing dispute between Nasir Uddin and Sabur Uddin of the village over a piece of land.

Local people arranged arbitration to settle the matter Friday afternoon.

At one stage, supporters of both Nasir and Sabur locked in a clash during the arbitration and vandalised Sabur's house, leaving six people from both sides injured.

BDR MUTINY TRIAL IN C'NAWABGANJ

Charges against 21 read out at special court

Trial proceedings against 21 mutineers of 39 Rifles Battalion began at special court-12, set up at the battalion headquarters in Chapainawabagnj, yesterday.

On the first day, Deputy Assistant Director (DAD) of the battalion Md Kamal Mia read out the allegations brought against the BDR rebels in the court headed by Rajshahi Sector Commander Col Ehia Azam Khan. Two other members are Lt Col Gazi Mohammad Khalid Hossain and Lt Commander Muhammad Touhidul Islam. Lt Col Zayed Hossain is the

prosecutor.

that 21 BDR men of the battalion revolted against their officers on February 25--26 last year, looted arms and ammunition from battalion armoury and fired blank shots.

The court took the allegations against the 21 BDR men into its cogninance and asked the prosecutor to produce all the accused in the court today.

The court also issued an arrest warrant against four BDR jawans for their involvement in the mutiny. They are nayek subedar Jamal Mia, havilder Panchanon Das, sepoy Moshfequr Rahman and sepoy Muhammad Ruhul Amin Shikdar.
