Rahimafrooz Renewable Energy (RRE) has signed a memorandum of understanding with TATA BP Solar to set up a solar power plant in Bangladesh.

Rahimafrooz will install the five-megawatt plant on 20 acres at a cost of \$25 million.

RRE Managing Director Munawar Misbah Moin and TATA BP Solar Managing Director K Subramania signed the deal on the sidelines of the Delhi International Renewable Energy Conference (DIREC) that continued from Wednesday to Friday in New Delhi.

TATA BP Solar, established in 1989, is a joint venture between Tata Power Company of India and BP Solar.

DIREC 2010 is the fourth in the series of the international renewable energy conferences, which was followed from the initiative taken at the 2002 World Summit on sustainable development in Johannesburg.

Previous three events were held in Washington in 2008, Beijing in 2005 and Bonn in 2004.

Calls for exchange rules upgrade

The Bangladesh Bank should rationalise the age-old foreign exchange rules and regulations to make the regime updated and cohesive, said former governor of Bangladesh Bank (BB) Dr Salehuddin Ahmed yesterday.

Ahmed said this while speaking at a seminar on foreign exchange and rates risk management organised by Citi Bangladesh at Spectra Convention Centre in Gulshan.

"I forwarded a draft to this effect to the government to rationalise the Act during my tenure, but nothing has happened yet," he said.

The Foreign Exchange Regulation Act, 1947 currently regulates payments and dealings in foreign exchanges and securities and the import and export of

The former governor said the Act should be modified immediately to make it more supportive in line with the global norms and regulations. Otherwise, it would be difficult for the banks to manage their foreign exchange risks appropriately, he added.

"Rationalising foreign exchange laws is a fundamental work and the BB should concentrate more in this area than attending seminars," Ahmed remarked.

Dr Salehuddin Ahmed served Bangladesh's central bank as governor on a four-year stint till May 2009.

The former governor also advocated for an increase in the foreign exchange net open position (NOP) by the commercial banks. The present NOP limit is 12.5 percent of a bank's total capital.



Samsung to sell tablet PC in India

Samsung Electronics will start selling its Galaxy Tab tablet computer in India from Nov. 10 and expects to capture about half of the market which it sees at up to 1 million units in the next 12 months, a company official said on Friday.

First Baghdad flight for European airline

An Airbus operated by France's Aigle Azur is on Saturday to make the first scheduled flight by a European airline to Baghdad in 20 years amid hopes of boosting historically close Franco-Iraqi business links.

The Airbus A319 is to take off from Paris-Charles de Gaulle at 11:30 pm (2130 GMT) with foreign trade minister Anne-Marie Idrac and 40 French businessmen aboard, landing at Baghdad International five hours later.

Commercial flights between the two

capitals, previously operated by national carrier Air France, were suspended after the Iraqi invasion of Kuwait in August 1990.

"This is an historic event because this is the first scheduled direct service by a European airline between a Western capital and Baghdad for 20 years," said France's ambassador to Iraq, Boris Boillon.

Aigle Azur, owned by the Franco-Algerian Idjerouidene family, will from early 2011 offer two flights a week from Charles de Gaulle, Europe's second busiest air hub after London Heathrow.

Toyota secretly bought back faulty vehicles

Japan's top world automaker Toyota secretly bought back some of the faulty vehicles it sold on the market in a bid to hide their defects from the public, the lawyers of clients suing the automaker said Friday.

One complaint filed in California and obtained by AFP said that, contrary to the company's statements, Toyota technicians have replicated the sudden unintended acceleration (SUA) problem that led to the recall of millions of its vehicles months ago.

"Upon the technicians replicating a SUA event, Toyota decided it was in the customer's 'interest' for Toyota to buy back the vehicle, meaning in reality that Toyota decided to remove this vehicle from the market since it was experiencing SUA incidents that could not be blamed on the driver," said the complaint.

"And, to further conceal the defect, Toyota required as a condition of the vehicle repurchase that the owner sign a confidentiality agreement and agree not to sue," it added.

The complaint said Toyota deliberately withheld the information from the National Highway Traffic Safety Administration (NHTSA) and from its testimony at congressional hearings.
