Rallies, processions, human chains continue in districts

Wave of protest against the killings of college teacher Mizanur Rashid and housewife Chanpa Rani Bhowmik continues in different districts across the country.

The protesters are venting their anger on the stalkers by holding rallies, processions and human chain programmes and demanding exemplary punishment to the

Rashid by ramming him with a motorbike as he had protested stalking of his female students in Bagatipara upazila of Natore district while Chanpa Rani in Modhukhali upazila of Faridpur district met the same fate as she had complained to local authorities against a stalker of her daughters.

In Natore, Bangladesh Samajtantrik Mohila forum yesterday held a press conference at local press club and formed a human in front of the club demanding exemplary punishment to the killers of Mizanur and Chanpa Rani, reports our correspondent.

At the press conference, leaders of the forum announced that they would bring out a procession in the capital tomorrow demanding punishment to the killers.

They urged the government to take immediate actions against the killers of Mizanur and Chanpa Rani and also stressed the need for creating social awareness against the menace of stalk-

After the conference, the forum arranged a human chain programme in front of Natore Press Club for an hour from 11:00am and then submitted a memorandum to the deputy commissioner of stalking. The rally was

demanding exemplary punishment to the killers of Mizanur.

In Barisal, teachers, students, guardians, political and cultural activists and representatives from different professional bodies yesterday Parishad Tahmina Molla. joined human chain programmes on the campuses in Gaibandha town yesterday. of 38 educational institution in the city and on the outskirts demanding immediate steps to stop eve-teasing and punishment to the killers of Stalkers killed Mizanur Mizanur and Chanpa Rani, according to a correspondent.

Organised by the Committee for Prevention of eve teasing, the programme was observed simultaneously at all the 38 institutions in the morning. Addressing the rallies on the campuses of the educational institutions, speakers demanded enactment of a law against stalking.

They also demanded immediate measures to stop eve teasing and stressed on vigorous campaign against the menace of stalking.

Our Thakurgaon correspondent reported that Thakurgaon NGO Cell, an organisation of local nongovernmental bodies, district unit of Sammilita Sangskritik Jote and district unit of Bangladesh Teachers' Association jointly organised a human chain programme in the town yesterday to press their demand for punishment to the killers of Mizanur and Chanpa Rani Bhowmik.

Addressing a rally at the venue at Thakurgaon intersection, the speakers urged the government to try the killers of Mizanur and Chanpa Rani an hour from 10:00am. under the Speedy Trail Act.

They urged all to resist the stalkers and build social awareness against the menace

addressed, among others, by Sammilita Sangskritik Jote district unit General Secretary Masud Ahamed, Dirrector of CDS, a local NGO, Nurul Islam and Vice-Chairman of Thakurgaon Sadar Upazila

Similar programme was held Thousands of school and college students took part in a human chain programme at DB Road at noon demanding capital punishment to the killers of Mizanur and Chanpa Rani.

They also vowed to build resistance to the stalkers and urged the government to take necessary steps to stop eve teasing and enact a stringent law to punish the delinquents, says our correspondent Students of Ahmeduddin

A college girl was physically assaulted by a stalker in Thakurgaon Sadar upazila on Saturday while three youths were yesterday arrested on charge of teasing a schoolgirl in Kachua upazila of Chandpur district.

In Thakurgaon, locals said Shohag, 22, son of Reazul Islam of Salonder village under the upazila, teased Khadiza Begum and her daughter Shima, a student of Salonder Degree College, while they were sitting on the college ground at around 2:30pm.

As Shima protested, Shohag physically assaulted her. Fellows took Shima to Thakurgaon Sadar Hospital Government Girls High connection with the case.

Admitting to the incident, acting principal of the college Ibrahim Ali said both sides negotiation.

Criminals killed a decorator in the district on Saturday while body of a grocer, kidnapped a few days ago, was found in Jessore yesterday.

Criminals on Saturday night hacked a decorator to death at Abaipur village under Shailkupa upazila of the dis-

The deceased was identified as Hashem Ali, 50, son of late Abdul Hakim Mia of Lakhandia village under the upazila.

Daughter of the victim, Razani Khatun, said, her father left for Sreepur bazaar in Magura district on Saturday for work there. The next morning Hashem's body was found lying behind the community clinic of Abaipur village in Shailkupa.

SI Ashraf Hossain of Shailkupa police station said, Hashem Ali worked at a decorator shop in Sreepur bazaar and stayed there. He might have been killed in family feud, he said.

Body of another middleaged man, kidnapped by criminals on October 7, was found in Jessore yesterday.

Nabin Mondol, 42, a grocer at Gazipur village in Harinakundu upazila, was abducted by criminals when he went to Jhenidah Sadar upazila on business pur-

Later, the abductors demanded Tk 3 lakh as ransom from his family.

Being informed, police arrested outlaw Anisur Rahman and his wife Nasrin from Harinakundu.

Following their confessional statement, police yesterday morning recovered the body of Nabin from the house of Puti Mollah at Shatiantala village of Jessore Sadar upazila.

Police arrested two others Rahed and Shahin from Jessore -- for their suspected involvement in the killing.

BDR MUTINY IN C'NAWABGANJ

Hearing on charge framing against 21 on Mar 15

The special court-12, set up at 39 Rifles Battalion Headquarters in Chapainawabagnj, yesterday fixed March 15 next for hearing on charge framing against 21 mutineers of the battalion.

Prosecutor Lt Col Zayed Hossain, commanding officer of the battalion, read out the allegations against the rebels. After hearing, the court headed by Rajshahi Sector Commander Col Ehia Azam Khan fixed the date for hearing on charge framing and sent the accused to

Lt Col Zayed told the court that the accused revolted against their officers, expressing solidarity with the mutineers of BDR headquarters at Pilkhana in the capital on February 26-27 last year. They looted arms from the battalion armoury and fired blank shots, he added.


The accused are Subedar Md Mostofa Mia, Havildar Benoar Rahman, Havilder Ruhul Amin, Nayek Eskendar Ali, Nayek Rohmat Ali, Lance Nayek Shafigur Rahman, Lance Nayek Mohammad Tous Mia, sepoys Mojibur Rahman, Jahangir Alam, Abdul Wazed Pramanik, Abdur Rahim, Monirul Islam, Abul Bashar, Roni Ahmed, Zahidul Islam, Nazrul Islam, driver Abdul Mannan, Nayek Subedar Jamal Mia, Havilder Panchanon Das, driver Moshfiqur Rahman and sepoy Mohammad Ruhul Amin Shikdar.

Two others members of the special court are Lt Col Gazi Mohammad Khalid Hossain and Lt Commander Muhammad Touhidul Islam. Assistant Attorney General Shasanko Shekhar Sarkar and advocates Manjur Alam and Rezaul Karim Reza were present during the trial.

Earlier, the same court issued arrest warrant against four BDR jawans for their involvement in the mutiny. Following court order, police arrested them from battalion headquarter on Saturday noon.

They are Nayeb Subedar Jamal Mia, Habildar Panchanon Das, driver Moshfequr Rahman and sepoy Muhammad Ruhul Amin Shikdar.

On May 18 last year, Ahsanul Haque, officer-in-charge(OC) of Sadar Police Station, filed a sedition case against 30 mutineers of 39 Rifles Battalion with Chief Judicial Magistrate's Court. They were produced in the court that sent them to jail. Of the 30 accused, 21 were later sued on mutiny charge.
