Bangladesh Bank has been implementing the Central Bank Strengthening Project funded by the International Development Association (IDA) for its overall automation and capacity building, and it intends to apply part of the proceeds of this fund to payments under the contract for the consulting services of a Bank Supervision Expert.

The primary objective of the assignment is to provide guidance and support in implementing a new set of prudential regulations and recommendations with respect to improved off-site reporting and analysis. In this regard, the services of the consultant may include, but not restricted to, the following tasks:

- ?? Review the existing regulations of Bangladesh Bank which were formulated in accordance with the Basel Committee Guideline, assess the need and help to revise or draft new regulations if necessary;
- ?? Analyze the current functions of Department of Off-site Supervision, Bangladesh Bank with a focus on coordination with other supervisory departments;
- ?? Review existing system of on-site supervision and develop, in alia, methodologies for risk-based supervision;
- ?? Review and assess the bank resolution process currently in effect in Bangladesh and advise pragmatic changes in areas required for improvement;
- ?? Assess and provide support to BB's effort to internally develop and deliver career development training for bank supervisors.

**Required skills and Experience:**  
The incumbent should have at least 8-10 years of international experience in related field.
