Abductors kill 4-year-old boy for Tk 5 lakh ransom

Body of a 4-year-old boy, abducted by criminals three days ago, was recovered from under a bridge at Syamgati village in Belkuchi upazila yesterday.

Victim Nahid was son of Harunur Rashid, a grocer of the village.

Police said criminals abducted Nahid from his residence on October 31 and later demanded Tk five lakh as ransom.

The abductors strangled Nahid as his parents did not comply with their demand, said OC of Belkuchi PS Mostafizur Rahman. On Tuesday night, police

arrested Sumon, 24, of Chandangati village in connection with the abduction. Following his confessional

A local trader was stabbed to death by muggers at Chatgaon under Keraniganj model police station early yesterday.

The deceased was identified as Shah Jamal, 55, a trader of garment accessories and son of Israfil of the area.

Police said Shah Jamal while returning home from his workplace at about 1am, a gang of muggers intercepted him in the area and tried to snatch his money and mobile phone set.

As he tried to resist the muggers they stabbed him indiscriminately leaving him critically injured. Hearing his cry for help

took him to Mitford Hospital at about 2am where the attending doctor declared him dead. In South Keraniganj, slaughtered body a young

About 1,000 people yesterday put the office of the assistant director of Bangladesh Road Transport Authority (BRTA) in Habiganj town under lock and key protesting delay in issuing licences and route permits from the office.

Bus, truck, auto-rickshaw and private car owners and transport leaders and workers reached the BRTA office in the afternoon to receive their licences, route permits and other papers. Finding Assistant Director Habibur Rahman, office assistants Abdul Wadud and Subhash Roy not available in the office, they became agitated and locked the office.


Addressing a rally on the office premises, the agitators alleged the local BRTA office staff have been involved in corruption for long. The BRTA men unnecessarily harass people and issue fake licence and route permit in exchange for money, they said.

The agitators demanded delivery of licenses and other documents by Wednesday next. Otherwise, they threatened to launch a greater agita-

tion programme. Later, they met the deputy commissioner (DC) and submitted a memorandum to him demanding punishment to the corrupt BRTA staff. The DC assured the agitating people of probing into the allegations against the BRTA men. If anybody found involved in corruption, he would be punished, the DC

added. Habiganj Sarak Paribahan Sramik Union General Secretary Sajib Ali, advocate Farid Uddin, Ashutosh Adhikary Sanker and others addressed the rally.
