## Serbian president apologizes for wartime massacre

AP, Vukovar

Serbian President Boris Tadic has apologized for Serb wartime atrocities at the site where more than 200 Croats were slain by Serb rebels during the 1991 war.

Tadic is the first Serbian leader to visit Ovcara, the site of a mass grave near the town of Vukovar. He said Thursday he came to "bow down before the victims" and "once again offer words of apology and express regret."

The massacre at Ovcara remains a painful symbol for Croats of Serb wartime brutality. Tadic and his Croatian counterpart, Ivo

Josipovic, will later lay wreaths in the nearby village of Paulin Dvor, where 18 Serbs were killed by Croats in 1991.

It is the strongest condemnation yet of wartime crimes and a symbolic step of reconciliation between the two nations.

Boris Tadic is also expected to lay a wreath at a mass grave at Ovcara, a pig farm where the bodies of more than 200 Croats were dumped after Serb soldiers dragged them out of a local hospital and executed them a massacre that remains a painful symbol for Croats of Serb wartime brutality.

Tadic and his Croatian counterpart, Ivo Josipovic, will also lay wreaths for 18 Serbs killed by Croats in a nearby village.

The visits are the strongest condemnation yet of wartime crimes, offering a symbolic step of reconciliation between the two nations after years of mutual accusations over atrocities.

Serbia backed Croatian Serbs when they rebelled against the country's independence from Yugoslavia, which triggered the war. The rebels seized a third of the country. More than 10,000 people were killed and entire communities expelled.

Four years later, Zagreb took back the territory in a blitz offensive, followed by a period of killings and purges of Serbs by Croatians.

The two Balkan neighbours have since largely patched up relations, but tensions persist and each nation still sees itself as the chief victim of the war. They have sued each other for genocide before The Hague-based World Court and nearly 2,400 people remain missing.

Josipovic and Tadic, who belong to a younger generation of politicians not involved in the war, have each made steps to reconciliation.

#### Iranians mark anniversary of **US** embassy takeover

AFP, Tehran

Thousands of Iranians chanted "Death to America" as they staged yesterday a mass protest against the "Great Satan" to mark the 31st anniversary of the capture of the American embassy by Islamist students.

Tehran, meanwhile, welcomed Washington's decision to list shadowy rebel group Jundallah as a foreign terrorist organisation, saying it was the "right" move, but reiterated its allegation that the US supports the Sunni network.

Iran annually on November 4 marks the anniversary of the capture of the US embassy by Islamist students in Tehran in 1979, months after the Islamic revolution, which toppled the US-backed shah.

On Thursday, waving Iranian flags and carrying anti-US banners alongside posters of Iran's supreme leader Ayatollah Ali Khamenei, the largely young crowd also shouted anti-Israel slogans outside the now closed US embassy.

Banners saying "I will give my life for the leader (Khamenei)" and another quoting Iran's revolutionary leader Ayatollah Ruhollah Khomeini as saying, "If you want to shout, shout at the US", were displayed at the embassy compound, an AFP correspondent reported.

## A two-person, two-party town

person, two-

party town now. And President Barack Obama, a Democrat and incoming House Speaker John Boehner, a Republican, need each other as both partners and foils while they push their own legislative agendas and lay the groundwork for the 2012 elections.

The unlikely duo must find areas of compromise to get something anything, really done to appease an unhappy electorate demanding economic stability from a government voters don't think works. At the same time, each leader must figure out how to use the other to draw partisan contrasts that will fire up their respective political bases.

Both risk the wrath of voters in two years if they fail on either task; nothing short of Obama's re-election, the Republicans' newfound grip on power and the country's economic well-being is at stake.

For now, Obama is the one on the defensive and it showed in the hours after the election, with Democrats uniformly calling for common ground while the GOP put conditions on its willingness to meet halfway. Come January if not sooner, Boehner will command greater capital in Washington and sway over the domestic agenda. But Obama must find a way to reboot his presidency by altering his goals, communicating them better or both.

The first glimpses of how both men position themselves came Wednesday, with each leader addressing the public in the wake of Republicans winning control of the House and cutting deeply into Democrats' Senate majority.

"No one party will be able to dictate where we go from here," a weakened president said from the White House. "We must find common ground in order to make progress."

"I'm not suggesting this will be easy," Obama added.

Boehner signalled as much earlier in the day by claiming Obama's health care overhaul was a "monstrosity" and needed to be repealed. He also suggested that the GOP's cooperation was conditional, saying: "We hope President Obama will now respect the will of the people, change course and commit to making the changes they are demanding. To the extent he is willing to do this, we are ready to work with

One by one, Democrats their ranks diminished weighed in and called for a new approach to working together.

Fresh off his own re-election victory, Senate Democratic Leader Harry Reid said he was planning to speak with his GOP counterpart, Mitch McConnell, about ways to "build a consensus and move this country along." The Democrat said the GOP must be more open to compromise, adding that "the time for politics is now over" and Republicans must do more than "simply saying 'no.'"

Still, in a sign of fights ahead, Reid said the health care measure was "ready for some tweaking" but that he won't support any move to repeal it.

There was talk of forthcoming high profile

gathering with Obama and new Republican leadership. But the day-after rhetoric was typical for the aftermath of a wave election and it was likely to

disappear as the hard reality takes shape of two parties with opposing viewpoints trying to govern a country in crisis.

In the long-term, the onus is on Republicans and Democrats alike to prove to Americans who are sour on both political parties that Washington isn't broken. Both Obama and Boehner need to show results to keep their jobs in 2012 and, in a split government, the only way to get results is to compromise.

#### 18 dead found in Mexico mass grave

In another grisly turn in Mexico's drug war, police have recovered 18 bodies from a mass grave announced in a YouTube posting a video saying the victims were from a tourist group kidnapped in Acapulco a month ago.

Authorities said they would resume their search Thursday for more remains at the burial site in Tres Palos, a town just south of the Pacific resort city.

Police did not yet know if the bodies found were from the 20 men abducted at gunpoint Sept. 30 while visiting Acapulco from neighbouring Michoacan state, Fernando Monreal, investigative police chief for Guerrero state, said Wednesday night.

Officers began digging at the site early Wednesday after receiving an anonymous phone call alerting them to two bodies dumped on an emptylot.

Hours earlier, a video appeared on Youtube in which two men their hands apparently tied behind their backs and answering questions from an unseen interrogator say they killed "the Michoacanos" and buried them in the area.

The two bodies reported in the tip were found wearing the same clothes as the pair seen in the video and were lying on top of the mass the grave.


