### CIP status for 10 top taxpayers

The government has decided to reward 10 top taxpayers with the status of Commercially Important Person every year to encourage people to pay direct tax.

The decision came at a weekly cabinet meeting at Bangladesh Secretariat with Prime Minister Sheikh Hasina in the chair. The cabinet also approved a policy subject to amendments.

Commercially Important Persons would be entitled to a host of facilities including access to VIP lounge at airports, ticket quota in Biman, railways and water transport, and entry pass to the Secretariat.

Ten people with highest tax returns for five consecutive years would be given special cards to enjoy some government facilities subject to conditions, Prime Minister's Press Secretary Abul Kalam SEE PAGE 15 COL 6

### 4 BCL men expelled from DU



Dhaka University yesterday expelled four students, all members of Bangladesh Chhatra League, for a year for harassing a female student on the campus and assaulting six other students who had protested the stalking on Sunday evening.

DU authorities also issued them a show-cause notice asking them to respond by November 24 why they would not be permanently expelled from the institution.

# Developer warned about a year back

Tilted high-rise built without proper piling work; Rajuk blames staff shortage for not following up on its notice

Rajdhani Unnayan Kartripakkha had served a deviation notice about a year ago to the developer of the seven-storey Asia Haider Tower in Kathalbagan of the capital that tilted and sank into the ground on Sunday night, but the developer had not responded to the notice.

The tower tilted onto a 17-storey building next to it before sinking into the ground by about 10 feet.

Despite receiving the Rajuk notice, the developer Asia Comtech Bangladesh constructed the faulty tower only 17 feet away from the next building. But according to the approved

design, the building was supposed to be constructed 25 feet away form the next one, said Aminur Rahman, authorised officer 1 of Rajuk. The tilted building is among 5,000

such structures in the capital, identified by Rajuk as buildings in violation of rules, and risking the neighbourhoods.

Rajuk did not follow up with Asia Comtech after serving the notice, neither did it demolish the illegally con- ble. structed parts of the building. Rajuk Chairman Nurul Huda said with a limited manpower the agency could not possibly demolish illegal portions of all 5,000 errant buildings that had been served such notices.

The agency however did demolish illegal portions of 200 such buildings after the notices had been served since last year. Rajuk will gradually demolish all illegal portions of those 5,000 buildings, if the owners do not correct the faults by the time the demolisher get there, the agency chairman added.

It will start demolishing the errant Kathalbagan building as soon as possi-

"We have issued a letter to the Buet authorities, requesting them to form a team to help us with the demolition, through supervision" said Nurul Huda.

# Obama: US won't impose solution

US President Barack Obama has ruled out any possibility of his country imposing a solution on India and Pakistan for the longstanding dispute over Kashmir and said it is for the two countries to resolve the issue.

"Kashmir is a long-standing dispute. The US cannot impose a solution to this problem but we will be happy to play a role the two parties consider appropriate," said the US president yesterday at a joint press conference at the palatial Hyderabad House in New Delhi at the end of his three-day India tour.

The US and India agreed that all countries in South Asia must work together and ensure that there "are no safe havens for terrorists," he said.

Indian Prime Minister Manmohan Singh said India is committed to engaging Pakistan to resolve all outstanding issues, including Kashmir, but talks cannot go on "while terror machines are active."

Obama said dialogue between India and Pakistan "may not begin on the flash point of Kashmir" and the two countries have to take confidence-building measures before turning to such

He said it was for India and Pakistan to resolve tension in their own interests.

"A strong and peaceful Pakistan is in the interest of India and I believe both India and Pakistan.

# No free transit

## Muhith tells media after meeting with Indian HC

There will be no free transit, insists Finance Minister AMA Muhith.

Bangladesh will definitely charge fees for allowing Indian vehicles to use its territory, he told reporters yesterday after a meeting with Rajeet Mitter, Indian high commissioner in Dhaka. "We'll charge fees for capacity maintenance, as our infrastructure will be used by their cargoes," Muhith noted.

The government is working to frame new rules and fix the amount of fees to operationalise road and rail transit, he added. "It will take two to three months to finalise the rules."

Replying to a query, the minister said the main opposition's anti-transit stance is "political".

Earlier on Sunday, BNP Chairperson Khaleda Zia warned the government against giving transit to India. Addressing a rally in the capital, she also said no foreign vehicles would be allowed to use Bangladesh territory. Muhith said Bangladesh has already been offering India

limited transit through waterways as per the Protocol Agreement of 1972, and it receives around Tk 4.5 crore in fees annually for maintenance of the routes.

Besides, it charges conservancy and pilotage fees, which take the total earnings from water transit to around Tk 20 crore a year. SEE PAGE 15 COL 6
