Hanif dies, will others see justice at all?

Family members and colleagues of deceased postmaster Hanif observed hunger strike in front of Patuakhali Press Club yesterday demanding remedy to the injustice done to him and several other

Hanif, who went to file a writ petition with the High Court (HC) for job regularisation as per an earlier order of the HC, died of a cardiac arrest in Dhaka on Friday.

Informed, Deputy sources said. Postmaster General Shahidul Islam, district postmaster

Shahkhawat Hossain and Organising secretary of district unit of Awami League Kazi Alamgir Hossain rushed to the spot.

Assuring that all dues of Hanif will be paid and job of 18 postmen will be regularised, they persuaded the protesters to break the hunger strike.

Md Hanif of Amkhola village under Galachipa upazila in the district was serving as postman in Dashmina upazila post office since 2004.

Patuakhali district post At the hunger strike that office authority appointed six postmen including Hanif in 2004 but as their job was not regularised after two years, they have remained deprived of salaries for four years,

JSC Kids Under Barisal Board

HC on July 21 this year issued an order to regularise their job and pay all their dues. But the HC order was not carried out.

Hanif and others on November 4 went to the HC to file additional petition in this regard but Hanif had a heart attack there. He died at Dhaka Medical College hospital the following day.

When contacted, Deputy Postmaster General Shahidul Islam said, "I ordered the district postmaster on October 26 to pay all dues to all 6 postmen as per directives issued by the HC."

But Postmaster Shakhawat Hossain said, "I could not pay their dues as Postmaster General Syed Ahmed during his recent visit in Patuakhali on October 26 orally directed me not to pay their dues."

Trial of 24 alleged mutineers of Lalmonirhat 31 Rifles Battalion was held at special court-13 at the battalion headquarters for the third consecutive day yesterday. The court started at 9:00 am and ended at 6:30 pm.

All the 24 mutineers were produced before the court amid tight security yesterday morning.

Of the 24 accused, 16 confessed to their involvement in the mutiny on the first day of the special court on Sunday and one more confessed on Monday while seven others still claimed innocence, BDR sources said.

Of the total 23 prosecution witnesses, the court recorded statements of 19 PWs on Sunday and Monday. The rest four PWs gave their statement yesterday, the sources added.

The four-member Special Court-13, was presided over by Dinajpur Sector Commander Col Muhammad Saleh Ahmad. Three others members-- attorney general's representative Deputy Attorney General Bishwajit Roy and two BDR officials Lt Col Mahfuz Alam and Major Didar Al-Latif were present.

Advocates Rezaul Karim and Rafiqul Islam Mithu were present as special public prosecutors while Commanding Officer (CO) of Lalmonirhat 31 Rifles Battalion Lt Col Aslam Hossain was the prosecutor.

A staggering 5,625 students, who comprise 8% of the examinees, were absent on the first and second days of the Junior School Certificate (JSC) examinations under Barisal education board.

A total of 75,551 students registered for the JSC examinations under Barisal board while 69,926 examinees attended it on the starting day November 4 in six districts of Barisal division.

Of the absentees, 1677 examinees are from Barisal district, 1101 from Bhola, 882 from Patuakhali, 842 from Pirojpur, 558 from Barguna and 565 from Jhalakathi district, board sources said.

"About 150 of the 1265 schools under Barisal education board have been identified as 'sick' schools. In the last SSC examinations, less than

five students passed from each of 41 schools while less than 10 students passed from each of 99 schools," Barisal board Chairman Bimal Krisna Majumder said.

"Many of these sick schools have done false registrations for this year's JSC examinations under Barisal board Fifty-nine registrations have already been identified as false. These false candidates were absent in the examination," he added.

As per rule, every school of rural areas must send minimum 30 students for Junior School Certificate examinations and the number is 50 for urban areas, the board chairman said, adding that 50% of the public examination candidates must be successful or else government benefits of

the school will be held off.

"Facing the terms and conditions, authorities of sick schools often do fake registration. We are considering steps to check the malpractice for the next term," he said.

Abdul Latif, headmaster of BM School, said, "The absentees from the public examinations are mostly irregular girl students of rural areas. They appear at the school annual examinations in conformity with the local social culture. The number of absentees can be checked if school authorities arrange registration of regular students for the examination."

Barisal board sources said none was expelled so far as the examination is continuing peacefully.
