Zaman's resignation deepens crisis in Sylhet city BNP

A frontline leader of the newly formed Sylhet city BNP has resigned on 'personal grounds' further escalating the party's on-going crisis. Shamsuzzaman Zaman,

who was made Joint secretary of the new committee, resigned Monday after the news of his alleged 'expulsion for misbehaviour with a senior leader' became widely known. He is one of the closest aide

of the district BNP chief and former lawmaker M Ilyas Ali. "More people may quit the

committee and about 50 leaders of the faction, led by Dr Shahriar met the party senior secretary general in the capital on Monday to raise their grievances", Nasim Hossain, former city BNP secretary and senior vice-president of the new committee told this correspondent yesterday.

days ago. The leaders and activists of Sylhet city BNP loyal to Saifur, rejected the new committee at a press conference on 6 November. They demanded scrapping of the committee in 7 days and threatened with agitation if their demands were not met within the deadline.

Central committee member Dr. Shahriar Hossain Chowdhury read out the written statement before the journalists.

The central committee on June 9 this year formed a 13man convening committee with Dr Shahriar Hossain Chowdhury as convenor and asked them to form the full committee. Although they sat united at first but differences arose later. Two factions of the party submitted two different committee suggestions on

Robbers loot houses in guise of policemen

Gunfight, house owners beaten up by gangs in five districts

Robbers looted two houses in guise of policemen in Manikganj yesterday while police arrested two bulletinjured robbers after gunfight in Narsingdi the day before.

Besides, robberies were committed also in Narayanganj, Comilla and Keraniganj early Wednesday.

In Manikganj, robbers looted cash, gold and silver ornaments, mobile sets worth about Tk5 lakh from two houses at Kanda Bashail village under Shivalaya upazila in the guise of policemen early yesterday, reports our correspondent.

The gang went to the house of Monoj Kumer Sarker at around 2:30 am. They tied up the house owner's hands, legs and mouth introducing themselves as policemen.

The gang forced the owner to give almirah's key, took away 8 tolas of gold ornaments, 5 tolas of silver ornaments, two mobile sets and cash Tk15, 000 from the almirah.

The robbers then went to the house of Jahangir Alam at around 3:00 am. They entered the house by breaking open door. They took away 8 tolas of silver ornaments, the house members said.

In Narsingdi, police arrested two bullet-injured robbers after a gunfight with them on the Dhaka-Sylhet highway at Doghoria Wednesday night.

The arrestees were identified as Mahbub Alam Shipu, 20, and Yesmin, 22, reports our

correspondent.

Nazrul Islam, officer-incharge of Narsingdi sadar model police station, said police challenged a stationary microbus carrying a gang near Mystic Pharmaceuticals at about 9:00pm.

Sensing danger, the robbers started the microbus forcing the law enforcers to open fire. The gang retaliated triggering a gunfight.

Police later stopped the microbus at Sonatola point and arrested two robbers who were hit by bullets during the gun battle.

They also recovered four bullets and three machetes from their possession.

In another incident in Narayanganj, robbers looted cash and valuables worth Tk 5 lakh from a house injuring house owner and his neighbour critically at Khirdasadi village in Araihazar upazila early Wednesday, reports

House owner Zahirul Islam said a gang of armed robbers wearing masks entered his house by breaking the door open and took the family members hostage at gunpoint at about 4:30am.

Later, they looted Tk 2.5 lakh in cash and valuables including seven tolas of gold ornaments and two mobile

Another agency report from Comilla adds: A gang of robbers stormed into the house of Zafar Ahmed at

Dishaband village in Monoharganj upazila and looted valuables worth Tk 2.50 lakhWednesday night injuring six house members.

Locals said the gang numbering 10/15 entered the house by breaking the door open and made the family members hostage at gunpoint at dead of night.

The robbers at one stage beat and stabbed Momena Khatun, 60, Meer Hossain, 40, Mamtaz Uddin, 35, Ferdous Akter, 30, Zannatul Ferdous Panna, 30, and Taslima Begum, 35, of the family leaving them seriously injured.

In yet another incident, robbers looted cash and valuables worth Tk 8.50 lakh from the house of a businessman at Darigaon village in Keraniganj earlyWednesday.

Police and locals said a gang of robbers numbering 15/16 entered the house of Yunus Miah breaking the collapsible gate at about 3:00am.

Later, they took the house members hostage at gunpoint and looted Tk1.60 lakh in cash, 35 tolas of gold, 2 colour TV, 6 mobile phone sets and other valuables.

Hearing the cry of the victims, locals after a hot chase caught two of the robbers and beat them mercilessly. Later, they were handed over to police who admitted them to Dhaka Medical College and Hospital.

Mutiny trial adjourned

The BDR court here yesterday adjourned the trial of 73 alleged mutineers under Mirpur sector in Kushtia till December 20. The Special Court-17 headed by Commander of Kushtia BDR sector Lt Col Nazrul Islam started the trial proceedings at about 9:30am and continued it for three hours. Prosecutor Lt Col Khandaker Ainul Jamal read out charges against the accused during the hearing. The Kushtia sector has two battalions -- 32 in Kushtia and 35 in Chuadanga. Out of 73 alleged mutineers, 61 belonged to 32 Rifles Battalion and 12 from 35 Rifles Battalion. During the first day's hearing, prosecutor Lt Col Khandaker Ainul Jamal read out the charges against 40 accused of the 32 Rifles Battalion. All the accused took part in the mutiny on February 26, 2009. They were arrested after a case was filed against them, the sources added.

Girl killed after rape

A 6-year-old girl was killed after rape at around 2pm on Wednesday at Amdanga village under Abhoynagar upazila in Jessore district. Victim Rushni Akhter was a student of class one at Amdanga Govt Primary School and only daughter of day labourer Harun Molla of the same village. According to police, Zakir Molla, 19, a spoiled son of Hannan Molla of the same Amdanga village took her to a nearby bush while she was returning home from her school. The teenage boy strangled the girl after committing rape, said OC Ahsan Habib of Abhoynagar police station. Doctors declared her dead when she was admitted to upazila health complex at 3pm, the OC further said. Police arrested Zakir at 9:30pm on the same day from Dhopadi village under the same upazila of Jessore district.

Transport strike called off

Khulna District Transport Owners and Workers Union has called off their indefinite strike that started on Wednesday on 18 inter-district routes to press for withdrawal of illegal human haulers like Nasimon and Karimon from streets. The decision to call off the strike was taken at a tripartite meeting held at 7:30pm on Wednesday in the office of the Khulna Police Super Tanvir Haider Chowdhury. Leaders of Bus-Mini Bus Owners' Association, Transport Workers' Union and officials of Khulna civil and police administration were present. "We have called off the strike as the administration assured us of banning human haulers like Nasimon and Karimon on 18 inter-district routes of south-western region," said Zakir Hossain Biplob, general secretary of Khulna Transport Workers' Union.
