Verdict in Lalmonirhat mutiny case today

Trial, charge framing against 44 to start in Sylhet

The special court-13 will deliver judgment in the mutiny case against 24 jawans of 31 Lalmonirhat Rifles Battalion under Rangpur sector today while the special court-14, set up at Sylhet sector headquarters, will resume trial and frame charges against 44 rebels of 21 Rifles Battalion.

According to our 31 Rifles Battalion. Lalmonirhat correspondent, the BDR court headed by Dinajpur Sector Commander Col Muhammad Saleh Ahmad will pronounce the judgment in the mutiny case at noon. Two other members are Lt Col Mahfuz Alam and Major Didar Al Latif.

Ali, Sirajul Haque, Toslur Rahman, Asaduzzaman, Motiur Rahman, Nazmul Sahadat, Habibur Rahman, Joynal Abedin, Ashraful Huda, Rokon, Dulal Hossain, Abu Bakkar, Shahadat Hossain, Amir Hossain and Abdur Rahman confessed to their

involvement in the mutiny while the rest seven, Parvez Hasan, Kamor Uddin, Abu Siddique, Nazrul Islam, Pronayan Chakma, Mohabbat Ali and Tariqul Islam, claimed innocence, a BDR official said.

The mutineers were later arrested and produced before the court that sent them to jail hajat, the official added.

prosecutor Lt Col Khairul Quadir, also the commanding officer of the battalion, read out the allegations against the accused in the court headed by Comilla Sector Commander Col SM Farhad.

The then officer-in-charge of Sylhet Kotwali Police Station Syeduzzaman filed three separate cases with the Chief Judicial Magistrate's Court against 24 mutineers of Court, Sylhet, on May 17 last year against the BDR men of Sylhet sector and two battalions under the sector as they took part in mutiny on February 26 last year, expressing solidarity with the mutineers of BDR headquarters at Pilkhana in the capital.

The complainant alleged that the jawans took control of Sylhet sector headquarters and two battalion headquarters on February 26.

They set fire to three priaccused of 21 Rifles Battalion vate vehicles of BDR officials, put up barricades on the main Earlier on October 20, road in front of the 21

Battalion headquarters and fired at least 200 blank shots.

Our Kurigram correspondent adds: Trial proceedings against 50 mutineers of 27 Rifles Battalion at Kurigram under Rangpur sector began yesterday.

Headed by Dinajpur Sector Commander Col Md Saleh Ahmad, the court started proceedings at around 11:25am and continued until 2:00pm. Two other members of the court are Lt Col Mahfuz Alam and Major Didar Al Latif.

Nayeb Subedar Munshi Manwar Hossain of the battalion brought allegations against 50 BDR rebels. Commanding Officer of the battalion Lt Col Abdur Razzak is the prosecutor.

The court asked the authorities concerned to arrest 16 of the accused, who were in service till yesterday, and produce all the 50 accused before the court at 9:00am today.

As per court order, the authorities concerned arrested the 16 accused and sent them to Kurigram district

One killed, 80 injured as Habiganj villagers clash

A man was killed and 80 others were injured in a clash between rival groups of villagers in Ajmiriganj upazila of Habiganj district yesterday.

Police arrested Sher Ali, 60, and Rabi Hossain, 40 in connection with the killing of Lal Miah, 40.

Police and locals said, Kabir Miah of village Rahela while going to his cropfield with power tiller yesterday morning, one Porosh Ali and aides stood on his way as sequel to a previous incident.

After an exchange of heated words, they locked in a clash while over a hundred villagers joined them with lethal weapons.

Lal Miah succumbed to his injuries at the Ajmiriganj upazila health complex while seven others with serious wounds were sent to the Sylhet MAG Osmani Medical College Hospital. Thirtyeight including four women were also admitted to upazila health complex and the rest took first aid.

Locals said, the clash was a sequel to an incident that took place in the night following Eid-ul-Azha. Some villagers including Kabir Miah rebuked five young men as they took liquor and were seen walking naked on the village road at night. The unruly youths made yesterday's attack, they said.

Officer-in-charge of the Ajmiriganj PS Enamul Haque also said that yesterday's incident was a sequel to the Eid day's incident. "We have arrested two, more would be rounded up soon," he said.

Signature campaign for constitutional rights

Indigenous people in two northern districts yesterday formed human chains, held rallies and started signature campaign demanding their constitutional rights.

Indigenous people of Chapainawabganj staged their programmes in the town, reports our correspondent.

Jatiya Adibasi Parishad organised the programmes in front of local press club. Several hundred indigenous people of the district including women took part in the human chain

Speakers at the rally said that the indigenous communities belong to this soil like the other mainstream people. So, all the small communities of both hills and plain lands should be given due recognition.

The speakers underlined the need for a concerted efforts to bring the indigenous people to the mainstream of society for their substantial welfare and protection from repression.

They called upon the government to give constitutional recognition to them and ensure their rights to their mother tongue, culture and land.

Abdul Odud, lawmaker of Chapainawabganj Sadar constituency inaugurated the mass signature collection programme.

Indigenous leaders said they will organise a one-kilometer-long human chain in front of Jatiya Sangsad Bhaban on November 28 and submit a memorandum to the Prime Minister demanding their constitutional rights.

In Thakurgaon, a mass signature campaign was held at Thakurgaon Deputy Commissioner's Office premises demanding

constitutional rights of indigenous people. Jatiya Adivasi Parishad Thakurgaon unit organised the programme as part of monthlong-signature collection programme, reports our correspondent.

People from all walks of life and different professionals gave signatures expressing solidarity with the demand. Apart from the programme a discussion was

held at the same venue.

Demanding constitutional rights of indigenous people, the speakers said the communities are victims of discrimination in different fields as the government did not pay proper attention to their causes. They are always lagging behind as they are being

deprived of their rights in all sectors, they said.

The speakers also demanded immediate formation of a separate land commission to protect their rights on the plain lands. They also called to establish a separate ministry for indigenous people to deal with their problems.

The speakers also demanded mother tongue-based primary education for their children and the community's quota in higher education and government service.

Earlier, indigenous people brought out a procession that paraded different streets in the town.

KILLING OF TWO SCHOOLGIRLS

Acid thrower to die in C'nawabganj, two rapists get life in Chandpur

A young man was sentenced to death in Chapainawabganj for killing a girl by throwing acid while two youths got life in Chandpur for killing a girl after rape, vesterday.

Arup Kumar Goswami, Judge of the Women and Children Repression Prevention Tribunal-2, handed down the verdict in Chapainawabganj, reports our correspondent.

Convict Akhtarul Islam alias Tanu, 27, is son of Arshad Ali of Jalmachhmari village under Shibganj municipal area.

According to the prosecution, accused Tanu tried to woo his neighbour Tokiara Khatun, 20, daughter of late Zohiruddin of Jalmachhmari village, but she refused to accept his proposal.

An angry Tanu later entered her house at night and tried to violate her. Locals

rescued Tokiara which followed an arbitration where locals fined Tanu Tk 12,000. After seven months, Akhtarul threw

acid on Tokiara at around 7:00pm on February 16, 1998, when she came out of her house to respond to nature's call.

Locals rushed seriously injured Tokiara to Shibganj health complex and the doctors sent her to Chapainawabgani Adhunik Sadar Hospital. The same night the doctors of Adhunik

hospital sent her to Rajshahi Medical College Hospital, where she died on November 11, 1998. Tokiara's sister Sufiara Begum filed a

case accusing Tanu with Shibganj police station on February 17.
