At least 150 people were wounded by gunshots and spears in a fierce clash yesterday between the supporters of local leaders of ruling Awami League (AL) at remote Mirzar Char of Raipura upazila.

One killed, 80 injured in B'baria

Another killed in C'nawabganj clash

One person was killed and at least 80 others were injured in a oficrce clash over possession of a shop at Ananda Bazar in the town yesterday.

Two rival groups of Natai and Birashar villages under Brahmanbaria pourasaba also damaged 10 houses during the clash.

The dead was identified as Md. Joynal Mia, 32, son of Md Phal Mia of Natai village.

According to eyewitness, hospital and police sources, three was a long standing rivalry between Dulal Mia of Birashar village and Ibrahim Mia of Natai village over possession a shop at Ananda Bazar in the town.

Yesterday, Ibrahim group attacked and damaged a dryfish shop of Dulal Mia at the Bazar at around 6am.

Within minutes both the groups equipped with lethal weapons locked in a bloody clash at Natai-Birashar cropland.

The clash lasted till 2pm leaving Md. Joynal Mia, 32, son of Md Phul Mia of Natai village dead on the spot and at least 80 others injured.

Of the injured, Farook Mia, 19, Gazi Mia, 30, Chotto Mia, 20, Surab Mia, 35, Aminul, 20, Jasim, 18, Nurul Islam, 45, Niamul, 13, Rahman, 25, Jasim Mia, 20, Abul Hossain, 20, Yeasmin, 17, Shohrab Hossain, 35, Shah Alam, 28, Nahidul, 26, Lalchan, 31, Arafat, 10, and Abu Bakkar Mia, 35, were admitted to Brahmanbaria Sadar Hospital and 55 others given first aid at upazila. the same hospital while the

27 sued in Patuakhali on war crime charges

Twenty-seven people of Galachipa upazila in Patuakhali district have been sued on war crime charges.

Abdul Halim, a freedom fighter, filed the case with the Judicial Magistrate's Court on Thursday. Taking the case into cognisance, Judicial Magistrate Nuruzzaman asked the officer-in-charge (OC) of Galachipa Police Station to take necessary actions against the accused after proper investigation.

Now Recodex for phensidyl addicts Pouring in thru' border

Indian cough syrup Recodex, having properties similar to contraband phensidyl, are entering Chapainawabagnj through the border as the new drug has gained popularity among a section of drug addicts in short time.

Battalion arrested two drug peddlers and seized 16 bottles of Recodex from their possession at Boalia in Gomostapur upazila of Chapainawabagnj district at around 9:30pm on Friday when they were returning from India, said BDR officials. The arrestees are Abdul Hakim, 40, and

Mohammad Rubel, 35, hailing from Boro Bangeswarpur of Gopmostapur upazila, confessed that they continued smuggling the drug from India and selling it in the country during the last one month as addicts prefer it to phensidyl and other drugs, said BDR officials. Demand of Recodex is higher than that of

phensidyl among the drug addicts, as drug Codin is mixed with Recodex prepared by Indian pharmaceutical company Biogenetic (pvt) Limited, said Abu Bakar Abu, commanding officer of 39 Rifles Battalion.

Bottles of the drug are also similar to those of phensidyl, he said.
