15 injured as launch, ferry collide

At least 15 passengers were hurt in a collision between a launch and a ferry on the Mawa-Kawrakandi route on

Padma River Saturday night. The launch, named ML Jubilee, did not have any lighting facilities, which led to the collision, said its passen-

Five of the injured passengers were admitted to hospitals at Faridpur and other places. Others were given primary treatment at local health complexes.

Angry onboard passengers also vandalised the launch.

Kawrakandi Launch ghat supervisor Muladad Hossain said, when the launch reached the Shibchar's Kathalbari area on Padma River around 8:00pm, it collided with a ferry heading for Mawa from Kawrakandi.

At the time, the launch was carrying around 90 passengers from Mawa, he added.

However, if any passenger went missing following the incident is still unknown.

Local sources said some of the launch's passengers were rescued from the river using speedboats. However, the launch authorities denied this.

Ctg 'rapist' remanded

Police yesterday produced Imam Moinudddin, arrested on charge of raping an eight-year-old girl at Patharghata on Saturday, in the Chief Metropolitan Magistrate's (CMM) Court and sought a five-day remand for him.

The court will hear the remand prayer today.

Police said the girl, a class two student of Rani Sabitri Primary School at Patharghata under Kotwali Police Station, was going to a tea stall near Mohiuddin's shop in the evening to buy food. Moinuuddin called the girl to his shop and raped her.

Being informed, locals beat up Moinuuddin and then

handed him over to the police. Police said Moinuuddin is an imam of a mosque at Yakubnagar in Pathargata and also owner of a shop in the area. He confessed to violating the girl.

Victim's mother filed a case with Kotwali Police Station on Saturday night.

Suspension of PGCL Gas Connections

Company counts loss while applicants in despair

Domestic as well as commercial and industrial gas connections in Pabna, Sirajganj and Bogra districts under Pashchimanchal Gas Company Limited (PGCL) have remained suspended for around a year following an order from the ministry concerned.

On an average, the company has been incurring a loss Tk 1.25 crore per month as gas bill since October last year as all kinds of gas connection has remained suspended, PGCL commercial department sources said.

At least 10,000 applications including those for six CNG filling stations have been pending in several offices of the company, PGCL sources said.

Following a ministry order that cited 'gas crisis' as the reason, PGCL had to stop all kinds of domestic connections in three northern districts on July 19 this year while the company was asked to stop all of commercial and industrial connec-

tions on September 24, 2009.

But the company could hardly give domestic connections after September last year due to different problems including crisis of pipes.

Company sources, however, said there is no gas crisis since the company started commercial operation in 2000.

A senior official of the company told this correspondent over cell phone on Friday evening that a letter has been sent to Petrobangla authorities with a request to relax the restriction on industrial gas connection.

PGCL Managing Director Md Ali Hossain said their management is trying to solve the problem.

"I have paid as per demand note for domestic gas connection to my residence about six months ago but it is yet to be given. And so, I have to bear additional amount of Tk 1000 per month as fuel cost," said Jalal Uddin, resident of Bogra town.

Advocate Zaidur Rahman paid all the official dues for domestic gas connection

to his Satmatha residence in Bogra town about eight months ago but he has not got the connection yet. "I have to pay additional amount of Tk 2,000 on an average every month to buy Liquefied Petroleum Gas (LPG) for cocking," he said.

PGCL General Manager (Marketing) Md Anisul Haque earlier said that they have enough scope to provide gas connections for domestic and other purposes in Bogra, Sirajganj and Pabna districts but they need government approval for it.

PGCL sources said that there is a scope to provide at least 6,000 domestic connections in Bogra, Sirajganj and Pabna districts right now as required gas pressure is available.

PGCL recorded gas pressure of 60 PSI (pound per square inch) near the entry point of Majhera Cantonment area, and almost the same pressure is available at end point of Thengamara on the outskirts of Bogra town which is more than enough to provide 5000 domestic as well as some commercial and industrial connections, sources said.

Rivalry among the influential locals over formation of the managing committee has kept this high school at remote Vati Kapasia, a char area on Teesta basin in Sundarganj upazila of Gaibandha district, virtually closed for six years.

A high school in remote char area at Vati Kapasia under Sundarganj upazila of Gaibandha district has remained without any academic activities for the last six years, as two influential groups are in the race for control over its management.

During the period, three managing committees were formed while rivals engaged in violent clashes and filed lawsuits against each other.

UNO Sabbir Ahmed immediately responded to the allegation and sent a police team to stop the early mar-
