Hard rock miners plan rail, road barricade

Strike continues, ultimatum ends but no programme today due to hartal

The miners of Madhyapara Granite Mining Company Ltd (MGMCL) continued strike for the third day yesterday to press for their seven-point demand including reinstatement of five fellows and withdrawal of the case filed against them by the authorities.

At a meeting held at the entrance of MGMCL yesterday afternoon, the agitating miners announced that they would launch a tougher agitation programme including blocking of Phulbari-Rangpur highway and rail tracks from December 1.

company dismissed five miners and filed a case against them following the incident.

Meanwhile, miners of Barapukuria Coal Mine and workers of Barapukuria Power Plant expressed their solidarity with the miners of MGMCL.

Md Abul Basar, general manager (admin) of MGMCL, said the miners have been hired through the outsourcing company as per the decision of Executive Committee of National Economic Council

"So MGMCL cannot regularise their job. But we've informed the ministry concerned about the miners' demands," he said.

Same old tale of violent for stalking attack by land grabber

Several families of an indigenous community at Aluari village in Phulbari upazila of Dinajpur district are passing days amid panic as musclemen of a local influential person made a violent attack on them to grab their land on Saturday afternoon.

Md Afzal Hossain of Hazipara village of Phulbari upazila accompanied by about 100 people equipped with sharp weapons and wooden sticks attacked the indigenous people to grab about 2.5 acres of land belonging to Shupal Soren, son of late Ramu Soren, locals said.

The village is home of about 30 indigenous families who have been living on government khasland for over 50 years.

The attackers beat up the indigenous people, injuring at least six of them.

Shupal Soren, 40, Mukhi Soren, 55, wife of late Ramu Soren, Ramnath Soren, 38, Gita Moni, 30, wife of Shupal Soren, Sunita Hemram, 27, wife of Manik Soren and Putul Murmu, 22, wife of Ramnath Soren were admitted to Phulbari Health Complex.

The criminals damaged a number of houses, crops and a church made of corrugated iron sheets, axed about 100 trees of a graveyard of the indigenous people and looted goods during the attack, alleged the indigenous people.

Informed, Phulbari police rushed to the spot and brought the situation under control.

Following the attack, Shupal and his family members have remained out of their house due to security threat.

Shupal and his three brothers along with their families have been living on the khas land as their forefathers settled there 50 to 60 years ago,

locals said.

But Afzal Hossain, claiming that he bought the land, was giving threats to Shupal and his family of dire consequences if they do not leave the land, they alleged.

Several times the victim family sought help from the local union parishad chairman but to no effect, said Shom Soren, an elderly person of the area.

Md Nabiul Islam, chairman of Aluari union parishad, also admitted that the indigenous people of the village have been living on the khas land for about 50 to 60 years.

AKM Sarwar, assistant commissioner (Land) of Phulbari upazila, declined to make any comments over the incident.

Jonas Soren, brother of Supal Soren, filed a case with Phulbari police station on Sunday night accusing at least 22 people for Saturday's attack on indigenous people, said Md Shawkat Ali, officer-in-charge of Phulbari police station.

Nobody was arrested in this connection.

Power generation resumes

Remaining shut for one and a half months, the 9th unit of Shahjibazar power station in Habiganj district resumed operation yesterday morning putting the station's total generation at 90MW. The unit stopped power generation on 13 October last due to a serious technical fault in the generator. The 8th and 9th units having 35MW capacity each started power generation first on 7 July in 2001. Running for 30 years, all the five units of the 104 MW gas-run Shahjibazar power station went out of operation in 1998. The units-5 and 6 were however, put into operation for producing 20MW in September this year after repairs by local engineers at a cost of Tk one crore.

A young man allegedly committed suicide by going under the wheels of a running train near Rajshahi University mass grave yesterday. Deceased Mohammad Rafi, 20, son of Abdul Majid of Mirjapur area in the city lied down on the rail track at around 12.30pm. The Rajshahi-bound train Uttara Express ran over him severing his body into two parts, said railway police. Sub inspector Khorshed Alam of Rajshahi GRP who visited the scene and recorded statement of witnesses told this correspondent that Rafi used to work at a rural barbar shop.

'Thief' beaten to death

A mob beat an alleged thief dead at Azaipur Moholla in the municipal area yesterday. The dead was identified as Yeasin Ali, 20, son of late Toufijul Hossain of Ramkrishtopur area in the town. ASI Sayed, duty officer at Sadar police station said, Yeasin entered a grocery shop of Abul Bashar at Azaipur breaking the locks at around 5:00am to steal goods. Sensing the incident, locals surrounded the shop and caught him redhanded. Following a severe mob beating Yeasin was taken to Chapainawabganj Adhunik Sadar Hospital where he succumbed to his injuries at around 12:20pm.

Man stabbed to death

A drug addict, who was stabbed grievously by criminals in front of Rail Colony in the district town Friday night, died at Dhaka Medical College Hospital on Saturday. The deceased was identified as Kamal Miah, 35, son of late Ialam Miah of Baniachal area of the town. Police said a gang chopped Kamal indiscriminately at about 9pm in the area, leaving him critically injured. Hearing his shrill cry, local people rescued and rushed him to Sadar hospital. Later, he was shifted to Dhaka Medical College Hospital as his condition deteriorated where he died at midnight.

3'smugglers' arrested

A bailey bridge over the River Chitra in Chitalmari upazila of Bagerhat district collapsed on Sunday morning, snapping road links between Bagerhat and some other districts.

The accident occurred

Ta-16-2476) boarded the bridge at around 8:00am. The stone-laden truck also fell into the river, but its driver and helper, however, survived

and managed to escape.

M Monowaruzzaman of Bagerhat office of Road & Highways Department (RHD), the Bagerhat-bound truck from Panchagarh district was carrying stones.

Though the bridge has ten tonnes load capacity, the truck was carrying 40 tonnes of stones, he said. The engineer further said

that at least seven days would be needed to reconstruct the bridge. The RHD will sue the owner of the truck with a demand for compensation, he added.

Witnesses said one Mesbahuddin and rickshaw van driver Ramen Biswas, who were on the bridge, have been missing since the incident while another named Nazrul Mir sustained severe injuries.

Son of Ashraf Mir of Chitalmari upazila, injured Nazrul Mir is undergoing treatment at Khulna Medical College and Hospital (KMCH), police said.
