Razzak rattles Zimbabwe

Tigers go 2-1 up

Left-arm spinner Abdur Razzak kept terrorising the Zimbabwe batsmen with a staggering spell of 4-14 as Bangladesh coasted to an easy 65-run victory in the third game at the Sher-e-Bangla National Stadium in Mirpur yesterday.

But before that it was inform Bangladesh captain Shakib Al Hasan (73) and Mushfiqur Rahim (63) who staged a tremendous recovery in overcast conditions with their 116-run fifth wicket stand to set the platform for the bowlers to take a 2-1 lead in the five-match series.

Despite late decision from the board to hold the match in daytime following a floodlight fiasco as well as the gloomy weather, a lot of spectators turned up. But the beginning did not give them any warmth when the visitors, without any hesitation, invited the Tigers to bat first.

But the top-order batting was found wanting when Bangladesh lost four wickets for 71 runs before wicketkeeper-batsman Mushfiqur joined the in-form skipper to turn the tables on the Africans. The two eventually guided the hosts to a commanding score of 246-7, the highest total of the series up to now. When replying, Zimbabwe

Govt sits on reply to HC

The government is yet to inform the High Court the process of selection of persons for appointment as judges both in the Appellate and HC divisions of the Supreme Court since independence despite an HC directive to do so about five months ago.

Additional Attorney General MK Rahman said vesterday they could not comply with the HC order as they were busy with many urgent cases.

He however told The Daily Star that they

would soon respond to the HC rule on the government that contained the directive.

Following a writ petition, the court issued the rule on June 6 giving four weeks to respond

The rule also asked the government to explain within the same period why specific guidelines should not be framed regarding the process of selection for such appointments (of judges in both the divisions of the SC) to bring transparency and competitiveness in it.

50 killed in Pak suicide blasts

A pair of suicide bombers disguised as policemen killed 50 people yesterday in an attack targeting a tribal meeting called to discuss the formation of an anti-Taliban militia in northwest Pakistan, officials said. The attack occurred on the grounds of the main government

compound in Mohmand, part of Pakistan's militant-infested tribal region. It was the latest strike against local tribesmen who have been encouraged by the government to take up arms against the Taliban.

The explosions also wounded more than 100 people, many of them critically, said Mian Iftikhar Hussain, information minister of neighboring Khyber Pakhtunkhwa province.

One of the reasons the attacks were so deadly was because the bombers had filled their suicide jackets with bullets, said Amjad Ali Khan, the top political official in Mohmand, who was at the compound in Ghalanai town when it was attacked.

Scrutinising the bill titled 'Border Guard Bangladesh Act 2010', the parliamentary standing committee on the home ministry placed a report in the House. The government has

moved to introduce the new law for the border force in the wake of the heinous slaving of army officers in the headquarters of Bangladesh Rifles (BDR) at Pilkhana in February last year.

US cable describes Saddam execution

A newly-leaked US diplomatic cable describes in detail the circumstances of Iraqi dictator Saddam Hussein's execution, from guards telling him to "go to hell" to officials taking mobile phone pictures.

Saddam's execution in December 2006 sparked international controversy after mobile phone video of the sentence being carried out was published on the Internet showing witnesses

taunting him as he was about to be hanged.

The controversies led then-US ambassador Zalmay Khalilzad to comment in the leaked cable that supporters of Saddam would use the poorly-conducted execution as an excuse to condemn what he said was a fair trial.

The cable, dispatched in January 2007 and classified SECRET, was one of several hundred US diplomatic reports that have so far been published by whistleblower website WikiLeaks out of a tranche of 250,000 that it says it has obtained. According to the cable, Iraqi deputy prosecutor Monqith al-


