China is likely to raise interest rates in the coming days in a demonstration of the government's resolve to tame inflation, an official newspaper said on Tuesday.

In a banner headline across its front page, the China Securities Journal said this weekend offered a "sensitive window" for a rate rise, which would be the country's second after a surprise increase in October, the bank's first rate hike since 2007.

China rate rise talk builds as loans and inflation rise

An increase in rates would put fresh on the bones of Beijing's announcement late last week that it was switching to a "prudent" monetary policy from the "appropriately loose" stance of the past two years.

The report weighed on Asian stock markets in early trade, though the country's market in Shanghai later pared losses. Chinese asset markets have tumbled in recent weeks as investors have priced in more tightening.
