UNHCHR chief urges to free Chinese Nobel Peace laureate

AFP, GENEVA, Oslo

UN human rights chief Navi Pillay yesterday called for the release of jailed Chinese Nobel Peace Prize winner Liu Xiaobo, on the eve of the award ceremony in Oslo.

"It is my view that the case should be reviewed, and Liu Xiaobo should be released as soon as possible," she said at a news conference ahead of World Human Rights Day on Friday, which coincides with the Nobel ceremony in Oslo.

China has sharply criticised the Nobel award and those who support the Chinese dissident, and said most of the world was opposed to the Oslo-based committee's decision to honour him.

An exiled Chinese dissident representing Liu's family has criticised the UN rights chief for not attending the ceremony for the laureate, charging she was bowing to pressure from Beijing, but she replied that she had prior engagements connected with marking Human Rights Day.

Meanwhile, the head of the Nobel Committee insisted Thursday this year's choice of peace laureate, jailed Chinese dissident Liu Xiaobo, was not "against" Beijing.

"This is not a prize against China. This is a prize honouring people in China," Thorbjoern Jagland told a press conference traditionally held by the laureate on the day before the annual peace prize

He was surprised to see the level of international support for jailed Chinese dissident and peace prize laureate Liu Xiaobo despite pressure from Beijing.

"We were not expecting a lot of support at a political level since so many countries depend on China economically and politically," chairman Thorbjoern Jagland told the commercial TV2 News channel.

"I am pleased to see how many international leaders have so strenuously demanded Liu's release," he added.

Speaking of the empty chair that will represent this year's absent prizewinner, who remains in a Chinese prison, he said "it is a very strong symbol (that) shows how appropriate this prize was."

On the other hand, China yesterday said the "overwhelming majority" of people around the world opposed the Nobel committee's decision to honour jailed dissident Liu Xiaobo as this year's peace laureate.

The fresh round of criticism of the Oslo-based committee comes on the eve of a ceremony in the Norwegian capital honouring Liu, who was jailed in December 2009 for 11 years on subversion charges.

"Those people at the Nobel committee have to admit they are in the minority. The Chinese people and the overwhelming majority of people in the world oppose what they do," foreign ministry spokeswoman Jiang Yu told reporters.

"Any attempt to exert pressure on China... cannot succeed."

Earlier this week, Jiang referred to the members of the committee as "clowns" and accused them of "orchestrating an anti-China fuss".

The writer and former professor, who was at the forefront of the 1989 Tiananmen Square protests, was jailed in December 2009 for 11 years on subversion charges after co-authoring "Charter 08", a manifesto that spread quickly on the Internet calling for political reform and greater rights in

INDIAN TELECOM SCAM

Govt appoints retired SC judge to probe

The Indian government has asked a retired Supreme Court judge to look into the telecom policies followed by different governments since 2001.

Telecom Minister Kapil Sibal said the inquiry by retired judge Shivraj Patil will be completed within four weeks. It will examine instances where procedure was not followed, as well as any lack of transparency.

Sibal said that the Supreme Court is already examining criminal culpability for the humongous 2G scam - estimated to be worth Rs. 1.76 lakh crore by the government's auditor.

Meanwhile, sources in the CBI say that during the raids at A Raja's home, they have seized three diaries, written in English, crammed with numbers that seem to indicate details of business transactions.

Till last month, when he was forced to resign, Raja was the Telecom Minister. Before that, he was the Environment Minister in UPA1, and these diaries are reportedly from that period.

Raja's homes in Delhi and his family's homes in Tamil Nadu were raided yesterday, along with the houses of four of his close aides and a man reported to be his business partner. The raids came nearly a year after the CBI filed a police case

against unknown officials in the Telecom Department for what's being described as India's largest-ever scam and centres on the allocation of valuable 2G spectrum in 2008 when Raja was Telecom Minister. Many said that the raids were pretence by the government to

suggest that the CBI investigation will indeed uncover those responsible for the great 2G robbery. Critics point out that Raja and those who worked closely with

him and are now being questioned had plenty of time to get rid of any documentary evidence of their alleged misdeeds.

However, the CBI said yesterday after the raids that it had found "incriminating documents" but did not specify who these were likely to indict.

'Diamondstudded' planet found

Astronomers led by Indian-American Nikku Madhusudhan have discovered a giant planet with an atmosphere and core dominated by carbon, raising the prospect that diamondstudded stars may exist.

Madhusudhan, a Banaras Hindu University (BHU) alumnus now at Princeton University, and his colleagues have observed that an extremely hot planet discovered last year has more carbon than oxygen - a feature never observed on a

planet until now. The planet, called WASP-12b, orbits a star about 1,200 lightyears from Earth, and appears to have temperatures of nearly 2300°C - hot enough to melt stainless steel, the scientists said in the journal Nature.

A computational technique developed two years ago by Madhusudhan while he was a the Massachusetts Institute of Technology (MIT), Cambridge, Massachusetts, was used to analyse the atmosphere of the

Like Jupiter, WASP-12b is made largely of gas, only its core contains carbon-based minerals such as diamonds and graphite, said Madhusudhan, now a postdoctoral scientist in the department of astrophysical sciences at Princeton.
