WAR CRIMES TRIAL HC order on petitions tomorrow

The High Court will pass orders tomorrow on the petitions filed by five detained leaders of Bangladesh Jamaate Islami for quashing the proceedings of International Crimes Tribunal against them in connection with crimes against humanity in 1971.

On conclusion of the hearing on the petitions, an HC bench of Justice Moyeenul Islam Chowdhury and Justice AKM Abdul Hakim yesterday fixed the date for orders.

Detained Jamaat Ameer Motiur Rahman Nizami, Secretary General Ali Ahsan Mohammad Mojaheed, Nayeb-e-Amir Delwar Hossain Sayedee, Assistant Secretary General Muhammad Kamaruzzaman and leader Abdul Kader Mollah filed five separate petitions through their lawyers on September 29 this

They also prayed to the HC to grant them bail in the war crimes cases.

International Crimes Tribunal has issued arrest warrants against them without framing formal charges, the petitions said, adding that the tribunal cannot issue arrest warrant at this stage.

Barrister Abdur Razzaq appeared for the petitioners, while Additional Attorney General MK Rahman argued for the state.

FRAMING RULES ON IMPORT OF SHIPS FOR SCRAPPING

HC starts hearing on Bela petition

The High Court yesterday started hearing a petition filed by Bangladesh Environmental Lawyers Association (Bela) seeking its directives on the government to frame specific rules over the import of ships for scrapping in accordance with HC guidelines.

Bela filed the petition on Sunday as a supplementary to the original writ petition upon which the HC had delivered verdict on March 17, 2009.

In the verdict the HC issued some guidelines, directing the government to frame specific rules in the light of labour and environment protection laws and Basel Convention restricting import of toxic and hazardous ships.

But the Ministry of Environment and Forests apparently ignored the HC order and allowed the ship breakers to import ships with "inbuilt" toxic mate-

An HC bench of Justice AHM Shamsuddin Chowdhury Manik and Justice Sheikh Md Zakir Hossain yesterday adjourned the hearing till 2:00pm today.

In the petition the Bela lawyer said the government has made rules inconsistent with the HC guidelines and relevant laws.

Bela sought directives from the court on the ship breakers not to break 22 ships, which were imported in last two months in the country, until the government frames "appropriative rules".

It also prayed to the court to order the government not to issue noobjection-certificates (NOCs) to importers of ships without environ-

mental clearances.

Advocate Syeda Rizwana Hasan and Iqbal Kabir Lytton appeared for Bela, while Rokanuddin Mahmud argued for ship breakers.

SHIP BREAKERS' NEWS BRIEFING **Bangladesh Ship Breakers Association** leaders yesterday alleged some nongovernment organisations are campaigning against the ship-breaking industry while the ship breakers are working close to the government in compliance with the regulations.

At a press conference held at the Dhaka Reporters Unity, they claimed they hardly pollute the environment as they bring the scrap ships after getting clearance from the Department of Environment (DoE) and other agencies concerned.

Reading out a written statement,

Hefazatur Rahman, president of the association, said the NGOs neither visited any shipyard nor presented any research analysis on the earth, air or water of the yard. Asked whether they had any

research on it, he said the Directorate General (DG) of Shipping is working on

After a long time, 16 ship-breakers had been granted temporary environmental clearance but an NGO filed a writ petition with the High Court in this connection, he said.

Sayeed is devoting herself in identifying the culprits responsible for the murders and rapes of unarmed Bangalees and Bangalee women during the war.

"I have written a charge sheet in my book against the Pakistani army generals for their role in 1971," said Pakistani journalist Hamid Mir, who earned repute particularly for his

interview of Osama Bin Laden. Alamdar Raja, the then West Pakistan divisional commissioner of Dhaka in 1971, who later joined the law profession on his retirement after returning to Pakistan, filed a writ with a

Pakistani High Court. The writ sought to redress the Pakistani atrocities "on their own people (East Pakistanis) during the war".

"I don't expect the writ to yield much . . . but I thought it was a moral responsibility to file the case in view of what I saw during my stay in your country that time," said Raja earlier during a visit to Dhaka.

Malik recalled that after Awami League's election victory by a majority of seats, the vested interest class in Pakistan and the army became upset and gradually the situation worsened, leading to the army action in East Pakistan.

Journalist Hamid Mir said, "I fully support the trial of all those who were responsible for killing innocent people in 1971".

"I think that governments of Bangladesh and Pakistan should join hands for arresting all those who were responsible for genocide in 1971," Mir said.

He recalled that soon after the Pakistan's "1971 debacle", the subsequent government constituted a commission to investigate into the cause of the debacle.

The commission identified General Yahya Khan, General AAK Niazi, Brigadier Muhammad Hayat, General Rao Farman Ali and many others responsible for the genocide.

Govt gets 24 days more for hearing

The High Court yesterday allowed the government 24 days to prepare for hearing of the writ petition that challenged the martial law trial and execution of Col Abu Taher in 1976.

An HC bench comprised of Justice AHM Shamsuddin

Chowdhury Manik and Justice Sheikh Md Zakir Hossain adjourned the hearing till January 6 following a time prayer by Attorney General Mahbubey Alam.

Earlier on December 7 the bench gave the government a week's time on the same ground. Taher's wife Lutfa Taher, his brother Anwar Hossain and

Fatema Yusuf, wife of Yusuf Ali Khan who was sentenced to a life term in the same trial, jointly filed the petition on August 22 this year. During the hearing, Mahbubey Alam told the court that they

needed time for replying to the rule issued earlier. In response to the writ petition on August 23, the HC issued a rule asking the government to explain why Martial Law Regulation No-13 of 1976, under which Col Taher was tried for sedition and executed 34 years back, should not be declared illegal and unconstitutional.

The court asked the government to explain why the orders of the Special Martial Law Tribunal in which Taher and 16 others

2.5 lakh buildings extremely vulnerable to earthquake

Says minister

At least 2.5 lakh buildings of the country are extremely vulnerable to earthquake and tsunami, said Food and Disaster Minister Abdur Razzaque yesterday.

Bangladesh is exposed to the calamities as four active sources of earthquake in the Bay of Bengal can generate tremors up to 7magnitude on the Richter Scale, he said, adding that a quake of 6-magnitude may cause massive destructions.. The minister was speaking as the chief

guest at the inaugural session of a two-day conference on Management of Complex Emergencies organised by Bangladesh Institute of Peace and Security Studies (BIPSS) at a city hotel.

He said the prime minister would hand over various rescue equipment worth Tk 70 crore to the armed forces division and the fire service department as a preparation to earth-

quake events. As per the findings of Comprehensive Disaster Management Programme (CDMP),

exposed to major earthquakes, said Abdur Razzaque.

As many as 90 earthquakes, including nine over 5 on the Richter scale, were detected between 2007 and 2008, the minister said.

He mentioned that cyclone Sidr claimed 3,295 lives and damaged around 2.2 million acres of croplands along with 1.5 million houses in the southwestern coastal belt of the country in 2007. Last year's Aila rendered 50,000 people homeless and exposed 20 million people to post-disaster health hazards.

Razzaque also said Bangladesh being on top of the Global Climate Risk Index has been projected to have 20 million of its population as "climate refugees" by the year 2050.

Alongside the local experts, 12 foreign experts and management practitioners from Pakistan, Nepal, Sri Lanka, China, Singapore Afghanistan and Canada are taking part at the
