As Bangladesh observes the 40th Victory Day today, the pace of the trials of war criminals still falls far short of people's expectations.

The trial of the war criminals is being delayed; there is a lack of manpower and a systematic approach compounded by poor logistic support.

Experts and people dealing with war crimes committed during the Liberation War criticised ministers' bold remarks about the time of the trials' completion, saying their comments sent the wrong message to the international community that the government has control over the trial.

Families of martyred freedom fighters too called for a stop to the passing of such politically motivated comments and ensuring logistic support and adequate manpower to expedite the trial.

"O boy! You have done it!

These were the words an Indian air force officer for Bangladeshi pilot Shamsul Alam when he landed his aircraft after launching an almost impossible operation during the Liberation War in 1971.

Flt Lt Alam, who had escaped from Pakistan and joined the War, flew a dilapidated Otter from Kailashahor of India and destroyed an oil depot near Chittagong seaport on

IOJ chief held over Huji link

Rapid Action Battalion (Rab) yesterday detained Mufti Izharul Islam Chowdhury,

president of a faction of the Islami Oikya Jote (IOJ) for his alleged involvement with a banned militant outfit, Harkat-ul-

Jihad-al-Islami (Huji). A team of Rab, led by Commanding Officer Lt Col Sazzad Hussain and Major Samad, second-in-command of Rab-7 detained Mufti from a madrasa at Lalkhan Bazar around 4:30pm.

"We have evidence and documents proving his involvement with Huji's militancy," Lt Col Sazzad told The Daily Star.

"Mufti Izhar did not show up at our headquarters last Monday, despite being officially summoned," Sazzad added.

HC asks for expert probe

Framing of rules in 3 months

The High Court yesterday directed the government to frame rules within next three months to ban import of any hazardous ships for scrapping. The rules must be framed in the light of six existing laws--

Basel Convention Act, 1989; Bangladesh Environment Protection Act, 1995; Bangladesh Marine and Fisheries Ordinance, 1989; Bangladesh Labour Act, 2006; Bangladesh Territorial Water and Maritime Zone Act, 1974, and Environment Protection Rules, 1997, according to the HC ruling.

In response to a petition filed by Bangladesh Environmental Lawyers' Association (Bela), an HC bench also ordered the government to form an expert committee within a month to check whether any ships with inbuilt hazardous materials enter the country's territorial waters.



Order sought for SQ Chy's arrest

HC rejects Nizami's bail plea

War crimes investigators have sought permission from the International Crimes Tribunal to detain senior BNP leader Salauddin Quader Chowdhury with links to crimes against humanity during the Liberation War.

The prosecutors, on behalf of the investigators, yesterday submitted a petition to the tribunal that fixed December 19 for its hearing, said tribunal Registrar Md Shahinur Islam. In the petition, they sought the court's permission to detain

SQ Chowdhury for his alleged involvement in the killings of Nutan Chandra Kundu, founder of herbal medicine factory Kundeshwari Oushadhalaya at Raozan in Chittagong, on April 13, 1971, and 107 others during the Liberation War.

Meanwhile, the High Court summarily rejected a petition of Jamaat-e-Islami Ameer Motiur Rahman Nizami, who pleaded for quashing the court proceedings against him for alleged crimes against humanity during the Liberation War.

Additional Attorney General MK Rahman told The Daily Star that similar petitions of the other three Jamaat leaders are likely to suffer the same fate.
