Age-old Teesta Bridge turns risky

Leaseholder adding to the worry for 'extra bucks'

Over century-old Teesta Bridge has turned risky, much to the worry of thousands of commuters of Lalmonirhat and Kurigram districts.

The leaseholder is allegedly allowing heavy vehicles including lorry to cross the bridge for

'extra money'. Constructed as a 2100-feet railway bridge over Teesta River in Lalmonirhat Sadar in 1901, the bridge is known as the doorway to the two dis-

tricts. Approximately 1500 vehicles cross the bridge every day. Following an agreement between Bangladesh

Railway and the Roads and Highways Department, light vehicles started crossing the bridge after placement of wooden floorboards in 1978. The authorities allowed only passenger vehicles to cross it at that time.

Later, in sheer violation of the agreement, heavy vehicles including ten-wheeled lorries also started crossing the bridge, eventually shortening its lifespan. The usable time of the bridge, which was hundred years from construction, expired nine years ago.

Now people travel through the bridge risking lives as movement of heavy vehicles caused damage to the

wooden sleepers, turning it unfit for movement.

The leaseholder gets Tk 30 as toll money against per vehicle loaded up to five tonnes but he allegedly receives handsome amounts of money from vehicles loaded over ten tonnes, even ten-wheeled ones.

Violation of the restriction on heavily loaded vehicles is frequent especially during the night with the help of a section of railway staff and some policemen who allegedly get share of the money, sources said.

Denying allegations of taking additional toll money by allowing heavily loaded vehicles, Golam Mostofa Swapon, the leaseholder of the bridge, however, said, "I hardly know about the matter."

Railway Divisional Engineer, Lalmonirhat Asadul Haque said, "As heavy vehicles ply through the bridge, wooden sleepers got damaged before the expiry time."

This is posing risk for train services as well as movement of other vehicles.

"We have already sent a letter to the higher authorities concerned on December 10 after another one in last month for taking necessary steps in this regard. But we are yet to get any response from the authorities," said Asadul Haque.

Meanwhile, during a visit to the area on Tuesday,

State Minister for Mass and Primary Education Motahar Hossain said the under construction new Teesta road bridge over Teesta River in Lalmonirhat Sadar upazila will be opened in June, 2011.

"Necessary action will be taken officially against the construction firm if the contractors of the construction firm fail to complete the bridge by schedule time on 31 May in 2011. Time was extended for third time so far," the state minister said.

Locals, however, expressed doubt about timely completion of the new bridge given the reality that the work was going on in a very slow pace. The construction firm missed two deadlines to

complete construction of the bridge on September 9 in 2009 and May 31 in 2010, they said. The construction work of the 750 metre-long and 12.11 metre-wide road bridge over Teesta River began on September 7, 2006 and it was scheduled to

be completed by three years, costing Tk 87 crore. The Bangladesh government provided 85 percent of the fund and the rest was given by the Kuwait

Two construction firms -- Amin-Delim (Bangladesh) and ASCO (India) are constructing the bridge under a joint venture.

Unruly acts of rogue ruling party men

The Victory Day was celebrated amid untoward incidents at three places of Jhalakathi, Jhenidah and Nilphamari districts yesterday.

In Jhalakathi, at least 20 people were injured and two buses and local BNP office damaged during a clash between the activists of Awami League and BNP at Rajapur upazila headquarters in the morn-

ing, reports a correspondent from Barisal. Witnesses said the clash ensued when the AL men attacked a BNP procession near by-pass road crossing at around 7:30am. The BNP men were returning to their party office in a procession after

placing wreaths at liberation war monument. Both sides equipped with lethal weapons attacked each other, made chase and counter chase. AL men ransacked local BNP office while the BNP activists damaged two passenger buses during the incident. Being informed Rapid Action Battalion (Rab) personnel rushed to the spot, dispersed the clashing groups and

brought the situation under control. The injured were admitted to local health complex and hospitals at Jhalakathi. Police later arrested three BNP activists-Forkan,

Abdullah and Fayez--for damaging the buses. Our Jhenidah correspondent reported that a dais erected by local BNP at Uzir Ali Secondary School ground in Sadar upazila for Victory Day function was damaged allegedly by BCL activists.
District BNP Joint Secretary MA Majid told this correspondent that Chhatra League and Juba league activists vandalised the stage on Thursdaynight.

Officer-in-charge (OC) of Jhenidah Sadar Police Station said unidentified people vandalised the stage made by BNP. A programme arranged by Jaldhaka upazila

administration to honour the local freedom fighters on the occasion of the Victory Day was spoiled yesterday as BCL activists protested the presence of a Jamaat leader at the programme, according to our correspondent.

Sources said the upazila administration arranged the function at Jaldhaka Stadium to honour the freedom fighters in the morning. Upazila Chairman Sayed Ali, also a rokan of Jamaat-e- Islami, attended the function as chief guest while Upazila Nirbahi Officer Sarwar Hossain as special guest.

As the function started, a group of BCL men raised slogans against Jamaat leader Sayed Ali and ransacked the dais.

Freedom fighter Abdul Gaffar said proliberation forces cannot accept the presence of a man belonging to the anti-liberation force. He also criticised the upazila administration for its failure to invite the local AL leaders to the function.

Contacted, Upazila Nirbahi Officer (UNO) Sarwar Hossain said local AL leaders were invited to the function.

Victim's tenant held as suspect

Police yesterday arrested a youth for his alleged involvement in the killing of Anwara Begum Chowdhury, an official of state-run Jalalabad Gas and a freedom fighter on December 9.

The decomposed body of Anwara was recovered from her Lamabazar residence in the city.

Police brought Osman Gani, 21, a tenant of one of the flats of Anwara's house, before local newsmen yesterday evening at the office of Sylhet Metropolitan Police (SMP) Commissioner Dr Aftab Ahmed.

But the journalists were not allowed to ask him any question for, what the officials said, the sake of investigation.

Osman, son of late Jahur Ali of Janigaon under Sunamganj Sadar Police station was arrested from his village home earlier yesterday.

Police officials said, on October 23 Osman rented a ground floor flat of the 4storey building of Anwara and used fictitious home address

and fake father's name for getting enrolled in a city computer training center.

However, police declined to divulge the motive behind Osman's alleged involvement in the killing. They said police would be able to unearth the mystery behind the killing after quizzing Osman thor-

oughly. Deputy SMP Commissioner Rezaul Karim told this correspondent that in addition to a blood stained shirt, the personal laptop and movie camera of the deceased were also recovered from Osman's house at the time of his arrest.
