WikiLeaks vows to target banks after 'attacks'

WikiLeaks founder Julian Assange on Friday said his organization had come under attack from banks, as he vowed to release damaging leaks about them.

"We have been attacked, primarily not by government... although things are heating up now, but by banks, banks from Dubai, banks from Switzerland, banks from the US, banks from the UK, so yes of course we are continuing to release material about banks," he told CNBC television.

In an interview published last month by Forbes magazine, Assange claimed a fresh "megaleak" would target a major US bank "early next

Assange said the bank leak would "give a true and representative insight into how banks behave at the executive level in a way that will stimulate investigations and reforms, I presume."

The controversial Australian said that he was ready to unleash tens of thousands of documents that could "take down a bank or two."

The main target is thought to be Bank of America, based on comments last year from Assange.

After releasing thousands of confidential diplomatic cables Assange has been arrested for sexual assault and seen at least one bank account in Switzerland frozen.

WikiLeaks founder fears US charges

WikiLeaks founder Julian Assange said it was "increasingly likely" the US would try to extradite him on charges related to leaked cables as he savoured his first day on bail.

Speaking Friday outside Ellingham Hall, a friend's mansion in eastern England, where he must live while on bail, Assange said he was concerned about potential moves from US authorities.

"The big risk, the risk we have always been concerned about, is onwards extradition to the United States. And that seems to be increasingly serious and increasingly likely," the Australian told reporters.

The 39-year-old founder of the whistleblowing website is fighting extradition to Sweden, where he is wanted for questioning over allegations that he sexually assaulted two women, which he denies.

But Assange said his lawyers believed a secret

US grand jury investigation had been started into his role in WikiLeaks' release of thousands of leaked US diplomatic cables -- a probe he condemned as "illegal".

Looking relaxed, he said the mansion was a "big improvement" on the London jail where he was held in solitary confinement for nine days before his release on bail Thursday.

Media reports suggest that US prosecutors are trying to build a case against Assange on the grounds that he encouraged a US soldier, Bradley Manning, to steal US cables from a government computer and pass them to WikiLeaks.

Assange said: "I would say that there is a very aggressive investigation, that a lot of face has been lost by some people, and some people have careers to make by pursuing famous cases." He said WikiLeaks had pledged 50,000 dollars

(38,000 euros) towards Manning's legal fund. But he told ABC television in the US that "I

had never heard of the name Bradley Manning before it was published in the press.

Sudan leader diverted not want me funds to Britain to marry Rajiv'

Sudanese President Omar al-Bashir siphoned off nine billion dollars (6.79 billion euros) of oil money into British bank accounts, according to US diplomatic cables revealed by WikiLeaks Saturday.

The document quotes the chief prosecutor of the International Criminal Court as saying that US officials should go public with the allegations about Bashir in order to turn Sudanese public opinion against him.

It said the prosecutor, Luis Moreno-Ocampo, told US officials that the figure allegedly put away by Bashir was possibly nine billion and "would change Sudanese public opinion from him being a 'crusader' to that of a thief."

Lanka involved in human rights abuses

Sri Lanka's government was complicit in the activities of paramilitary groups engaged in political killings, kidnappings, extortion and prostitution, a leaked US diplomatic cable suggested Friday.

The 2007 cable, written by the then US ambassador to Sri Lanka, Robert Blake, cited evidence provided by "trusted embassy contacts" that top officials allowed the groups to operate with impunity, and even encouraged them.

and marked "confidential", is titled "A garrulous Sonia Gandhi opens up to Maria Shriver", indicating how freely the Indian leader chatted away. CABLE ALSO REVEALED

Shriver met Sonia as part of her official visit to India. A reading of the cable indicates the conversation might have been taped by accompanying US embassy officials.

The cable says that Sonia, who is "usually withdrawn and reserved in public ... revealed a rare glimpse of herself" as she spoke about herself, women's issues and compulsions of political life.

"Her comments and demeanour put the lie to cocktail party suggestions that she courts Manmohan Singh's job," the cable said.

The cable says: "Gandhi [Sonia] revealed that her own parents objected to her marriage to Rajiv Gandhi and she 'resented their position' and went ahead and married him anyway." Rajiv Gandhi became

prime minister in 1984 and was assassinated in 1991.

The cable said Sonia was reluctant to provide details regarding her decision to turn down the prime minister's post after the 2004 victory of the United Progressive Alliance (UPA).

"I am often asked about this, but tell people that I will write a book someday with the whole story," she told Shriver.

Rahul warned US of Hindu extremist threat

Rahul Gandhi, widely seen as an Indian prime minister-inwaiting, believes Hindu extremists may be a greater threat to his country than Islamist militants, a leaked US diplomatic cable said Friday.

Gandhi, scion of India's Nehru-Gandhi political dynasty, told US Ambassador Timothy Roemer last year that there was "some support" among Indian Muslims for militant groups like Lashkar-e-Taiba -- blamed for the 2008 Mumbai attacks.

US fears theft of bioweapons from India labs

US officials fear lax security at Indian laboratories could make the facilities targets for terrorists seeking biological weapons to launch attacks across the globe, according to comments in a leaked US diplomatic cable made public Friday.

The cable was part of a trove of documents sent from the US Embassy in New Delhi that was obtained by the website WikiLeaks and published Friday by the British newspaperThe Guardian.

The cables also dealt with accusations of Indian torture in Kashmir, India's complaints about Pakistan's handling of the Mumbai terror attacks, and the concerns of Rahul Gandhi -- seen as India's prime-minister-inwaiting -- that Hindu extremists posed a greater danger to India than Islamist militants.
