Tiger kills fisher-woman

Quoting locals police said, the victim along others went to fish in the Tengrakhali canal. All of a sudden, a tiger swooped on her and dragged her into the deep forest at about 12:30pm. Local people recovered the body in the afternoon.

Motorbike lifter held

A ringleader of an inter-district motorbike lifters gang was arrested from a garage in Patharghata upazila of Barguna district Saturday morning. The arrestee was identified as Sujan Khan, 25, son of Sultan Khan of the upazila. On secret information, a joint team of Bagerhat and Patharghata police conducted a drive at 'Bhai Bhai' motorcycle garage in the upazila and arrested him. Police also recovered two motorbikes from his possession. Sujan also confessed that he along with his accomplices Sohag and Sumon of the area and others were engaged in lifting motorbikes from different southern districts since long.

6 ruling party men sued

The other accused are Jubo League leaders Maniruzzaman Mukul and Liton, local Chhatra League leaders Abdur Rab, Ranju and Kabir. Police said, Shyamnagar upazila AL erected an arch to mark the Victory Day near the Shaheed Minar on December 13. The accused damaged the arch and set fire to it due to rift in local AL on December 15 night.

MUTINY IN RANGAMATI

23 BDR personnel

The special court-15 yesterday framed mutiny charges against 23 BDR personnel of 18 Rifles Battalion under Rangamati sector.

All of the 23 accused were produced in the special court headed by Col Zahedur Rahman, Chittangong sector commander, at 10:00am. The two other members of the court are Lt Col Md Abdun Nur and Maj Golam Mostafa al Mamun.

Prosecutor Lt Col Mehedi Hasan read out the allegations against the accused. He appealed to the court to frame sentative Kazi Md Ijarul

charges against all the 23 as they took part in mutiny at the battalion headquarters on February 26, 2009.

The accused revolted against their officers, expressing solidarity with the mutineers of BDR headquarters at Pilkhana in the capital and looted firearms and ammunition from armoury, the prosecutor said.

All the 23 accused claimed innocence. The special court then framed charges against the accused and adjourned the trial proceedings until 10:00am today.

Haque Akand, senior public prosecutors advocate Belayet Hossain and advocate Aminur Rahman Khan were present in the court.

BDR personnel at three of the sector's five battalions revolted on February 26 last year, expressing solidarity with the rebels of BDR headquarters at Pilkhana in the capital and looted arms and ammunition from armouries.

The battalions are 12 Rifles Battalion at Rajanagar in Longudu, 9 Rifles Battalion at Marishya in Baghaichhari and 18 Rifles Battalion a Chhotohorina in Barkal upazila.

BSF kills one in Benapole

College teachers end strike

TANORE WHIPPING OF HOUSEWIFE

2 out of 7 accused held

Police yesterday arrested two of the seven accused in the case for whipping a housewife who succumbed to her injuries at Rajshahi Medical College and Hospital on December 14.

The arrestees are Sajjad Hossain, 45, and Meherjan Bibi, 40, of Kochua village under Tanore upazila. They were produced in the court that sent them to jail.

The victim, Sufia Begum, 45, wife of Omar Ali Pramanik, fell victim to fatwa (religious edict) and was whipped 40 times at the village a month ago over allegation of an illicit affair with her stepson.

Sufia fell sick following the incident and was under treatment of a village doctor. As her condition deteriorated, she was admitted to Rajshahi Medical College Hospital where she died on Tuesday.

Taimur Rahman, brother of the victim, filed a case with Tanore Police Station on Saturday, alleging that she succumbed to her injuries.

Charges framed against 23 BDR personnel Moulvibazar to recall tragic death of over 25 war heroes today

Today is December 20, a reminder of a painful memory for the people of Moulvibazar.

On this day in 1971, only a few days after the final victory over the Pakistan occupation forces, more than 25 freedom fighters met tragic death in a series of explosions caused by an accidental mine blast at the transit camp established at century-old Moulvibazar Government High School.

After December 16, local freedom fighters in batches started joining the transit camp and arms, ammunition, mines and other explosives carried by the freedom fighters were being kept there.

On December 20 morning, a mine from the hand of a freedom fighter accidentally fell on the floor of the school building and exploded with a big bang. It caused blasting of several other mines.

Hearing the sound of explosions, local people and Indian allied army rushed to the spot and recovered the bodies of over 25 freedom fighters.

The were buried with due honour in the south-eastern corner of the playground of Moulvibazar Government High school. A martyrs' memorial, built

in front of the burial ground, came to be known as the Central Shaheed Minar of Moulvibazar district. Beside the Central Shaheed Minar, another monument was

later built with inscriptions of a list of 25 freedom fighters who died in the tragic incident. Martyred freedom fighters mentioned in the list at the monument are -- Suleman Miah (Fenchganj, Sylhet), Rahim Bakhs Khuka

(Kulaura, Moulvibazar), Askar

Ali (address not known), Jahir

Miah (Kulaura, Moulvibazar),

The number of the victims would be much more as several bodies got burnt and destroyed beyond recognition, said a few senior politicians of the area.

80 hurt as rival villagers clash in Habiganj, Patuakhali

At least 80 people were injured as rival villagers in Habiganj and Patuakhali clashed on and upazila health complex in critical condi-

In Habiganj, at least 50 people were injured in a fierce clash between two groups of villagers over embezzling money of a mosque at Nischintapur village in Baniachang upazila. Locals said, an altercation ensued on

Saturday morning between Abdur Nur and Rafiq Miah of the village over misappropriation of the money. Later, both the groups equipped with lethal

weapons attacked each other leaving 50 people from both sides injured.

On information, police rushed to the spot and brought the situation under control. Among the injured, 25 were admitted to Sadar hospital.

In Patuakhali, at least 30 people were injured as two rival groups of villagers clashed over a disputed land at Nayabhangoni village under Rangabali police station in Galachipa upazila on Saturday. Of the injured, 12 were admitted to hospital
