Remand prayer for Izharul rejected

A Chittagong court yesterday rejected a 10-day remand prayer for Mufti Izharul Islam Chowdhury, president of a faction of Islami Oikkya Jote (IOJ), and sent him to jail.

Judicial Magistrate Md Aktar Hossain passed the order after MA Latif, subinspector of the police station concerned and investigation officer of the case, produced him before the court.

Five activists of the banned militant outfit Harkat-ul-Jihad-al-Islami (Huji) were also produced before the court with a 10-day remand prayer for each on the same day. The court also rejected their remand prayers.

The case was filed on December 16 at Raozan Police Station on charge of Mufti Izharul's alleged involvement in Huji.

BID TO CLEAN GULSHAN-BARIDHARA LAKE

10-day drive starts

A team of government officials along with local community leaders launched a ten-day drive for cleaning the Gulshan-Baridhara Lake yesterday.

Six government officials trained under Management at the Top (MAT) workshop have undertaken the participatory drive as a pilot project to make it sustainable, said Rawnak Mahmud, convener of the cleaning programme.

The drive launched from Baridhara Lake Park continued for a one-kilometre stretch of the Gulshan-Baridhara Lake up to road No 80 near Kalachandpur.

The first phase of the project will continue until end of December and the second phase will be run through January to June 3, said Mahmud, executive officer of Dhaka City Corporation zone-9.

Some eight workers will be appointed during the second phase to guard and clean the said stretch of the lake. Private waste collectors have agreed to collect the lakeside wastes dumped in bins.

Thirteen local community organisations will bear the cost worth Tk 65,000 to carry out the drive.

Chowdhury, convener of Gulshan Society (zone-6), said it was inspiring to see the government officials taking an initiative with the local

people in such a public service. "I am hopeful that the move will sustain and the community will extend cooperation, as the government and the locals will work together,"

he said. A total of 55 house owners have been identified as illegally connecting their sewage lines with the surface drains that directly release into the lake.

Leaders of the drive will hold a meeting with the landlords of Gulshan and Baridhara on January 7 and request them to stop releasing domestic sewages into the surface drainage system.

Officials of deputy secretary and joint secretary ranks since 2005 have been taking part in the MAT workshops funded by DFID and Bangladesh government to receive training on innovative and reformative ways of doing public service.

The MAT workshops are aimed at working in five broad areas of socio-economic welfare ultimately to facilitate achievement of the Major General (retd) Amin Ahmed Millennium Development Goals, said Rawnak.

ELEVATED EXPRESSWAY

Bid evaluation report submission today

Tender evaluation committee on Dhaka Elevated Expressway (DEE) submits its appraisal report on the winning bidder's financial bid to the communications minister today for approval.

The committee will hold further negotiations with the bidder after ministerial approval, said Prof Jamilur Reza Chowdhury, head of the Tender Evaluation Committee (TEC).

It will take some time to analyse in detail both the technical and financial offers of the winning bidder and determine the negotiation strategies for further gains of the government, he

Some areas of the negotiations include the annual concession fee and reducing construction cost of "Box" and "I" type girder of the elevated way, said Chowdhury, ex-professor of Buet and former vice-chancellor of Brac University.

"Technical teams of Buet and Infrastructure Investment Facilitation Centre are preparing a cost analysis of the project and we will ask for item-wise analysis of the project cost proposed by the bidder for negotiation."

Mosharraf Hossain Bhuiyan, secretary to Bangladesh Bridge Authority (BBA), implementing agency of the 26-kilometre DEE project, said they sat yesterday with TEC and expert teams from IIFC and Buet to ascertain areas of further negotiations.

They sit with the bidder, Ital-Thai Development Company, tomorrow to inform points of agreement and disagreement on the technical and financial offers.

PILKHANA MUTINY

Two BDR men plead guilty

Two BDR Rifles Security Unit (RSU) members yesterday pleaded guilty of their involvement in the February 25-26 mutiny last year at a special court at the Darbar Hall of Pilkhana.

After the proceedings began, the threemember Special Court-7 led by BDR Director General (DG) Maj Gen Md Rafiqul Islam completed reading out individual charges against 113 accused mutineers of the RSU.

The BDR DG then said, "The court will show special consideration if you [BDR jawans] admit your guilt."

When sepoys Wazed Ali Mollah and Komor Uddin pleaded guilty, the court asked the security to free them from handcuffs and separate them from others. Both of them were seen in tears at that time.

Wazed has been charged with collecting firearms and ammunition from the magazine, and participating in the mutiny while the allegations against Komor are not informing the higher authorities about the mutineers' plans and not resisting them.

Some of the 113 are accused of more than one crime.

The allegations against 111 jawans of the unit include leaving the Darbar Hall, showing solidarity with the mutineers, participating in the mutiny with firearms, not working to prevent the mutiny and failing to control unruly subordinates.

BSMMU RECRUITMENT

Doctors blame admin for losing job

The medical officers of Bangabandhu Sheikh Mujib Medical University (BSMMU), who lost their jobs following a recent High Court (HC) verdict, blamed the current administration yesterday.

Under the banner of 'Doctors from every level of BSMMU', they formed a human chain in front of the university at Shahbagh in the city and claimed that the appointment issue was resolved in 2006.

The issue was revived and the university authorities did not fight as the defendant. Rather, it cleverly hid real information from the court. That is why the HC on December 14 this year declared appointment of 236 doctors illegal, they said.

Prof Iqbal Arslan filed the writ petition on January 2, 2006. The HC on February 28 that year said there are no irregularities in that appointment.

However, as the then authorities did not dismiss the case, Dr Iqbal, secretary general of Swadhinata Chikitshak Parishad, a pro-Awami League doctors forum, revived the case again in November this year.

But this time the university authorities did not fight the case as the defendant. That is why the result went in favor of the plaintiff, they said.

Test for govt high school teachers' posts Jan 7

The written test for selection of candidates for the post of assistant teachers of government high schools will be held on January 7 next year.

The teachers will be appointed against 1,968 posts created after the introduction of double shift in 82 government high


