2G SCANDAL

Indian police grill former minister

Indian federal investigators yesterday questioned a former minister at the heart of one of the biggest corruption cases in the country's history.

Ex-telecom minister A. Raja quit last month over the 2008 cut-price sale of secondgeneration (2G) mobile phone licences that India's government audit watchdog said cost the treasury as much as 40 billion dollars.

A spokesman for the Central Bureau of Investigation (CBI) said Raja was being questioned at its headquarters in New Delhi.

Raja, who has denied any any wrongdoing, is accused of changing rules to help certain companies, many of which, according to the auditor, were ineligible to apply for wireless permits.

His lawyer said his client feared he already stood "condemned, charge-sheeted, tried and convicted by the media."

The questioning came after police raided Raja's home and offices along with those of current and retired telecom ministry officials and a high-profile corporate lobbyist. The CBI has said the searches recovered

allegedly "incriminating documents". Indian media reports say the CBI is probing the possibility of kickbacks being paid by some of the firms bidding for 2G licences.

The scandal paralysed parliament for the entire winter session and has brought opposition calls for Prime Minister Manmohan Singh's resignation.

Raja was expected to face questioning about alleged irregularities in the timing of the sale and about the role of his relatives in some of the companies which allegedly acted as fronts for certain telecom firms which won spectrum.

The case is being seen by Indian commentators as the Congress-led coalition government's most serious crisis during its six years in

Singh, 78, declared earlier in the week he had "nothing to hide" as he volunteered to be quizzed by a parliamentary panel over the scandal. But the offer failed to satisfy the opposition which is seeking a cross-party investigation into the licence sale. Singh, who enjoys a reputation for honesty

Cambodia's premier said yesterday he accepted an apology from the World Food Programme for an incorrect statement about the country's food security, days after the controversial jailing of a WFP

Cambodian warehouse employee Seng Kunnaka was sentenced on Sunday to six months in prison for printing and distributing antigovernment material in a rushed trial criticised by rights groups.

The arrest came not long after Prime Minister Hun Sen gave a speech in which he attacked the WFP for wrongly claiming Cambodia was vulnerable to food shortages. The UN organisation has since apologised for the

A government spokesman told AFP earlier this week that there was no connection between the arrest and Hun Sen's attack on WFP.

"This is an individual case... They did not prosecute WFP," Khieu Kanharith said Monday.

Nepal crisis not to end by 2010

With just a week left for the year to end, the protracted political crisis paralysing Nepal for nearly six months is not likely to be resolved with the formation of a new government by next Friday. The faint hope of a new government ended with the opposi-

tion Maoist party losing their parliament battle Thursday night

to the ruling coalition and agreeing to call it off. The former guerrillas had forced President Ram Baran Yadav to call a special session of parliament this month in a bid to end the futile prime ministerial election process, which failed to

choose a new premier despite 16 rounds of vote, and begin a fresh race with new contestants. The special session was also intended to be a rap on the knuckles for the government that had prorogued the house last month without their consent after a brawl in the house over the

new budget. However, the plan misfired after it became apparent that the communists in the ruling coalition, who are also demanding a new prime ministerial election, would not support the Maoists but remain with their allies and defeat the former rebels if it came to a vote.

The Maoists therefore had no option but to agree to end their much-vaunted special session after only two sittings.

While the mollified ruling parties said a regular session of parliament would be called within a week and it would focus on electing a new prime minister, it would still not end complications and have a new government in place by Friday.

The Nepali Congress, the largest party in the alliance government, has refused to withdraw its candidate, Ram Chandra Poudel, who has been holding up the formation of a new government for months.

Poudel is the only contestant left in the prime ministerial fray after both the Maoists and communists were forced to withdraw their nominees, the first due to a vote-buying scandal and the latter after a feud within the party.

Militants kill US spies to avenge drone attacks

Suspected American spies are being killed routinely in Pakistan's northwestern tribal region bordering Afghanistan, apparently to avenge US drone attacks.

Tribesmen in the region have said corpses appear in fields and on roadsides almost every day with written warnings pinned to their clothes: 'All American spies will meet the same fate.' 'Espionage has long been

viewed as an egregious offence in the lawless borderland but residents say the current pace of assassinations is unprecedented,' The Washington Post reported yesterday. The killings parallel a mas-

sive surge in CIA drone attacks on North Waziristan, home to a nest of insurgents that includes Al Qaeda and the militant Haqqani network.

CIA drones have fired 112 missiles on Pakistan's tribal areas this year - 88 percent of which hit NorthWaziristan, the daily said.

But tribesmen have now said the US campaign has had 'farreaching consequences' for people in North Waziristan and has provoked 'cycles of vio-lence' that are difficult to predict and impossible to control.

Pak Islamists warn of anarchy if blasphemy law changed

Thousands of Islamists rallied in major Pakistani cities yesterday threatening further protests and anarchy if the government moves to amend a controversial blasphemy law.

A ruling Pakistan Peoples Party lawmaker sparked outcry last month by seeking to end the death penalty for blasphemy, after a Christian mother of five was sentenced to hang for defaming the Prophet Mohammed.

Demonstrators marched in the eastern city of Lahore, the port city of Karachi and the central city of Multan, after influential religious parties called for protests to defend the law.

A crowd of nearly 1,500 people gathered in Lahore, calling for "Jihad" and pledging to sacrifice their lives to protect the honour of Prophet Mohammad.

They also warned that attempts to soften the law would trigger nationwide protests.

"Pakistan was created in the name of Islam and we will not tolerate any attempt to amend the law," a leader of the pro-Taliban Jamiatul Ulema-e-Islam (JUI), Maulana Ahmad Khan told the participants.

Former information minister and lawmaker from the ruling Pakistan Peoples Party government, Sherry Rehman in November submitted a draft bill in the lower house seeking an end to

quoted Rehman as saying that the law victimised minorities in the country.

Rights activists also say the law encourages Islamist extremism in a nation already beseiged by Taliban attacks.

Addressing a separate rally of over 500 people in Lahore, a leader of the banned charity Jamaatud-Dawa (JuD), Husnain Siddiqui said, "We will launch a national movement against all those lawmakers, who support efforts to amend the

Politicians and conservative clerics have been

Pakistan has yet to execute anyone for blasphemy, but Bibi's case has exposed the deep faultlines in the conservative country

In the port city of Karachi, more than 2,000 people rallied against Rehman's proposed draft bill and demanded the government had Bibi a severe punishment for insulting Prophet

Bibi was arrested in June 2009 after Muslim women labourers refused to drink from a bowl of water she was asked to fetch while out working in the fields.

Days later, the women complained that she made derogatory remarks about the Prophet Mohammed. Bibi was set upon by a mob, arrested

US pays Pakistan more than \$600m in aid

Washington transferred more than 600 million dollars to the Pakistani government this week to pay for its efforts in the fight against violent extremists, the US embassy in Islamabad said Thursday.

The 633 million dollar payment under the Coalition Support Fund (CSF) programme came on Wednesday, amid reports that top US military commanders in Afghanistan were pushing to expand special forces ground raids across the border into Pakistan's lawless tribal areas.

"The Coalition Support Fund is designed to reimburse the government of Pakistan for expenses incurred fighting violent extremist groups," the embassy said in a statement. It added that the payment covered the first six months of this

year and Pakistan had now received "approximately 8.76 billion dollars" since 2001 under the scheme. The CSF process reimburses 27 nations, including Pakistan, for logistical, military and other support provided to

Washington's overseas military operations. Washington considers Pakistan's lawless tribal belt the global headquarters of Al-Qaeda and says eliminating the militant threat is vital to winning the nine-year war against the Taliban in neighbouring Afghanistan.
