The department of environment (DoE) yesterday fined a dyeing factory Tk 19.5 lakh for polluting Karna Para canal in Savar, the outskirts of the capital.

Bangladesh Dyeing Ind Ltd was also given an ultimatum of 24 hours to initiate the functioning of ETP.

A team of the DoE conducted the drive around 1:00pm, says a press release.

The team found that toxic liquid waste of red, blue, and purple colour from the industry was flowing into the canal.

Boiler blast kills two, injures 50

Two workers were killed and 50 others injured, eight of them critically, in a boiler blast in a tobacco factory at Najirerhat in sadar upazila yesterday evening.

The dead are Ranzina, 28, and Mahbul, 30 of village Najirerhat. The injured workers were sent to Rangpur Medical College Hospital. The condition of Arzina, Roksana, Sabina and Rozina is

critical, said the hospital director. Eyewitnesses and fire fighter sources said the boiler in Siraj Varosha (SV) Tobacco exploded at about 6:15pm as the water in

the boiler ran short.

Director of Fire Service and Civil Defence of Rangpur said auto-feed of the boiler did not work properly. This was why water of the boiler ran short and it exploded.

Meanwhile, thousands of villagers encircled factory and staged demonstrations in front of it as police did not agree to lodge any case in this connection.

When asked, OC of Kotwali Police Station Haider Ali said a general diary was lodged in this connection.

Accept constructive criticism

JS body suggests government

A parliamentary body yesterday called upon the government to accept constructive criticism against it from different quarters including the media. The parliamentary standing committee on

the information ministry also said the government should have the strength to accept criticism if it believes in democracy. The House watchdog also termed the Press

Institute of Bangladesh (PIB) as a "white elephant" saying that it has failed to fulfill its objectives. The committee asked authority concerned to bring PIB under a legal framework immediately.

"In the meeting we have told Information Minister Abul Kalam Azad that the government and the media should work hand in hand to strengthen democracy," Obaidul Quader, chief of the JS body told reporters after the meeting at the Jatiya Sangsad Bhaban.

"The government must have accept criticism if it believes in democracy. Dispute will not bring anything positive," he added.

Obaidul Quader, also made comment on various other issues including the much-talked electoral slogan of ruling Awami League --

"charter of change" and "Digital Bangladesh".

"Nothing will change unless the government as well as leaders of Awami League do change their mindset and perception," Quader, also an AL presidium member said.

"The ministers and leaders of ruling Awami League should change their mind before asking people about the charter of change," he added.

On the slogan Digital Bangladesh, Quader said, putting some computers on tables in the government's different offices does not mean Digital Bangladesh,"

"The government will have to ensure it so people can get all information about the activities of different ministries," Quader went on saying, adding that there are websites of different ministries where there was no update information about the respective ministries.

He also said even there are website of some ministries where only name of the minister and his photograph of oath taking ceremony have been put.

On PIB's performance, he said, "PIB has turned into a white elephant like Bangladesh Press Council. The committee asked the ministry to bring the institute under a legal framework to make it meaningful,"

170 more cases to be dropped

The government yesterday recommended withdrawal of 170 more cases classifying those as "politically motivated".

One of the cases was filed against veteran freedom fighter and sector commander of the Liberation War Lt Gen (retd) Mir Shawkat Ali, who died on November 20.

State Minister for Law Quamrul Islam revealed this after the 24th meeting of the national committee to review politically motivated cases at the home ministry.

Of the cases, 145 were filed under the Penal Code, while the rest, including that against Mir Shawkat, were filed by the Anti-Corruption Commission.

Four cases filed against former Proshika chairman Qazi Faruque and two against Jatiya Party (Ershad) lawmaker Ruhul Amin Hawlader were recommended for quashing.

NGOs overlap programmes

Say regulatory body officials

NGO Affairs Bureau (NGOAB) has decided to limit the non-government organisations' programmes so they cannot get concentrated in the same places with the same

Some NGOs are operating in the same places for the same beneficiary groups, said the bureau officials.

Such concentration deprives thousands of remote area people of the services and facilities provided by the development organisations, they added.

According to a senior official, the bureau found at least ten districts where more than fifty foreign funded NGOs have been working.

And they do not know how many local NGOs are operating in the same areas, he said.

He added the same people constantly benefit from the programmes of those NGOs, which deprives the poor and underprivileged people of other remote areas and districts.

"During approval and foreign fund

release, we scrutinise these issues to avoid concentration and make more people to benefit across the country," Khurshid Alam, deputy director of NGOAB, recently told The Daily Star.

Some NGOs concentrate their programmes in Dhaka, Chittagong, Jessore, Barisal, Tangail, Khulna, Dinajpur and Sirajganj for better communication facilities, said the bureau sources.

Data show 1180 foreign funded NGOs out of 1420 in Dhaka division have programmes in Dhaka district alone while only three NGOs work in Sherpur.

It was also found 81 foreign funded NGOs have been working in Chittagong, 42 in Barisal, 38 in Tangail, 68 in Jessore, 51 in Khulna, 44 in Dinajpur, and 30 in Sirajganj.

Only three NGOs are found operating in Laxmipur, Munshiganj, and Sherpur and five NGOs in Panchagarh, Chuadanga, and Feni. Most of these organisations' projects

involve informal education; primary, mater-

nal, and child health care; and different awareness programmes on education, family planning, sanitation, safe drinking water, women empowerment and girl children's education etc. NGOAB has taken stricter steps during

fund release for the micro-finance operators in Chittagong Hill Tracts (CHT), said Khurshid.

operate the micro-credit among the same loan receivers in CHT areas. Tajul Islam of NGO Federation of

Bangladesh, an apex body of over 500 local and national NGOs, told The Daily Star that the programme and area concentration is a problem. He said it should be handled effectively

so everyone can get the services and facilities provided by the non-government organisations. He also pointed out that other regulatory

body can also consider the problem and undertake to take the NGO facilities to large number of underprivileged population of remote areas.


