Natore clash: One more dies

One more person injured in Wednesday's clash succumbed at Rajshahi Medical College and Hospital yesterday morning. Victim Kalim Uddin, 52, was son of Kamor Uddin Biswash of Dhanaidaha Parkol village under Baraigram upazila. Earlier on Wednesday noon Ahsan Habib, 32, son of Aser Ali of the same village was killed and at least five others were injured in a clash between two groups of villagers. Police said, there was a long standing feud between Ahsan Habib and Kamor Uddin over a piece of land. The clash began when Kamor Uddin and his sons went to capture the land and Ahsan Habib and his followers resisted them. Injured Shariful Islam, 35, Sohel, 32, Sumon, 25, Jakir, 26, and Askan, 45, of both groups were admitted to local clinics.

Fire burns dwelling house

Fire burnt down a house at Boalia village in Chitolmari upazila on Wednesday morning. Police quoting locals said the fire originated from an electric short circuit at the house of Kanai Lal Mondol and soon engulfed the entire house. Hearing the hue and cry, locals rushed to the spot and doused the fire after one and half hours of frantic efforts. The house owner claimed that cash and valuables worth Tk 10 lakh were gutted by the fire.

Cadet college tops list

Sylhet Cadet College has topped the list of the 20 institutions under Sylhet Education Board in the Junior School Certificate Examination.

All the 53 students of the college came out successful while 26 of them got GPA-5.

Blue bird School and College became second with 37 GPA-5 recipients among its 242 students. Only one student failed to succeed. Sylhet Government Pilot

Boys' High School was the third with all 256 students passed including 14 GPA-5. Jalalabad Cantonment Public School and College followed it with 70 out of 71 coming out successful capturing 12 GPA-5. Sylhet Government Pilot Girls' High School was fifth with all the 232 passed including 12 GPA-5. It was followed by Buds Residential Model High School with all 145 passed including eight GPA-5. The seventh position went to Habiganj Government

Boys' High School with 110 successful candidates including six GPA-5. BTRI High School of Srimangal captured eighth place with all the 58 students successful while five got GPA-5.

BKGC High School in Habiganj became ninth as its 119 out of 120 passed having eight GPA-5 recipients while Sylhet Rifles Public School had 10th position as 179 students out of its 186 were successful. The school had 13 GPA-5 recipients.

5 leaders of Jamaat, Shibir sent to jail

A court sent to jail three leaders of the district unit Jamaat-e-Islami and two Shibir men, rejecting their bail petitions yesterday.

The five Jamaat leaders were identified as district Jamaat ameer Abdus Sattar, Sadar upazila Jamaat ameer Prof Shamsul Islam Talukder, secretary Abdur Rashid Hasemi, district unit Shibir president Mahfuzur Rahman Bhuiyan and secretary Abul Hashem Mollah.

They were held in connection with December 7 clash in which 30 people including 5 policemen were injured.

Police filed a case against 42 Jamaat leaders and workers under Speedy trial Act on the day.
