### Malaysia likely to send back 3.5 lakh Bangladeshis

Instead of extending work visas, Malaysia may send back 3.5 lakh Bangladeshis whose job contracts have already expired, said Expatriates' Welfare and Overseas Employment Khandaker Mosharraf Hossain yesterday. "The Malaysian authorities have said this to [the minis-

try]. But, we have requested them to renew their visas, because these workers spent too high to go there and may not earn the amount they spent," he told The Daily Star last evening. According to statistics, there are around five lakh

Bangladeshis there. Nearly four lakh went there since late 2006. Malaysia is not recruiting from Bangladesh now. However, sources in the government said that country is planning to reopen the market soon.

Asked why Malaysia is not renewing the workers' visas when they need workers and is planning to reopen the market, Mosharraf Hossain said, "You have to ask this question to the Malaysian authorities."

#### COL TAHER'S TRIAL

### Reply to HC today

The government is likely to place a reply on the High Court (HC) rule over the martial law trial and execution of Col Abu Taher before HC today, terming those illegal and unconstitutional.

An HC bench comprised of Justice AHM Shamsuddin Chowdhury Manik and Justice Sheikh Md Zakir Hossain will hold final hearing on the writ petition challenging Martial Law Regulation No-13 of 1976.

Col Taher and 12 others were tried for sedition under this regulation and executed on different dates in 1976 and 1977. On August 23 last year, it issued a rule asking the govern-

ment to explain why the regulation and execution of Col Taher should not be declared illegal and unconstitutional. Additional Attorney General MK Rahman yesterday told

The Daily Star that they would submit the reply saying all martial law, rules and regulations are illegal and unconstitutional as per the Supreme Court verdicts on the constitution's fifth and seventh amendments.

The trials and executions were also without lawful authority and against the constitution, he said.

Col Taher's wife Lutfa Taher, his brother Anwar Hossain and Fatema Yusuf, wife of Yusuf Ali Khan who was sentenced

to life, jointly filed the petition on August 22.

### Police to seek remand for three

Police will seek fresh remand for three visually impaired people today, held in connection with the murder of the general secretary of Jatiya Andha Sangstha, an organisation for the visually impaired, after a two-day remand. Hasina Akhter, wife of murdered Khalilur Rahman, filed a

case with Mirpur Police Station against eight visually impaired people. Hasina alleged that the three were allegedly present in a meeting, which resolved to kill Khalilur using hired criminals. Officer-in-Charge (OC) Kazi Wazed Ali of Mirpur Police

Station yesterday said the three, claiming to be innocent, alleged that Ayub Ali, defeated by Khalilur in the organisation's general secretary election, might know something. The three said Khalilur embezzled huge amounts of money, received as foreign grant and proceedings of the

organisation's lottery ticket sale, creating serious resentment among the common visually impaired people, said the OC. Minhaz, one of the three, was defeated in the organisation's president post election, said the OC, adding that police

are raiding different places to nab Ayub who is on the run. Khalilur was shot dead allegedly by his rivals at a house in city's Mirpur on Saturday night.
