Hundreds of Uttara EPZ workers stage sit-in

Demand release of 10 held on Sunday

Several thousand workers of Uttara EPZ (export processing zone) at Shongolshi yesterday abstained from work and came to the district town by walking about 10 kilometers to demonstrate in front of the deputy commissioner's (DC) office.

As police obstructed them before the DC office premises, the agitated workers staged a day-long sit-in there demanding release of arrested workers and withdrawal of cases. Earlier on Sunday,

Jasimuddin Ahmed, manager of Diaz Spinning and Knitting Limited, a factory in the EPZ, filed a case under Speedy Trial Act accusing 10 workers of ransacking the factory and obstructing others from attending work.

Diaz authorities alleged that the unruly workers of another factory ransacked the unit and obstructed their workers.

The workers arrested in the case appeared before the chief judicial magistrate court yesterday and prayed for bail. The court rejected prayers of nine of them and sent them to jail.

The workers sent to jail are Md Farook Hossain, Selim, Joinal Abedin, Md Nur Alam, Md Montu Mia, Md Jahangir Alam, Md Motiur Rahman, Md Rabiul Islam and Md Mizanur Rahman.

Most of the accused are workers of Uttara Sweater Manufacturing Company Limited, the biggest unit at the EPZ.

Sunday's was the second case filed against the workers by another management in the EPZ since the workers staged their agitation programme on 13 December demanding their wage as per new government pay structure.

On 19 December, **Evergreen Products Factory** Limited filed a case against 11 workers bringing charges of ransacking, creating chaos and flexing muscle.

In that case police arrested two and later the court granted bail to all the 11 accused.

Hafizur Rahman, general manager of Uttara EPZ told this correspondent that the factory fulfilled most of the demands of the workers. But a small section of unruly workers is creating chaos in the EPZ to discourage the foreign investors. The investors have all the right to take legal steps to safeguard their assets, he added.

Counicillors lock mayor office in Pabna

Agitated councillors of Faridpur municipality in the district locked the mayor's office on Monday afternoon protesting recruitment of 12 employees allegedly to woo votes in the upcoming municipality election.

Refuting the allegation, mayor Abul Hossain claimed that the recruitment was made through a long administrative procedure.

According to the sources, recruitment of 12 employees of the municipality was completed in December. Earlier the recruitment of the posts was postponed in 2004 as the councillors had protested the recruitment terming it a 'political recruitment'.

"The mayor recruited 12 employees belonging to BNP, Jamaat parties in 2004. We protested the political recruitment and the then district administration stopped the recruitment. After 6 years the mayor recruited them again last month targeting the upcoming municipality election." Md. Shahadat Hossain, councilor of Ward No. 2 of Faridpur municipality told this correspondent.

The mayor left the area when the news of agitation by the councillors spread in the municipality. All the 12 councillors went to the mayor's office and locked it on Monday, locals said.

Contacted, mayor Abul Hossain also the upazila unit BNP leader refuted the allegation.

"There was a long investigation into the disputed recruitment process. After the investigation I recruited them last month," Abul Hossain said.

Asked about the locking of his office, the mayor said that the councillors often harassed him for not heeding to their illegal proposals.

Teachers protest 2 shifts

in govt high schools

144 to vie for 31 mayor posts in Khulna division

One hundred and fortyfour candidates will now contest for the post of mayor in 31 out of 33 municipalities of ten districts in Khulna division.

However, the election to Lohagarha municipality of Narail district remained stayed by the High Court.

On the other hand, election to Magura Sadar municipality will be held on January 27 as per schedule of the Election Commission as court quashed the stay order.

According to sources at Khulna divisional office of the Election Commission, 52 out of 196 candidates for mayoral posts withdrew their nominations on December 27.

The highest number of 17 out of 45 mayor candidates who have left the race are from Jessore district followed by 16 out of 44 candidates from Jhenidah district.

Only one out of 15 candidates withdrew nomination leaving 14 others in the race to vie for the post of mayor of Satkhira Sadar and Kalaroa municipalities in Satkhira district.

Sources said both Awami League and BNP failed to resolve intra-party squabbles to prevent more than one candidate from submitting nomination papers for mayoral posts in most of municipalities in 10 districts of Khulna division.

December 15 was the last date for submitting nomination papers while

December 27 was the date for withdrawal. The scrutiny of nomination papers was held on December 18 and 19.

The authorities will set up 500 polling centres having 2,864 polling booths for 33 municipalities in ten districts of Khulna division.

According to Election Commission office sources, the total number of voters for polls in Khulna division is 8,83,564.

Of them 4,36,341 are male and 4,47,223 female.

Meanwhile, 282 out of 500 polling centres in ten districts of Khulna division have been identified as most risky. These polling centres are located in the outlawinfested districts, EC office sources said.x

Memorial of mine blast victims in utter neglect

The memorial, built in honour of around 800 victims of the mine blast tragedy on January 6 in 1972 on the premises of Moharaja Girijanath High School at Balubari in Dinajpur town has remained in utterneglect.

Same is the condition of their mass grave at Chehelgazi village in Dinajpur Sadar upazila.

After the final victory against the Pakistan occupation forces on December 16 in 1971, a transit camp of freedom fighters under sectors 6 and 7 were set up at the school.

About eight hundred freedom fighters were staying at the transit camp while hundreds of mines and mortar shells left by the Pakistan occupation forces at different places were gathered and kept at the camp.

In the afternoon on the fateful day, an accidental mine blast led to a series of explosions, shaking several square kilometres of area and covering the school premises with thick smoke bellowing high. Orgy of blood and blown up limbs of the freedom fighters created a pathetic scene in the area.

Around 200 freedom fighters died on the spot that day and many other injured

died later, said Dinajpur Municipality Mayor Md Shafiqul Haque, also an eyewitness freedom fighter.

Bodies of 86 martyred freedom fighters and detached limbs of unidentified others were buried at the place with state honour the following day. Later 27 more martyred freedom fighters were buried.

However, the exact number of the victims could not be known.

The memorial plaque contains names of 120 freedom fighters who became victim of the tragedy only a few days after the final victory over the occupation forces.

The monument area has turned into a garbage dumping station and cattle grazing field, showing utter callousness of the local administration and the authorities of Moharaja Girijanath High School.

During a recent visit to the site, this correspondent found goats roaming on its premises and garbage littering the area.

The school authorities would do a great job to honour the martyred freedom fighters if they arrange keeping the monument premises clean with the help of students of the school, said members of January 6 Smriti Parishad, a local committee that arranges functions in memory of the martyrs every year.
