## Harijans vote every time amid empty promises

Unlike other areas of the country, the enthusiasm for the upcoming municipal election has hardly touched the Harijan people in Chapainawabganj

Their 'value' increases only when polls approach. The candidates give them many promises but those are hardly met.

About 50 families belonging to the Harijan community live in the sweeper colony, locally known as Methorpara in Chapainawabganj town, and the number of voters there is about 100.

Thirty-two other families of Harijan community live in 'station area', Court Bagan and near Rajmohol Cinema Hall, and the candidates are trying to woo their votes by making various pledges.

"People of Harijan community clean the town but they themselves

live in dirty, unhygienic and dilapidated quarters. Around 25 years ago, former municipal chairman late Abdul Mannan Sentu constructed a tin-shed building in Methorpara and Jamadar, 80, of Harijan Palli. arranged dwelling of 15 Harijan families there. That time each family got one room with a veranda. Now at least 50 families live in the same area," said Dulal Kumar, president of Harijan Durga Puja Udjapon Tilok Jamadar, 80. Parishad.

"Lack of proper housing facility is the main problem of the Harijan community which forces them to scatter around the town," he added.

Putul Rani, 70, said, "There are only two toilets for 220 people. Previous mayors of Chapainawabganj municipality have failed to ensure adequate civic amenities for the Harijan people."

"Want of pure drinking water, sew-

erage system, insufficient toilets and residential problems plague the Harijan community and yet no mayor has met our demands," said Pacha

"Many government offices including Chapainawabganj municipality are hiring people from other communities as sweepers. As a result unemployment in our community is increasing," said

"Candidates of different political parties make many pledges to voters before the municipality election but they forget all after being elected," said Parul Rani.

"We continue to suffer but nobody pays any attention. Everybody forgets that we are human too," Punnu Jamadar, 65, said.

The Harijans are now waiting for the right person who can work for their overall welfare.

## Headmaster punished for taking money for textbooks

#### 60,000 new books seized from ruling party men

A headmaster was punished for realising money for textbooks while a task force seized 60,000 new textbooks on Tuesday.

In Satkhira, headmaster of a primary school was suspended on Tuesday for allegedly realising money from the students for textbooks.

Local education office took the step against Bithi Sanyal, headmaster of Jhhowdamga Government Primary School in Sadar upazila, reports our correspondent.

A guardian of two students of the school alleged that his two sons read in the school and the headmaster on Saturday realised Tk. 30 from each of his sons and other students of the school while giving a way textbooks

meant for free distribution. On getting the allegations, district

primary education officer Panchanon Bala asked Sadar upazila primary education officer (TEO) Tapan Kumar Karmakar and ATEO Faruk Hossain to investigate the matter. The two went to the school on

January 3 and recorded the statements of guardians, local people and students. During probe they found that the headmaster realised money from the students while distributing books. The headmaster admitted to the

two officials that the school realised money from the students to bear carrying costs and other expenses, sources said.

Later district primary education

officer Panchanon Bala suspended her on Tuesday. In Jessore, a task force headed by

Sadar UNO Rezaul Karim and assisted by district primary education officer (DPEO) Arun Sen Gupta seized 60,000 new textbooks of class three from two separate places of the town Tuesday.

Samir Kundu and Abdul Mannan, two leaders of Jessore district unit of Swechhashebak League were arrested for keeping the books in their illegal possession, reports our staff correspondent in Khulna.

According to police, 18,000 books were seized from a house at Bejpara under Sadar police station while 42,000 books were found in another house in the same area.

#### Bhola: SC clears way for holding Char Fashion polls

The Supreme Court yesterday cleared the way for holding election to Char Fashion municipality in the district scheduled to be held on January 27.

Justice S K Sinha, chamber judge of the Appellate Division, yesterday stayed for six weeks a High Court order that halted the process for holding election to this municipality, reports a correspondent.

The judge passed the order following a petition filed by the Election Commission seeking stay on the HC order.

He also asked the EC to file a regular leave to appeal petition with the SC against the HC order within six weeks.

Additional Attorney General MK Rahman told this correspondent that now there is no legal bar to holding polls in the municipality on January 27 following the apex court order.

In response to a writ petition, the HC on December 15 last stayed the election process.

#### Joypurhat: Candidate fined for violating poll code

A mayor candidate in Kalai municipal election was fined by a mobile court for violating electoral code of conduct on Wednesday.

Accused Mamunur Rashid had to pay a fine of Tk 20,000, reports UNB.

Kalai UNO and upazila returning officer Abdur Rahim said as per electoral code of conduct more than five people at a time cannot take part in electioneering in favour of any candidate.

But a showdown with the participation of over 200 people in favour of the candidate was held on Wednesday morning.

While returning to his office after attending a training workshop on the upcoming election, Abdur Rahim witnessed the showdown at about 11:30am and took it into cognizance.

Instantly, a mobile court fined the candidate Tk 20,000, in default, to suffer 15 days in jail.

Mamunur Rashid is contesting the polls as a rebel candidate of ruling Awami League. The voting in the municipality will take place on January 12.
