private power plants. Summit has won both these projects competing in a tender floated by the Bangladesh Power

Development Board. In the Syedpur tender, Summit beat five other bidders by offering a Tk 6.99 per kilowatt power tariff for 15 years. In the Shantahar tender, it similarly beat five others by offering a tariff of Tk 7.06

per kilowatt hour for 15 years. Both these projects have to be completed within 15 months of signing the respective agreements.

Summit has previously won three power projects through competitive tenders: Bibiyana phase 1 and 2 gasfired private power plant (341 MW each) and Meghnaghat dual fuel 335 MW private power plant. In addition, it won or procured three HFOfired rental power contracts: Narayanganj 102 MW, Khulna 115 MW and Noapara 40 MW

These six projects alone require around \$1 billion for implementation. Summit chief Muhammad Aziz Khan claims it has \$2 billion investment assurance from different financial institutions.

He also says his company has arranged all technical sets of people to implement these projects in time. But Finance Minister AMA

Muhith feels uncomfortable with putting too many eggs in one basket. He said, "It has been discussed a lot that too many works have concentrated at one place. We have taken this issue into our con-

sideration. We have to fix a policy in dealing with such an issue."

While talking to journalists at the Cabinet Division after the purchase committee meeting yesterday afternoon, Muhith explained the reasons for his concern. He said, "This has got a relationship between capability of the company and timely implementation of projects.

"We have reviewed the works that were awarded [to Summit]. Our concern is with their technical competence and financial involvement," he added.

Replying to a question what kind of policy would safeguard the government interest in awarding multiple projects to a single bidder, the minister said the government would put a ceiling to the number of jobs that can be awarded to a company at a time.

A bidder that has bagged jobs up to that ceiling would not be allowed for more contracts till it delivers the results of awarded jobs.

The minister also expressed concern over subsidising purchase of power from rental power projects. He said he would soon hold an inter-ministerial meeting on the subsidy to take a decision.

Rental power projects seek costly power tariff as these operate on imported petroleum. The PDB that is purchasing power from rental plants would incur huge loss while selling the same to the consumers. Therefore the PDB has sought huge subsidy from the government and also seeks increase of power tariff.

An appellate division of the Supreme Court cleared the way by staying the HC order on January 2.

The concessionaire has to start the construction work of the elevated expressway within three months after receiving the work order and complete it in three and a half

The proposed route of the expressway runs from Hazrat Shahjalal (R) International Airport through Kuril, Banani, Tejgaon, Moghbazar and Kamalapur Stadium along the rail track.

Then, it goes through Gulbagh, by the Syedabad Water Treatment Plant, across Demra Road to Kutubkhali through Dania.

The expressway, expected to facilitate smooth traffic movement between north and south Dhaka city, will be transferred to the government after the concession period of 25 years.

A separate proposal was also approved yesterday for importing 50,000 tonnes of non-boiled rice through private importers at \$450 a tonne.

The price of per tonne rice to be imported from Vietnam is about \$100 higher than that of the private importers. Nurul Karim, joint secre-

tary of the cabinet division, said the government decided to buy rice from Vietnam at a higher price because nobody can say for sure that private importers will be able to supplyrice. They have already got work

orders for importing rice, he said.

The finance minister said private importers participate in tenders and sign agreements with the government. But they often fail to supply the commodity according to the deal. The government is buying

rice at a higher price to ensure supply on the domestic market, he said. A food ministry report

presented in yesterday's meeting showed the government in recent times awarded contracts to 17 firms for importing 5.5 tonnes of rice and signed agreements with 13 firms. But the government has so far received only 78,000

tonnes of rice from them.

Many companies are struggling to supply rice to the government as its prices have skyrocketed on the international market. The prices of coarse rice have increased by 40 percent to Tk 34 to 35 a kg over the last one year, the report said. The deadline for many

contractors to supply rice to the government will expire within 10 to 15 days. Moreover, bid bonds of three firms have been cancelled for failing to supply rice in line with an agreement, it said. In order to keep the

domestic market stable, the government has decided to continue different programmes including Open Market Sale (OMS), Fair Price Card, Test Relief and Food for Work. It will also introduce rationing for class-IV government employees and village police, the report mentions.

But a satisfactory food stock has to be built to implement the programmes, it said.

Wishing anonymity, a food ministry official said they took many initiatives to increase the food stock over the last one year, but in vain. On December 29 last year

the country's food stock stood at 8.16 lakh tonnes which was 11.16 lakh tonnes on the same daya year ago.

row and fourth time in a month the retail investors took to the Motijheel streets protesting the steep fall in share prices. In last four trading days, the stockmarket slumped by 570 points.

Although a long-term correction in stock prices was expected anytime in the last one year, the recent bearish trend as seen by experts is due mainly to liquidity crisis in the market.

Yesterday, the aggrieved investors started taking positions on the streets after the market closed 213 points lower at 3:00pm, the regular closing time.

The protesters blocked roads from Shapla Chattar to Ittefaq crossing, staged a rally and chanted slogans, vandalised several vehicles and threw brickbats on police.

The law enforcers chased the demonstrators to free the streets. Chase and counterchase between the police and investors continued for some Police charged truncheons

on the agitators while they were trying to enter the Modhumita building, just opposite to the Dhaka Stock Exchange (DSE) main building, and lobbed at least two tear gas canisters to disperse the demonstrators.

After the police actions, vehicular movement became normal at about 4:15pm.

Tofazzal Hossain, officerin-charge of Motijheel Police Station, said police will take decision about the detainees after quizzing them.

From inside the prison van the detainees said they had no alternative but to demonstrate as they were continuously losing money due to the bearish trend in the market.

They however, denied their involvement in street vandalism, and sought government intervention to stabilise the stock market.
