municipal election. A nonpartisan affair by book, it is essentially a political battle which the government must win to have its grasp on the grassroots.

With a crashed stock market and broken investors -- remember that the reach of this market penetrated even the remote places, as brokerage houses opened branches across the country and pooled money of the unsuspecting small savers -there is little chance for the government-backed candidates to win.

So a great deal of scurry must have happened in the offices of policymakers. Many great heads must have met greater heads. And decisions were made that the market must be yanked back on track for the time being. It did not matter whether fundamentals had enough gravitational force to keep the market on track.

Banks are reported to have been assured of refinancing at low rates, provided they invest in stocks. Institutional buyers like asset managers and merchant banks were advised not to sell. They were rather asked to buy. Not that all of them bought -- who would want to burn their fingers? Restrictions on mutual funds' exposure limit were temporarily withdrawn. Now they can buy over 10 percent of a single company or over 25 percent of a particular sector.

the market through the banks. Bangladesh Bank alone pumped in Tk 7,493 crore -- Tk 2,886 crore through repo and Tk 4,607 crore as liquidity support. On top of it, the central bank terminated auctioning of treasury bonds to the tune of Tk 200 crore. Another Tk

600 crore was released as treasury bonds matured. So market once again

sloshed with money. But then what? Did investors confidence return? It did not. They were as much scared of yesterday's phenomenal rise in index as they had been scared the day before at the spectacular crash. They were fooled once. But they could not be fooled again. Or rather they are no more in a position to be fooled. Look at the thin trading volume -- only Tk 977 crore exchanged hands and yet the index hit the ceiling! If you halve the amount (as a half of the turnover actually went to buy shares and the rest to sell, so the real trade was a half of Tk 977 crore), what picture do you get? Again, a great portion of the one half of the total amount went into netting. So the actual trade was may be of hardly Tk 200 crore or so. What a bounce back! Only fools can take satisfaction in it.

considering them vulnerable to the poll violence. Striking force will also be in those election areas in addition to members of regular law enforcement agencies. Members of police and Rab will work to maintain law and order in other election

areas. Police and ansar members will guard polling stations. However, locals still fear violence on election day.

"The holding of free and fair polls largely depends on the role of the law enforcement agencies," the home ministry said in a circular on security arrangement. Issued on

December 29, the circular said the government is determined to hold the polls in free

and fair manner.

The last municipality election, held between May 5 and May 10 in 2004 when the BNP-Jamaat-led alliance was in power, was marked with violence and various irregularities. At that time, polls to 115 municipalities were held while some others went to elections in phases later. The tenure of those municipalities

expired in 2009. The EC could not hold the polls on time due to various reasons, including the state of emergency, holding of parliamentary elections, and the incumbent government's indifference to local government elections. Finally, the EC on December 2 announced schedules for the mid January elections. It will be the eighth general elec-

tions to the municipalities. The previous elections were held in 1973, 1977, 1984, 1989, 1993, 1999 and 2004. During the first elections, there were only 50 municipalities in the country but the number shot up to 310 in 2010 as a large number of municipalities were set up in last decade without following the criteria due
