
Shops burnt in mall fire

Padma Bridge cost doubles in 4 years

Ecnec okays project at Tk 20,507cr

The Executive Committee of the National Economic Council (Ecnec) yesterday approved seven projects involving Tk 22,520 crore including the revised Padma Bridge Project.

Construction cost of the bridge has been revised at Tk 20,507 crore which is more than double the initially estimated cost of Tk 10,161 crore, approved by the Ecnec in 2007. Of the revised cost, Tk 17,516 crore will come from

development partners.

The projects were okayed at an Ecnec meeting at the planning ministry with Prime Minister Sheikh Hasina in the chair.

Govt eyes 2,000MW more power this year

While the government scored a record of signing dozens of deals for generating around 3,000 megawatt power last year, this year it aims at making another record: adding more than 2000MW electricity to the national grid.

If successful, this would increase Bangladesh's power generation capacity by nearly 50 percent. While this would significantly reduce the ongoing power crisis, there would still be some shortfall.

Chairman of the Power Development Board (PDB) Alamgir Kabir told The Daily Star that if all goes well, the level of load shedding would be strikingly low by the end of this year.

Plus, this additional power generation

would not put any pressure on the natural gas supply as most of the new power plants will operate on fuel oil, he said.

Gas has been the main source of power generation till now, and its crisis has affected power generation.

On the negative side -- the country's oil import cost is expected to shoot up significantly. When all of these new oil-based power plants would launch operation, these are expected to consume 1.9 million tonnes of diesel and heavy fuel oil a yearthus almost doubling the country's petroleum import cost, according to an estimate of the PDB.

In addition, there had been questions of how the Bangladesh Petroleum Corporation (BPC) would be able to store

496 military men executed thru' secret trial during Zia's period, Inu tells HC

Jatiya Samajtantrik Dal President Hasanul Huq Inu yesterday told the High Court that 496 military officers were executed after a secret military trial for protesting the "autocracy" of Ziaur Rahman. All freedom fighters, they were not allowed to defend themselves.

Murder spree in city

15 killed in 10 days

Murder of over 15 people coupled with frequent robberies and gun attacks in the capital within the first ten days of the new year mark an alarming slide in law and order.

A sense of impunity evolved among the criminals due to the government's recent recommendations for releasing the accused in a number of murder and robbery cases, observed some police officials.

A total of 52 robbery cases have been withdrawn between January and June 2010, said sources in police headquarters. Of these, seven cases were filed on charges of robbery with murder. But the government committee concerned found all these cases were filed in a bid to harass the

Police did neither prepare nor it were asked to make a list of cases to be considered as politically motivated, Hassan Mahmood Khandker, inspector general of police (IGP) told The Daily Star. Police headquarters sent a letter to the

home ministry expressing concern regarding withdrawal of some cases listed under this category. Many accused in these cases, mainly

US pledges to help conduct credible war crimes trial

The United States will provide all necessary assistance to Bangladesh to ensure fair and credible trial of the 1971 crimes against humanity, said Law Minister Shafique Ahmed yesterday.

The minister said this at a press briefing after a meeting with Stephen J Rapp, US Ambassador at Large for War Crimes Issues, and James F Moriarty, US Ambassador to Bangladesh, at his Secretariat office.

Shafique said the US representatives observed that the International Crimes Tribunal Act is good for holding a fair trial of the crimes against humanity. But they recommended amending its rules for providing more time to the defence to take preparation for their protection, he added.
