Bombs seized in Meherpur

Police early yesterday recovered four bombs in Meherpur. Acting on a tip-off, a team of Gangni police led by officer-incharge (OC) Motiar Rahman, raided the house of one Akmol Hossain at Chadpur in the upazila at abut 4.00am and recovered the bombs from rooftop of his house. Police said Akmol was accused in two cases. They however, could not arrest Akmol. On Monday, Rab arrested four cadres of outlawed Purbo Banglar Communist Party (PBCP-ML) faction Janajuddho after a gunfight at Ramnagar in Gangni of Meherpur. Rab recovered one 9mm pistol, five bullets, 9 bombs, one kg gunpowder, some bomb-making materials including wires and 250 leaflets of Janajuddho. Three Rab members and three outlaws were injured in the incident.

Jubo League leader held

Body of a police constable was recovered from old DC court area of the district town Monday morning. Police said after night duty Shamsuzzoha was returning to his town's Adarshawpara residence early in the morning. But the reason behind his death could be known immediately. Police suspected that he might have died of cardiac arrest.

Woman burnt to death



A mobile court in separate drives in Faridpur realised Tk 1.25 lakh fine from five brick kilns in Kanaipur area of Sadar upazila on Tuesday. The five brick kilns are

Mostafizur Rahman led the mobile court along with fire servicemen and police.

The court fined NRB Bicks Tk 20,000, PBF Bricks Tk 25,000, JB Bricks Tk 25,000, HBF Bricks Tk 30,000 and ARM Bricks Tk 25,000 for violating various rules including not having licenses, burning bricks with firewood and not using specified chimney.

The court also lodged five cases against those brickfield owners. Later, fire servicemen destroyed drum chimneys and raw bricks of unlicensed brick kiln own-

The owner of the illegal brick kiln--Messrs United Bricks--was fined Tk 20 lakh.

The brick kiln owner did not have requisite clearance certificate given by the environment department, said an environment department official.

Coal, water pumps, machinery, a motorbike, baked bricks and unbaked mud bricks were seized during the drive.

People of Naodari village had long been protesting the operation of the illegal brick kilns using drum chimney creating an adverse impact on environment and also affecting the Rabindra Complex at the adjacent The wood was kept at Dakkhindihi village under the same upazila, said

Headmaster's certificate found fake after 18 yrs

The headmaster of Betagi Sikdaria High School in Dashmina upazila in Patuakhali district is facing legal action as a recent probe by the upazila administration found that he took the job through submitting a fake experience certificate 18 years ago.

On August 1 in 1992, Abdul Aziz Mia joined as headmaster of Betagi Sikdaria High School.

In his application for the post, he submitted a fake

experience certificate along with other necessary papers and the school managing committee had issued appointment letter to him considering his experience, goes the probe report.

The certificate showed that he had served as the headmaster of Hazikhali High School in Patuakhali Sadar upazila since December 15 in 1991 but he never served in that school, it adds.
