# 'Stop torture, free Mishu'

Some women leaders yesterday strongly condemned the incident of taking garment workers' leader Moshrefa Mishu on remand and demanded her immediate release.

A statement signed by eleven women leaders said Mishu has fallen extremely sick due to torture during remand. It is a sheer violation of human rights and insulting attitude towards women leadership, reads the statement.

The signatories are Prof Latifa Akand, Dr Hamida Hossain, Khushi Kabir, Shirin Haque, Salma Ali, Farida Akhter, Nibedita Das Purkayasto, Sultana Akhter Rubi, Rawshan Ara Rusho, Shima Das Shimu, and Shahinur Begum.

Garment Sramik Oikkya Parishad President Moshrefa Mishu was remanded twice in a case filed with Kafrul Police Station for vandalism and arson during garment unrest.

#### Two extortionists arrested

Angry locals beat up two youths and handed them over to police for exploding bombs in an attempt to extort money from the owner of a workshop at city's Rothkhola in Sutrapur yesterday.

The wounded youths were identified as Mohammad Hafizul, 18, son of Abdul Mannan of Uttar Basanchar, and Mohammad Milon, 19, son of Koratitola at Sayedabad.

Haji Abdul Aziz, owner of the workshop Mecca Engineering Works, filed a case with Sutrapur Police Station.

Aziz said the criminals were demanding money for the last few days. As he denied complying, they hurled two bombs in front of his workshop around 10:00am to create panic, he said.

# Cabinet approves president's speech

A special cabinet meeting yesterday approved a speech to be delivered by President Zillur Rahman at the new year session starting on January 25.

Prime Minister Sheikh Hasina chaired the meeting attended by ministers, state ministers, her advisers, and secretaries at her office.

The cabinet also approved a policy to compensate Tk 3 lakh for each of those who will die for saving forest wealth and Tk 1.5 lakh for every injured person.

The cabinet on January 3 formed a five-member committee headed by PM's Adviser HT Imam to finalise the speech.

The committee also includes the PM's another adviser Dr Mashiur Rahman, principal secretary to the PMO, and the education and finance secretaries.

At the previous meeting, the premier instructed the committee to make a summary of the speech between 2,000 and 2,500 words so that the president could read it within 20 to 25 minutes. The entire speech would be tabled in the Jatiya Sangsad.

Declaring corporal punishment against children in educational institutions illegal and unconstitutional, High Court (HC) yesterday issued the government a set of directives to stop such punishments.

In response to a writ petition, it directed to ensure dissemination of the final guidelines prohibiting corporal punishment, specifying the nature of disciplinary punishments that may be imposed on children. The HC bench of Justice Md Imman Ali and

Justice Sheikh Hasan Arif ordered for defining corporal punishment as 'misconduct' under the Government Servants Discipline and Appeal Rules 1985. Definitions of 'misconduct' under this law

must be specified to include any breach of the prohibition of corporal punishment, it said. Breaches include actions such as caning, beating, confining or chaining children or otherwise

subjecting them to any cruel and degrading and inhuman punishment, it said. The bench directed that probes into schools and madrasas must cover occurrences of corporal

punishment, complaints, investigations, action

cruel and degrading and inhuman punishment against those responsible, its prevention and

security to the victim. The court said any inquiries into such inci-

dents must be confidential and should ensure protection to the victim.

with necessary cooperation, facilities and documents for this purpose, enabling him or her to provide a report to the national committee and the court. The HC in the verdict observed that such pun-

ishment constitutes a clear violation of children's constitutional rights including to life, liberty and freedom from cruel, inhuman and degrading treatment. It found that the government failed to take

appropriate and adequate action to address fourteen seperate incidents of corporal punishment, including one involving the suicide of a ten-year old boy. The HC gave the verdict following the writ

petition filed as 'public interest litigation' by two human rights organisations -- Ain O Salish Kendra and Bangladesh Legal Aid and Services Trust.

Barrister Sara Hossain, assisted by Advocate Taufiqul Islam, Advocate Abantee Nurul, and Advocate Majhabeen Rabbani, appeared for the petitioners while Deputy Attorney General Motahar Hossain Saju stood for the government.

# 'Dhaka gives importance to attaining MDGs'

Health and Family Welfare Minister Dr Ruhal Haque yesterday said Bangladesh is giving importance to attaining millennium development goals (MDGs) despite the country's successes in this area and the ultimate recognition by the UN.

He was talking to a four-member delegation of lawmakers from three European countries at his secretariat office, said an official press release. The minister said maternal mortality rate has declined

remarkably in the country as per the latest survey. The results of the survey would be published soon, he added. He said the government is working to reduce child and maternal mortality rates further.

The health minister said Bangladesh, like many countries

of the world, does not have an adequate number of anesthesiologists and gynecologists. He said the government is trying to resolve the problem and added that the assistance of foreign agencies is required

for training of the concerned people. He said the government's priority project of community clinics would expedite attaining MDGs in regards to child and maternal health.
