Sri Lanka flood victims vent anger

Victims of flooding in Sri Lanka have besieged a government office in the east of the country, accusing officials of holding back relief supplies.

Windows were smashed as more than 1,000 people surrounded the office in a village in eastern Batticaloa district.

Flood victims have told the BBC that some local politicians have been giving food and other aid to their supporters rather than the

most needy. Improvement in the weather has allowed many displaced to start returning home.

Flood victims barricaded staff in the government office in Ariyampathy yesterday after finding aid inside that had not been distributed.

Vietnam's communists LATEST LEAKS vote on new leaders

Vietnam's ruling communists met yesterday to pick new leaders, who are expected to oversee a drive to modernise the economy while refusing to abandon the country's authoritarian political system.

The secretive congress aims to map out the country's direction for the next five years in the face of mounting economic challenges including rising inflation and a weakening currency.

Nearly 1,400 delegates voted for an elite Central Committee, which party sources say has taken on an increasingly important role as the communists pursue more internal debate.

Turkey allowed US extraordinary rendition'

The US secret services used Turkey as a base to transport "terrorism" suspects as part of its extraordinary rendition programme, German daily Die Welt reported yesterday citing a WikiLeaks cable.

Some 24 CIA flights landed at Incirlik airport in southern Turkey between 2002 and 2006 with the knowledge of the Turkish military, according to a cable from the US embassy in Ankara dated June 8, 2006, the paper said.

"The Turkish military has since 2002 allowed us to use Incirlik as a refuelling stop for prisoner transport flights from 'Operation Fundamental Justice', but revoked permission in February this year," said the cable, referring to the rendition programme.

Die Welt published excerpts from the cable in German.

On June 14, 2006, a spokesman for Turkey's foreign ministry, Namik Tan, told reporters: "The Turkish government and state never played a part (in the secret transfers) ... and never

Turkey had just been named in a Council of Europe report listing it among 14 European countries that colluded in or tolerated the covert transporting of prisoners.

WikiLeaks has obtained some 250,000 US diplomatic cables and handed them to five major news organisations: the New York Times, Der Spiegel, the Guardian, El Pais and Le Monde.

To date, 2,444 have been published on the whistleblowing website but the Ankara cable is not yet among them.

Die Welt said it had secured access to the complete cable dump, in cooperation with Norwegian daily Aftenposten, which is also putting them out independently.

US intelligence services used secret rendition flights in the aftermath of the September 11 attacks to transfer "war on terror" suspects to third countries for interrogation, where many said they were imprisoned and tortured.

GRAFT SCANDAL

Mumbai tower to be torn down

India's environment ministry has ordered the demolition of a block of flats in Mumbai that has been at the centre of a corruption scandal.

It said the Adarsh Society building must be demolished within three months for breaching coastal protection laws.

The 31-storey block was originally planned as a sixstorey housing project for war widows.

But flats were sold to politicians and military officers, allegedly at prices far below the market rate.

Minibus bomb kills 18 in NW Pakistan

A timed bomb blast in a minibus that killed 18 people in Pakistan's northwest yesterday targeted a Shiite Muslim leader accused of sectarian killings in the area, police told AFP.

The deadly blast in Jawarza, near the restive town of Hangu, killed 16 passengers travelling in the explosives-laden minibus and two people in a pick-up truck nearby. Another eight people

were hospitalised with injuries, four of them in critical condition, said senior police officer Masood Khan Afridi.


The target of the bombing was apparently Shiite leader Kamil Ali Shah, who Afridi said was blamed for the killings of four Sunni Muslims in Hangu district in September.

Jyoti Basu's first death anniversary observed

Late Marxist leader Jyoti Basu was remembered on his first death anniversary yesterday.

Former Indian Parliament Speaker Somnath Chatterjee paying rich tributes after garlanding Basu's portrait said the former West Bengal Chief Minister's absence is deeply felt at a time when politics in the state Bengal has turned bloody.



"The spurt in political violence and hostility are occurring daily in the state. Had Jyoti babu been alive today, this situation would not have developed," Chatterjee said after visiting Indira Bhavan in Salt Lake locality of Kolkata where Basu had lived yesterday.

Chatterjee recounted the days when an ailing Basu, three years before his death, had invited Trinamool Congress chief Mamata Banerjee to discuss burning issues, particularly after the Nandigram violence.

"It was at Basu's instance that the opposition leader came to his residence for discussing serious political issues. At this juncture, Jyoti Basu's absence is deeply felt," Chatterjee, who has been expelled from CPI(M) for 'anti-party activities'.

A 'Jyoti Basu Centre for Social Studies and Research' will be set up at Rajarhat renamed Jyoti Basunagar on the outskirts of Kolkata.
