Rab man arrested

Police arrested a suspended member of Rapid Action Battalion-8 (Rab-8) and his associate yesterday morning from Ranai village under Dumuria upazila. Shahinuzzaman Shahin, 32, and his associate Sheikh Raisuddin, 26, were held with 100 bottles of phensidyl. According to OC, Shahinuzzaman Shahin was suspended in July last year from service also for carrying 199 bottles of phensidyl from Barisal towards Rajbari district. He was caught red-handed by police from Rajbari town and later released on bail from Rajbari district jail in December, the OC said.

One jailed for stalking

UNB, Gopalganj

A mobile court on Sunday sentenced a stalker to three months imprisonment for harassing a schoolgirl in Kashiani upazila. The convict was identified as Milon Sheikh, 28, son of Shahid Sheikh of the upazila. Police said local people caught Milon red-handed while he was teasing the schoolgirl on her way home from school in the upazila headquarters and handed him over to police. Later, the mobile court awarded the punishment.

Security guards suspended

Three security guards of the state-run Crescent Jute Mill (CJM) have been suspended for neglect of duty during Friday's devastating fire. The guards are Abdus Sobhan, Monir and Kabir. On the other hand, two high ranking officials of BJMC head office arrived in Khulna on Saturday evening to inspect the fire affected godown of the jute mill. The fire broke out at 1:45 pm on Friday at godown no-12 at Khalishpur. There were 20,000 maunds of jute worth about Tk4 crore in the warehouse which was under lock and key at the time of fire incident. Over 2,000 maunds of jute worth over Tk50 lakh were completely gutted in fire.

Digital fair at Rangpur

MUTINY BY MARISHYA BATTALION

Verdict in case against 74 Feb 5

The special court-15, set up at BGB Rangamati Sector Headquarters, yesterday fixed February 5 for judgement in the mutiny case against 74 jawans of 9 Battalion of Marishya Zone under Baghaichhari upazila of the district. The court, headed by BGB Chittagong Sector Commander Col Zahedur Rahman, fixed the date. All the 74 accused were produced in the court and sent back to Rangamati jail on completion of their argu-

ments with the prosecution witnesses. Fifty-two out of 102 prosecution witnesses gave their depositions before the special court. All the 74 jawans claimed innocence and appealed to the court to acquit them of the mutiny charge. Prosecutor Lt Col Munir Hasan first gave statement against the accused jawans who also argued with him. After recording statements and completion of arguments, the court fixed February 5 for judgement in the case and adjourned the trial proceedings until

2:00pm on the day. Mutiny took place at three of the five battalions under Rangamati sector on February 26 in 2009. These are 12 Rifles Battalion at Rajanagar in Longudu, 9 Rifles Battalion at Marishya in Baghaichhari and 18 Rifles Battalion at Chhotohorina in Barkal. On Sunday, the same court fixed the same date for judgement in the mutiny case against 23 jawans of 18 battalion at Chhotohorina in Barkal upazila. Of the accused, 22 claimed innocence and appealed to the court to

acquit them of the mutiny charge. Only an accused named Subeder Major Md Shah Alam confessed to his involvement in mutiny at the battalion on February 26 in 2009. Prosecutor Lt Col Mehedi Hasan first gave statement against the accused jawans who argued with him. After receiving statements and arguments from both prosecutors and the accused, the court fixed February 5 for judgement in the mutiny case and adjourned the trial proceedings until 9:00am on the day.

5-hr labour of 4,000 Aila-hit people lost

An embankment repaired in five hours from 8:00am on Friday through voluntary services of nearly 4,000 Aila affected men and women collapsed at 3:00pm on the same day. According to upazila chairman GM Mohsin Reza, the homeless and half-fed men and women of three unions under Koirapara upazila came out of their makeshift camps and cyclone centres braving biting cold to repair the Pabna embankment. They repaired it in five hours with a hope to stop the surging water of the Shakbaria river. They dropped over one lakh sand-filled bags to get rid of miseries caused by the defective embankment.

Pabna embankment damaged by cyclonic storm Aila and tidal surges, remained unrepaired since 2009 causing untold sufferings of over one lakh people of three unions. Two thousand metric tonnes of rice were sanctioned by the government for repair of the embankment last year. Messers AL Mamun Enterprise of Barguna district got the work order to reconstruct the embankment as his firm won tender competition invited by the Water Development Board (WDB) in 2009. But the contractor allegedly left the site after doing not more than 60 per cent of the work due to reason yet to be known. Khulna office of WDB again invited the same contractor to complete the remaining work with a revised rate. Later, from October 23 last year, the same construction firm again started work under direct supervision of the army. Engineer Akram Hossain of WDB still hopes that it would be possible to complete the reconstruction work of the embankment within next one month.

But to the utter disappointment of over one lakh Aila-hit people, the embankment collapsed due to furious cross current and abnormal high tide of the saline infested river on the same day. Apart from those who gave voluntary services, thousands of frustrated people simply witnessed with tearful eyes the cruelty of the Shakbaria river, Mohsin Reza said.

Drug peddlers injure two BDR men

Two Bangladesh Rifles (BDR) members were injured in an attack by drug peddlers along Daulatpur frontier here early yesterday. BDR commander Siddiquar Rahman said being tipped-off that a gang of drug peddlers with huge smuggled phensidyl syrup were entering the country from India, they chased the peddlers in Ghonarmath area in the early morning. At one stage, drug peddlers attacked BDR members with sharp weapons that left two border guards injured. Later, the peddlers fled the scene leaving behind the contraband drugs when BDR members fired 18 rounds of bullet. The jawans later seized 12 sacks of phensidyl syrup from the spot. In Sathkira, BDR in a drive on Sunday night recovered a large quantity of Indian sari from a truck at Sharashkati Bazaar in Kolaroa upazila. Acting on a tip-off, BDR 41, battalion chased a Keshabpur-bound truck from Sathkira frontier area at night. At one stage, the smugglers fled away leaving behind the truck at the bazaar. Later, the border guards recovered huge Indian saris worth Tk 20 lakh from the truck.
